Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Washington Center for Internships and Academics Seminars 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Washington Center for Internships and Academics Seminars 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. PLAN DESCRIPTION

The following description of The Washington Center for Internships and Academics Seminars 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of The Washington Center for Internships and Academics Seminars (the Organization) who have reached the age of 21 and one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan includes automatic enrollment of 3% of compensation per payroll period. There are no automatic deferral escalations.

Contributions

Participants may elect to contribute portions of their annual compensation to the Plan, subject to certain limitations. Participants may contribute up to 90% of compensation. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their and the employer's contributions into various investment options offered by the Plan. The employer makes safe harbor matching contributions to the Plan. For the year ended December 31, 2024, the employer matched 100% of contributions from the first 3% of a participant's compensation, plus 50% of a participant's compensation between 3% to 5%.

Participants' Accounts

Each participant's account is credited with the participant's contribution, the employer's safe harbor matching contribution, and an allocation of plan earnings, and is charged with an allocation of administrative expenses, which consist of recordkeeping, audit, and investment management fees. Allocations of earnings and expenses are based on the participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their contributions plus earnings on those contributions. The employer's matching contributions are subject to a vesting schedule. Participants will only become 100% vested after three years of continuous service.

Notes Receivable from Participants

Participants may borrow from their plan accounts from \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balances, whichever is less. Each loan is secured by the balance in the participant's account and bears interest at the prime rate that is published in *The Wall Street Journal* at the time the loan is made, plus one percent. Principal and interest are paid ratably through payroll deductions.

1. PLAN DESCRIPTION (CONTINUED)

Payment of Benefits

Distributions from amounts attributable to salary deferrals are not permitted before the age of 59½ except in the event of death, disability, termination of employment, or reasons of proven financial hardship. Distributions are made as lump-sum payments in the amount equal to the value of the participant's vested interest in his or her account.

Forfeitures

Terminating participants forfeit the non-vested portions of the participants' employer contributions, however, the Plan is fully vested in all contributions immediately. Forfeitures for the Plan result primarily from stale checks that participants have not deposited. Forfeitures are used first to pay administrative costs of the Plan, and the remainder is then used to reduce future employer contributions. There were no forfeitures applied to offset the employer's contributions or administrative costs for the year ended December 31, 2024. Forfeitures available as of December 31, 2024 and 2023, totaled \$16,654 and \$482, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The Plan presents its financial statements under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments that are valued at fair value include shares of registered investment companies (mutual funds) that are valued at quoted market prices which represent the net asset values of shares held by the Plan at year end. Units of participation in common/collective trusts are valued at the unit values reported by the sponsoring banks at the Plan's year end. The Stable Value Fund is valued at contract value. The net asset and unit values represent the current market values of the underlying assets of the funds. Purchases and sales of securities are recorded on a trade-date basis. Interest revenue is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Income Taxes

The Plan meets the requirements of the Internal Revenue Code (IRC) and ERISA to qualify as exempt from federal income taxes. The plan sponsor has obtained a prototype non-standardized profit-sharing plan opinion letter dated October 6, 2020, in which the Internal Revenue Service has determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under that guidance, the Plan may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities based on the technical merits of the position. For the Plan, a tax position is the Plan's tax-exempt status under the provisions of the Internal Revenue Code (IRC) and ERISA. The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement. There were no unrecognized tax benefits related to uncertain tax positions identified or recorded as liabilities for the year ended December 31, 2024.

The Plan's policy would be to recognize interest and penalties, if any, on tax positions related to its unrecognized tax benefits in income tax expense in the financial statements. No interest and penalties were assessed or recorded during the year ended December 31, 2024. The Plan's Forms 5500, *Annual Return/Report of Employee Benefit Plan*, is open for inspection by the taxing authorities, generally for three years after the date it was filed.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Employer, as provided in the plan agreement.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the information related to investments included in the accompanying financial statements and supplementary schedule is complete and accurate.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs to the valuation methodology are unadjusted quoted prices for similar assets in active or inactive markets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Registered Investment Companies: The fair value of the shares of mutual funds owned by the Plan is based on quoted market price values on the last business day of the plan year.

The preceding methods described may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE CONTRACTS

The Plan participates in a fully benefit-responsive investment contract with Reliance Trust Company via an investment in the Invesco Stable Value Fund ADP85 (SVF). This is an investment option within the group annuity contract. The SVF is a common collective investment trust. Stable Value funds seek to achieve stability by preserving principal and accumulated earnings. Stable Value funds are similar to money market funds but typically offer higher returns. The typical investments held in a Stable Value portfolio include GIC's, collateralized mortgage obligations, managed bond portfolios, and cash. Although Stable Value funds seek to preserve principal and earnings, there can be no assurance this will be maintained. It is possible to lose money. Investments in funds are neither insured nor guaranteed by the United States government. Amounts invested at contract value as of December 31, 2024 and 2023, totaled \$47,934 and \$22,733, respectively.

6. PLAN TERMINATION

Although the Organization have not expressed any intent to do so, they have a right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accounts.

7. RELATED PARTY TRANSACTIONS

Certain plan investments were managed by affiliates of Reliance Trust Company. Reliance Trust Company was the trustee as defined by the Plan. These transactions qualify as party-in-interest transactions. Fees and commission paid to Reliance Trust Company for the year ended December 31, 2024, were \$13,089.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) was signed into law on March 27, 2020, and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act) was signed into law December 29, 2019. These laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

Effective April 17, 2020, certain provisions were implemented under the CARES Act. The Plan will be formerly amended for the CARES Act and the SECURE Act provisions elected in accordance with applicable law and IRS guidance. Under Notice 2022-33 and Notice 2022-45, the IRS has extended the deadline for retirement plans to adopt the amendments required by the SECURE Act and the CARES Act until December 31, 2025.
