**Note 1—Description of the Plan**

The following description of MECA Solutions, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan established on January 1, 1995 and most recently amended and restated January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Eligibility* – All non-union, non-leased employees of MECA Solutions, LLC (the “Company”) who are 18 years of age or older and complete three month of service are eligible to participate in the Plan.

*Plan Administration* – The Company is the Plan sponsor and Plan administrator. Assets of the Plan are in the custody of Mid Atlantic Trust Company, the “qualified institution” of the Plan. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan.

*Contributions* – Participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan up to \$23,000, the annual limit established by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in accordance with IRC limit. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Company may make discretionary matching contributions based upon a percentage of the participant’s eligible compensation, and discretionary profit-sharing contributions based on an allocation formula established in the Plan provisions. For the year ended December 31, 2024 (audited), the Company made a discretionary matching contribution to the Plan of \$230,935 and no discretionary profit sharing contribution.

*Investment Options* – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers multiple investment options for participants. Participants may change their investment elections at any time.

*Participant Accounts* – Each participant’s account is credited with the participant’s and Company’s contributions, an allocation of Plan earnings or losses, and charged with participant’s benefit payments and an allocation of administrative expenses. Allocations are based on participants’ compensation, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions is based on years of continuous service as follows:

2	50%
3	75%
4	100%

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The period of repayment for any loan shall be for a period not to exceed five years unless for the purchase of buying a home, for which the term could be longer. The loans are secured by the vested balance in the participant’s account and bear interest at prevailing market rates. All outstanding loans bore an interest rate between 4.25% and 9.50% for the year ended December 31, 2024 (audited). Principal and interest are paid ratably through payroll deductions on, at least, a quarterly basis.

### Note 1—Description of the Plan (continued)

*Payment of Benefits* – Upon attainment of age 59½, termination, or permanent or total disability, a participant may elect to receive an early withdrawal in the form of a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon reaching normal retirement age (age 65), the participant will become vested in all unvested portions of their account and will be eligible to make withdrawals. A participant who is experiencing financial hardship may request a withdrawal of all or any portion of the participant's vested balance.

*Forfeited Accounts* – Forfeitures of terminated participants' non-vested accounts may be used to pay Plan expenses or reduce the Company's contribution obligation, as directed by the Company. Forfeited nonvested accounts at December 31, 2024 (audited) and 2023 (compiled), totaled \$13,063 and \$4,822, respectively. During 2024 (audited), \$15,873 was utilized to pay Plan expenses.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting. This basis conforms to accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Payment of Benefits* – Benefits paid to the participants are recorded when paid.

*Contributions Receivable* – The amount of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Company contributions receivable in the Plan's financial statements

*Administrative Expenses* – The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan.

**Note 2—Summary of significant accounting policies (continued)**

*Risks and Uncertainties* – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution of the Plan has certified the following data included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, including realized and unrealized gains and losses, and interest and dividends as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4—Fair value of financial investments**

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used to measure the Plan's investments at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There were no transfers between levels during the year ended December 31, 2024.

**Note 4—Fair value of financial investments (continued)**

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 (audited) or 2023 (compiled):

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Interest Bearing Cash* – The carrying amount of interest bearing cash approximates its fair value due to the relatively short time between origination of the instrument and its expected realization.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Tax status**

The Company adopted a prototype non-standardized plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

**Note 5—Tax status (continued)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 (audited) and 2023 (compiled), there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6—Parties-in-interest transactions**

Certain Plan investments are managed by the qualified institution, and these transactions qualify as party-in-interest transactions. The Company also paid certain administrative expenses of the Plan. Fees paid by the Plan for administrative services were \$55,372 for the year ended December 31, 2024 (audited). Notes receivable from participants qualify as party-in-interest transactions.

**Note 7—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

**Note 8—Subsequent events**

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through October 13, 2025, the date these financial statements were available to be issued.

The Plan document was amended as of January 1, 2025, modifying the vesting schedule. All participants are immediately vested in all contributions to their accounts.
