**INDEPENDENT AUDITORS' REPORT**

To the Administrative Committee of  
Country Select Catfish 401(k) Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Country Select Catfish 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Country Select Catfish 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Country Select Catfish Company 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Country Select Catfish Company (collectively, the “Sponsor”) who have at least one year of service, are age 21 or older, and are not union employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator for the Plan is the Administrative Committee. The Plan Administrator controls and manages the operation and administration of the Plan. Empower Trust Company, LLC, serves as the Trustee and Recordkeeper for the Plan. Martin, Martin, Randall and Associates serve as the third-party administrator of the plan, and LPL Financial serves in a fiduciary role to the Plan as defined by ERISA section 3(38) as the Plan’s Registered Investment Advisor. The sponsor provides certain administrative services to the Plan and pays certain administrative expenses of the Plan, at no cost to the Plan.

Contributions

Each year, participants may contribute a percentage of compensation each year of pretax annual compensation, as defined by the Plan, subject to certain Internal Revenue Code (“IRC”) limitations. Beginning January 1, 2023, the Sponsor matches participant deferrals in an amount equal to 100% of the participant's first 1% of compensation plus 50% of their deferrals beyond that 1%, not to exceed 6% of compensation. The Sponsor may make discretionary profit-sharing contributions to the Plan which will be allocated to those in the plan. The Sponsor’s matching contributions are made each payroll period, were made in cash, and were based on the individual participant’s investment allocation in the participant’s accounts at year end.

Employee and Employer Contributions

Employee deferrals and respective employer matching contributions are recognized as additions to net assets on the date on which such employee deferrals would otherwise have been payable to the participant. Employee rollover contributions are recognized as additions to net assets on the date transferred from other qualified plans. Employer discretionary contributions are recognized as additions to net assets when approved by the Board of Directors.

Participant Accounts

Each participant's account is increased by the participant's contributions and allocations of Sponsor contributions and Plan earnings and is reduced by the participant's withdrawals with an allocation of those administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances. Forfeited balances of terminated participants' nonvested accounts are used to reduce administrative expenses paid by the Plan.

Vesting

Participants are immediately vested in their contributions and actual earnings or losses thereon. Vesting in the Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant becomes fully vested after the fifth year of credited service. The plan's vesting schedule is a five-year cliff vesting schedule for matching and profit-sharing contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of his or her account among alternative investment funds provided under the Plan. Participants may change or transfer their investments options periodically.

Loan Policy

Participants may borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator in accordance with the Plan policies and procedures. Principal and interest are paid proportionally through payroll deductions.

Participant Benefits

When benefits become due, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account or installments over a period of time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,676 and \$16,704, respectively. These amounts will be used to pay administrative expenses or reduce future employer contributions.

2. Summary of Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Plan's statements of net assets available for benefits.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Date of Management's Review

Subsequent events were evaluated through the date of the auditors' report, the date the financial statements were available to be issued.

Investment Valuation and Income Recognition

The investments of the plan are stated at fair value, as determined by quoted market prices when available. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative expenses

Plan expenses are paid from forfeited funds when available, plan assets, or by the plan sponsor.

Payment of Benefits

Benefits are recorded upon distribution.

Excess Contributions Payable

The Plan is required to return contributions received during the Plan year in excess of IRC limits.

3. Fair Value Measurements

The fair value measurements authoritative literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels that are listed below.

Level 1- Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not active or financial instruments for which all significant inputs are observable either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the US Securities Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stock: Valued at the trading price on the close of the last business day for the year.

Fixed annuities: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. 4. Investments – Information Prepared and Certified by the Plan Custodians

The statements of net assets available for benefits as of December 31, 2024 and 2023, the investment activities included on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Custodians OF Empower Retirement, LLC in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. At December 31, 2024, the certification included total assets of \$11,249,030, which included cash of \$18,676, mutual funds of \$11,131,484, fixed annuities of \$51,771 and notes receivable of \$47,099. At December 31, 2023, the certification included total assets of \$10,177,127, which included cash of \$16,704, mutual funds of \$10,051,975, fixed annuities of \$49,302, and notes receivable of \$59,146. The certification also included related income on the Plan's investments of \$924,413 and \$1,214,807 for the years ended December 31, 2024 and 2023, respectively.

5. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of

ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

6. Federal Income Tax Status

The Plan was designed using a pre-approved plan document which received an opinion letter from the IRS dated June 30, 2020, that the Plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS and state jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others.

During the 2024 and 2023 Plan years, Empower Trust, LLC provided recordkeeping and trust services to the Plan for trustee and custodial services. The administrative expenses paid by the Plan were rendered by parties-in-interest. Those fees were based on customary and reasonable rates for such services. The Plan Sponsor provides administrative services to the plan and these costs are absorbed by the Plan Sponsor. The administrative fees to the plan for the years ended December 31, 2024 and 2023, were \$47,586 and \$42,513, respectively.

8. Erroneous Transfer of Prior Year Forfeitures

The Company inadvertently transferred \$2,502 of employee funds to forfeitures in 2020. These funds were transferred to the individuals accounts and disbursed in 2023. The related lost earnings were calculated and paid in the year ending December 31, 2024.

9. Differences in Audited Financial Statements and Tax Return

Differences were noted between the audited financial statements and the Form 5500 tax return for the year ended December 31, 2024 related to accounts receivable and participants loans in the amount of \$373. Differences were noted between the audited financial statements and the Form 5500 tax return for the year ended December 31, 2023 related to accounts receivable and participants loans in the amount of \$113.

10. CARES Act, SECURE Act, and SECURE Act 2.0

On March 27, 2020, December 20, 2019, and December 29, 2022 respectively, the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act) and the SECURE Act 2.0 were signed into law. The Plan has implemented certain requirements by the CARES Act, the SECURE Act, and SECURE Act 2.0 which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, allow coronavirus-related distributions, allow temporary loan amount increases, and delay the commencement date for required minimum distributions. Other optional features within these acts are currently being assessed but have not been implemented to date. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

The key provisions of the CARES Act and SECURE Act 2.0 that affect the Plan include:

- allowing participants to take a coronavirus-related distribution (CRD) of up to \$100,000 (not to exceed the participant's account balance) from their retirement plan without a 10% early withdrawal penalty. Eligible distributions can be taken up to December 31, 2020. CRDs may be repaid within three years. The plan management may rely on an employee's certification that the employee satisfies the conditions for a CRD (section 2202. Special rules for use of retirement funds);
- allowing suspension of loan repayment due March 27, 2020, through December 31, 2020, for up to one year (section 2202(b)(2)); and
- allowing suspension of 2020 required minimum distributions (section 2203).
- allowing participants to borrow up to \$100,000 from qualified plans – an increase from \$50,000 previously allowed under Internal Revenue Code section 72(p) – for loans made from March 27, 2020 through September 22, 2020, and repayment can be delayed (section 2202. Special rules for use of retirement funds);
- increasing the age for required minimum distributions

11. Delinquent Participant Contributions

For the years ended December 31, 2024 and 2023, certain contributions were not remitted to the plan within the plan policy, constituting nonexempt transactions between the Plan and the Company. The late payments were remitted during the years they were incurred. The lost earnings related to delinquent contributions for 2023 have been calculated and paid in the year ended December 31, 2024 and lost earnings related to the delinquent contributions for 2024 were paid in the year ending December 31, 2025.
