**NOTE 1 – DESCRIPTION OF PLAN**

GovOS 401(k) Plan (the Plan) is a qualified retirement plan adopted by GovOs, Inc. (the Sponsor), to provide employees with the opportunity to save for retirement on a tax-advantage basis. Participating employers include: Tenacity Manufacturing, Complete System Support, Inc., Kofile Conversion Services, Inc., Kofile Systems, Inc. and Bizodo, Inc. (collectively, the Company). The Plan was adopted March 24, 2023 and was most recently amended effective March 1, 2024. The Plan is subject to the provisions Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company are eligible to participate in the plan after 30 days of service. An employee's entry date will be the first day of the month immediately following or coinciding with the date the employee satisfies the eligibility requirements.

On March 1, 2024, the Plan was amended to implement an Automatic Contribution Arrangement (ACA) for newly hired employees. Under the amended terms, eligible employees hired on or after the effective date are automatically enrolled at a 5% elective deferral rate unless they elect otherwise. The Plan also introduced an automatic escalation feature that increases the deferral rate by 1% annually up to a maximum of 10% of compensation, with each increase occurring on the anniversary of the participant's entry date.

Contributions: Participants may elect to reduce their compensation and make a contribution to the Plan on a pre-tax basis as an elective deferral contribution, not to exceed the annual dollar limitation set forth by Internal Revenue Code (IRC) section 402(g). The Plan also allows for elective deferral contributions to be made as Roth contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or an individual retirement account. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Such contributions are recorded by the Plan in the period in which the Company makes applicable payroll deductions.

The Company may make a discretionary matching contribution on a participant's behalf during the Plan year. Each year, the Company will determine the amount of the discretionary percentage. For 2024, the Company elected to make a discretionary match equal to 50% of the first 3% of a participant's eligible compensation, not to exceed \$4,500 annually.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Investment Options: Participants direct the investment of their entire interest in the Plan into various investment options. The Plan currently offers various mutual funds and a group annuity as investment options for participants. Participants may redirect the investment of future contributions or reallocate or transfer existing balances among available investment securities at any time.

Vesting: Participants are always fully vested in their salary deferrals, including catchup contributions, rollover contributions, and the appreciation of earnings thereon. Participants are also always fully vested in discretionary contributions.

Notes Receivable From Participants: Participants may apply for a loan from the Plan to borrow a minimum of \$1,000, and no more than the lesser of (a) \$50,000 reduced by the excess, if any, of their highest outstanding balance of loans from the Plan during the one-year period prior to the date of the loan over their current outstanding balance of loans; or (b) 50% of the participants' vested account balances. Loan terms are not to exceed five years in accordance with the Plan agreement unless the loan is for the purchase of a principal residence. The loans are secured by the balance in the participants' account and bear an interest rate equal to 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through payroll deductions. Participant loans are classified as notes receivable from participants in the Plan's financial statements.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum distribution or a partial withdrawal. If the participant's vested account balance does not exceed \$5,000 and is greater than \$1,000, then the vested account balance will be automatically rolled over to an IRA. If the vested amount of a participant's account exceeds \$5,000, they must consent to any distribution of their account.

Participants may be entitled to receive an in-service distribution. Participants may receive a distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59 ½. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Plan Termination: Although it has not expressed any intent to do so, the Company reserves the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

Subsequent Events: The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and no events have occurred that would require disclosure in the financial statements.

## **NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive investment contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan invests in various securities that are exposed to market volatility, interest rate fluctuations, and credit risks. In addition, global economic conditions — including inflationary pressures, fluctuating interest rates, and geopolitical events — may increase the volatility of investment returns and impact participant account balances. It is at least reasonably possible that changes in the fair values of these investments could occur in the near term and materially affect the amounts reported in the financial statements.

## **NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The Plan classifies fair value measurements within the fair value hierarchy based on the lowest level of input that is significant to the fair value measurement in its entirety. In instances where inputs used to measure fair value fall into different levels of the hierarchy, the entire fair value measurement is categorized based on the lowest level input that is significant. Management uses judgment, considering factors specific to each asset, in evaluating the significance of inputs used.

The following presents the valuation method and assumptions used by the Plan to estimate the fair values of investments.

**Mutual Funds:** Valued using the market approach based on unadjusted quoted prices in active markets for identical assets obtained from nationally recognized securities exchanges.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

**NOTE 5 – GROUP ANNUITY CONTRACT**

The Plan holds a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America; formerly Great-West Life & Annuity Insurance Company (Empower). The contract is a group annuity contract for a fixed account what is part of the general account of Empower. Principal and interest are fully guaranteed by the general account assets of Empower. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 0.05%. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The group annuity contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company initiated events that result in distributions exceeding a set amount. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds a group annuity contract with Empower Annuity Insurance Company of America, and Empower Trust Company, LLC is a service provider to the Plan. These transactions, including the Plan's payment of fees to Empower for recordkeeping and administrative services, qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – INCOME TAX STATUS**

The Company adopted a non-standardized pre-approved CODA, sponsored by Empower Retirement, LLC. The pre-approved plan obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was acceptable under section 401 of the IRC for use by employers for the benefit of their employees. Plan management believes that the Plan is currently being operated in accordance with the requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
