To the Trustees of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Monolith Materials, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP")
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). ## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

##### 1. Description of Plan

The following description of the Monolith Materials, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General** – The Plan is a defined contribution plan covering all employees of Monolith Materials, Inc. (the Company) who are age 18 or older, except union employees and nonresident aliens are not eligible. Employees become eligible to participate in the Plan on the date in which the eligibility requirement is met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions** – Participants may contribute up to 100% of their compensation, as defined in the Plan through either pre-tax or after tax- Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation for each payroll period and automatically increased 1% on the first day of each Plan year until 15% or changed by the participant. Automatically enrolled participants contributions are invested in a target retirement date fund based on their age until changed by the participant.

The Company may make discretionary matching contributions. The Company contributed 50% of the first 6% of eligible compensation the participant contributed to the plan totaling \$1,112,771 for the year ending December 31, 2024. Additional discretionary nonelective contributions may be made by the Company of which none were made for 2024. Participants direct the investment of all contributions into various investment options offered by the Plan.

- C. Participants Accounts** – Each participant account is credited with the participant's contribution, allocations of Company contributions, allocations of Plan earnings and losses, and is charged with an allocation of administrative expenses. Allocation of Plan earnings, losses, and administrative expenses is based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting** – Participants are 100% vested in all contributions and actual earnings (losses) thereon.

**E. Payment of Benefits** – On termination of service due to death, disability, hardship, termination of employment or upon reaching age 59 ½, a participant may elect to receive all or any portion of the participant's vested account balance. Hardship distributions may only be made from participant's elective deferrals. If the vested account balance is \$5,000 or less, a mandatory distribution will be made. If the vested account balance is more than \$1,000 and \$5,000 or less it will be automatically rolled over to an individual retirement account.

2. Summary of Significant Accounting Policies

**A. Basis of Accounting** – The financial statements of the Plan are prepared on the accrual method of accounting.

**B. Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition** – Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and Note 5 for discussion of the investment contract.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Payment of Benefits** – Benefits are recognized when paid.

**E. Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the accompanying financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**F. Subsequent Events** – Management evaluated transactions and events occurring subsequent to December 31, 2024, and through October 10, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level is based on the lowest level of any input that is significant to the measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts (PSA):* Are valued at net asset value (NAV), based upon the market value of its underlying investments, which may include equities, bonds, mutual funds, separate accounts and collective trust funds. The NAV for PSAs are not publicly quoted prices in an active market.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. These funds are required to publish daily net asset values (NAVs) and to transact at that price.

As of December 31, 2024, all plan investments valued at fair value are PSAs valued at NAV. In accordance with ASC 820, certain investments measured at fair value using the net asset value per share or its equivalent practical expedient are not classified in the fair value hierarchy. Therefore, the fair value hierarchy table has not been disclosed for 2024.

#### 5. Group Annuity Contract with Voya

The Plan entered a fully benefit responsive group annuity contract with Voya totaling \$150,299 at December 31, 2024. In accordance with the contract, contributions to the Fixed Income Account (the Account) are maintained in Voya's general account. The Account under the contract is credited with contributions and interest and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Voya which includes a credited interest rate which is compounded daily at the effective annual interest rate which will never be less than the guaranteed minimum floor rate of 1%. Voya or the Plan can terminate contributions to the Account by providing 90 days prior notice. Plan initiated transfers from the Account to similar investments or withdrawals may be restricted and subject to a market value adjustment. No such transfers or withdrawals were made as of December 31, 2024.

This contract met the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represented contribution made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Withdrawals from the account directed by the Company, an unusual volume of participant directed transfers or withdrawals which Voya reasonably concludes an employer directed withdrawal has occurred, or certain Plan sponsor events (for example, sale, merger, divestitures, or spin-offs) may limit the ability of the Plan to transact at contract value with Voya. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Voya and that also would limit the ability of the plan to transact at contract value with the participants.

#### 6. Related-Party Transactions

Plan investments are managed by Voya which is also the issuer of the Plan investments. These transactions, therefore, qualify as party-in-interest transactions. Fees incurred by the plan for these investment management services are included in the net appreciation in fair value of investments rather than a direct payment.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participant account balances become fully vested.

#### 8. Tax Status

The Plan is a preapproved non-standardized plan created by the Plan's third-party administrator and adopted by the Company January 1, 2022. The Internal Revenue Service determined and issued an opinion letter for the plan as of June 30, 2020 that the preapproved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan. However, the Plan administrator believes the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by tax authorities. The Plan administrator has analyzed tax positions taken by the Plan, and concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

#### 9. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to interest rate, market and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the value will occur, that such changes could materially affect participant account balances, and the amount reported in the statements of net assets available for benefits.
