To the Board of Directors

Opinion

We have audited the financial statements of Tradehome Shoe Stores, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the Tradehome Shoe Stores, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan covering all employees of Tradehome Shoe Stores, Inc. (the "Company") who have completed one year of service, or who have completed 1,000 hours of service during a plan year, and is an employee on the last day of that Plan Year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company's Board of Directors, which is comprised of four executives and two outside members. The Board of Directors has overall responsibility for the operation and administration of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions - Company contributions are determined by the Board of Directors of the Company and are limited to the maximum amount deductible for federal income tax purposes. The Plan does not provide for participant contributions. For the year ended December 31, 2024, the Board of Directors declared contributions of \$440,000.

Participant accounts - Each participant's account is credited with the participant's allocation of (a) the Company's contribution, (b) forfeitures of terminated participants' nonvested accounts and (c) plan earnings, and charged with an allocation of administrative expenses. Company contributions and forfeitures are allocated to participants based on the participant's number of years of continuous service and the participant's compensation for the Plan year, as defined in the Plan agreement. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Vesting - Employer contributions are subject to the following vesting schedule:

A participant, if employed by the Company, is also 100% vested at normal retirement age, total disablement, as defined by the Plan, or death.

(1) Description of plan (continued)

Notes receivable from participants - Prior to November 13, 2008, participants were allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions. Effective November 13, 2008, the Plan was amended to eliminate plan provisions providing for participant loans. The loan policy and provisions of the Plan applicable to participant loans will continue to apply to existing loans for long as those loans remain outstanding.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either (a) a lump sum distribution or rollover equal to the value of the vested portion of his or her account, or (b) installments as elected by the participant for a period of time not to exceed the life expectancy of the beneficiary or the joint life expectancy of the beneficiary and the beneficiary's spouse. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. A participant may also elect to receive a one-time "In Service" distribution of up to 50% of his or her vested accrued benefit, provided the participant remains an employee, has attained age 50, and is fully vested in the plan. The "In Service" distribution may be taken in a single lump-sum, or, taken in equal annual or more frequent installments.

Forfeited accounts - At both December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeitures are allocated to Plan participants as additional contributions. For the year ended December 31, 2024, forfeitures allocated to participants were \$92,281.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(2) Summary of significant accounting policies (continued)

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(3) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(3) Fair value measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Interest bearing cash: The carrying value approximates the fair value.

Money market funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price.

Corporate bonds and collateralized mortgage securities: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) **Related party transactions and party-in-interest transactions**

As described in Note 2, the Plan made direct payments to third party administrator and other service providers of for the year ended December 31, 2024. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(5) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(6) **Tax status**

The Internal Revenue Service ("IRS") has determined and informed the Company by letter dated July 8, 2014, that the Plan and the related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) **Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) **Subsequent events**

The plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
