NOTE 1 – DESCRIPTION OF PLAN

The following description of Hope Hospice and Community Services, Inc. (The Company, the Plan Sponsor) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan Sponsor was acquired by Chapters Health System, Inc. effective March 1, 2023.

General: The Plan is a defined contribution plan originally effective January 1, 1990. The Plan has been amended throughout the years to comply with tax legislation. The Plan was last amended and restated effective November 1, 2021, as part of the Cycle 3 remedial amendment period. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for the oversight of the Plan. The Plan administrator, along with the external investment advisors, determine the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility: Employees are eligible to participate in the Plan after completing one year of service and upon attaining 20½ years of age. One year of service is defined as a consecutive 12-month period during which an employee has at least 1,000 hours of service.

Contributions: The Company's contribution to the Plan is discretionary. The allocation of the Company's contribution is cross-tested based on segregating the Plan's participants into four groups. One group is the chaplains and the other three groups are based on salary ranges. The Company determines the amount of the contribution for each group and the contribution amount is allocated to each participant in the group based on the eligible compensation for each participant. In order for a participant to share in an allocation of the Company's contribution, they must be actively employed on the last day of the Plan year and complete 1,000 hours of service during the year. Participants, who are not actively employed due to retirement (normal or late), total and permanent disability, or death, are not eligible to share in the allocation of contributions for the Plan year. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with an allocation of the Company's contribution and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of the Company's contribution are based on the participant compensation within the applicable group. Plan earnings or losses and administrative expenses are allocated based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting: Vesting in the Company's contribution, plus actual earnings thereon, is based on years of credited service. Vesting is at the rate of 20% per year after two years of service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are only permitted one outstanding note at a time. The notes are secured by the balance in the participant's account and bear interest at a rate of 1% above the prime rate at the time of the commencement of the note. Principal and interest is paid ratably through payroll deductions.

Benefit Payments: Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 65. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts: Forfeited nonvested accounts can be used to reduce administrative expenses or used to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$318,709 and \$130,832, respectively. There were no forfeitures used to pay administrative expenses for the year ended December 31, 2024. During the year ended December 31, 2024, there were \$120,350 of forfeitures used to reduce Company contributions for the year ended December 31, 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator, along with the external investment advisors, determines the Plan's valuation policies utilizing information provided by the trustee and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions: Employer contributions are recorded in the year in which the compensation is paid to employees.

Benefit Payments: Benefit payments are recorded when paid.

Administrative Expenses: The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and loans are charged directly to the participant's account and are included in administrative expenses. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Change in Service Provider: Effective January 1, 2024 the Plan changed service providers to Lincoln Financial. The Plan documents were restated under Lincoln Financial effective January 1, 2024 and the Plan was amended to add a provision that there will be no new participants admitted to the Plan.

Subsequent Events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 – CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. ("Lincoln"), the Trustee of the Plan.

Empower Trust Company, LLC, the previous Trustee, and Empower Annuity Insurance Company of America, the previous insurance company, (collectively referred to as Empower), the previous qualified institutions of the Plan, supplied the Plan administrator with a certification as to the completeness and accuracy of the notes receivable from participants and related interest and all investment information presented on the accompanying statement of net assets available for benefits as of December 31, 2023.

As MassMutual's administrative agent and attorney-in-fact, Empower Annuity Insurance Company of America, the insurance company, on behalf of MassMutual, supplied the Plan administrator with a certification as to the completeness and accuracy of the general account on the accompanying statement of net assets available for benefits as of December 31, 2023.

NOTE 4 – FAIR VALUE OF MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 – GROUP ANNUITY CONTRACT WITH MASSMUTUAL

On January 1, 2019, the Plan entered into a fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (MassMutual). MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than -0%. The crediting rate is reviewed on a semi-annual basis for resetting. MassMutual was acquired by Empower during 2020 and the transition completed on September 9, 2022.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

On January 1, 2024, the Plan's investment in the fully benefit responsive guaranteed investment contract with MassMutual was terminated.

NOTE 6 – TRADITIONAL FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT WITH LINCOLN

On January 1, 2024, the Plan entered into a traditional fully benefit-responsive investment contract with The Lincoln National Life Insurance Company (“Issuer”) that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value was \$1,001,758 at December 31, 2024.

The Issuer maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than the guaranteed minimum interest rate, as shown on the contract specifications. The Issuer’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan’s investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances, which would allow the Issuer to terminate the contract, include the Plan’s uncured material breaches of responsibilities, misrepresentation of material information and the issuer discontinuing offering the contract to the public. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts.

NOTE 9 – PLAN TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirement of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE 9 – PLAN TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

NOTE 10 – PARTY-IN-INTEREST

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. As of December 31, 2024, the Plan is invested in a benefit-responsive investment contract issued by Lincoln. As of December 31, 2023, the Plan is invested in a benefit-responsive investment contract issued by MassMutual. Therefore, these transactions in such investments and the Plan's payment of trustee fees, record keeping fees, and investment management fees to Lincoln and Empower qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.
