Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedules, schedule H, line 4i—schedule of assets (held at end of year), and schedule H, line 4a—schedule of delinquent participant contributions, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1: Description of the Plan**

***General***

The following description of Mesa Natural Gas Solutions LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by Mesa Natural Gas Solutions LLC (the “Company”) for the benefit of its employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Mid Atlantic Trust Company served as plan trustee and custodian for the period of January 1, 2023 through May 5, 2024. Charles Schwab & Co., Inc. (“Charles Schwab”) served as the plan trustee and custodian for the period of May 6, 2024 through December 31, 2024.

***Change in Recordkeeper and Trustee***

Effective May 6, 2024, the Plan transitioned trustee and recordkeeping services from Mid Atlantic Trust Company and Paychex, Inc. (“Paychex”) to Charles Schwab. Participant account balances and plan assets were seamlessly transferred. Investment options were mapped to substantially equivalent investment vehicles where identical funds were not available. Participants were informed of a blackout period from May 6, through May 31, 2024, during which investment changes were temporarily suspended.

Administrative transition costs were paid by the Plan sponsor and not charged to the Plan. Charles Schwab and Paychex provided ERISA Section 103(a)(3)(C) certification covering investment data as of December 31, 2024, which supports the information reported in the financial statements and supplemental schedules.

***Contributions***

Employees are eligible for contributions after completing two consecutive months of eligible service. Employee traditional and roth contributions, rollover contributions, and catch-up contributions are permitted. Eligible employees are automatically enrolled at 3% of compensation. Once eligible, employees may make a change to their contribution percentage or decide to opt-out. The Company makes safe harbor matching contributions of 100% of employee contributions up to the first 4% of employees’ compensation.

***Participant Investment Account Options***

Each participant’s account is credited with the participant’s contribution, the Company’s contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Vesting in the Company's profit-sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants are immediately vested in their voluntary contributions. A participant is fully vested after two years of continuous service. The non-vested balance is forfeited upon termination of service.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account or annual installments over a 5-year period. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution. After termination, if a participant does not take action within 30 days and there is a balance of less than \$5,000, the Company will initiate an involuntary distribution.

***Forfeited Accounts***

Forfeited balances of terminated participants' nonvested accounts may be used to pay administrative expenses of the Plan or to reduce future employer contributions. For the year ended, December 31, 2024, nonvested accounts were not used to pay administrative expenses or to reduce employer contributions. At December 31, 2024, there were \$268,048 of forfeited nonvested accounts. At December 31, 2023, there were \$149,572 of forfeited nonvested accounts.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at a reasonable rate, consistent with market rates, ranging from 4.25% to 9.50% as of December 31, 2024. The loans mature on various dates through 2033. Principal and interest is paid ratably through monthly payroll deductions. However, a participant may make additional payments or repay the loan in full at any time without penalty.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The statements are presented in United States Dollars (\$) and have been prepared in accordance with accounting principles generally accepted in the United States of America ("US GAAP"). The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully

benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). As of December 31, 2024 and 2023, the Plan had no investments reported at contract value. Quoted market prices, if available, are used to value investments. Common stocks and U.S. government securities are valued at the closing price reported on the active market on which the individual securities are traded. Corporate bonds are valued on the basis of yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less a discount. If a quoted market price for unrestricted common stock of the issuer is not available, restricted common stocks are valued at a multiple of current earnings consistent with multiples of similar companies based on current market prices. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought, sold and held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest and are classified as investments on Form 5500. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Note 3: Certification of Plan Trustee**

The Company has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mid Atlantic Trust Company and Charles Schwab have certified the following information under their coverage period included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statement of net assets available for benefits and related disclosures as of December 31, 2024
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Notes receivable from participants as shown in the statement of net assets available for benefits and related disclosures as of December 31, 2024
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4: Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays any other fees related to the Plan's operations.

The Plan paid \$88,003 and \$30,842 of recordkeeping fees during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 5: Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy, and include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no securities classified as Level 2 or Level 3.

**Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 7: Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved retirement plan and trust/custodial document sponsored by Charles Schwab. This pre-approved plan document has filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service (IRS) stating that the prototype constitutes a qualified plan under Section 401 of the IRC and that the related trust was tax-exempt as of the financial statement date.

**Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10: Nonexempt Transactions**

During 2024, the Company inadvertently failed to deposit \$189,463 of participant deferrals within the required timeframe as stated by DOL regulations. There were minimal lost earnings in connection with the late deposit. The Company intends to file Form 5330 and pay the applicable excise tax in 2025. The excise tax payments will be made from the Company's assets and not from the assets of the Plan.

**Note 11: Subsequent Events**

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Effective July 15, 2025, the Company will be reporting under Mesa Natural Gas Solutions, LLC dba Mesa Power Solutions.
