

The accrued retirement benefit as of the early retirement date shall be payable commencing at normal retirement. However, a participant may elect to have his benefit commence prior to normal retirement in a reduced monthly amount determined by applying a reduction of 1/180 for each month of the first five years and 1/360 for each month of the next five years by which the commencement date precedes the normal retirement date.

Late Retirement

The late retirement benefit shall be the greater of (1) or (2) as follows:

(1) The accrued retirement benefit as of normal retirement date increased 1/2% for each month of employment past normal retirement date shall be payable commencing at late retirement.

(2) The accrued retirement benefit as of the late retirement date, using service and compensation as of the late retirement date, payable commencing at the late retirement date.
