The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 Plan Description and Basis of Presentation

The following description of the Pennoni Associates Inc. Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants and other readers should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Pennoni Associates Inc. (the “Company”) established the Pennoni Associates Inc. Employee Stock Ownership Plan (the “Plan”) on December 17, 1994, retroactively effective, January 1, 1994. The Plan is a stock bonus plan qualified under Section 401(a) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the “Code”) and a leveraged employee stock ownership plan (“ESOP”) designed to comply with Section 4975(e)(7) of the Code. The Plan is also subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan is administered by five Trustees, who are all appointed by the Company’s Board of Directors.

The Plan purchased thirty percent of the Company’s outstanding common stock on June 29, 1995, and an additional twenty-eight percent of the Company’s outstanding stock on January 24, 2003. These purchases along with additional minor purchases and contributions over the years, brought the Plan’s total stock holdings in the Company to 72.62 percent prior to the December 2018 stock purchase.

In December 2018, the Company and its shareholders agreed to convert the Company into a 100% owned ESOP. As a result of this decision, 6,315 were sold to the ESOP and the remaining shareholders’ stock was repurchased by the Company as treasury stock.

In 2023 the Company contributed 3,573 shares valuing \$5,384,511 to the plan increasing the cost basis and number of shares held by the plan (see Note 4).

Allocations

The financial statements of the Plan as of December 31, 2024, and for the year ended December 31, 2024, present separately, the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with vested rights in allocated common stock (Allocated) and
2. Common stock not yet allocated to employees (Unallocated).

Eligibility

Employees of the Company are generally eligible to participate in the Plan after they have worked at least 1,000 hours, completed one year of service, and are age twenty-one or older as of the prior January 1 entry date. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of plan year are generally not eligible for an allocation of Company contributions for such year. A participant need not be employed on the last day of the plan year to share in contributions if he or she dies, retires after reaching normal retirement age, or becomes disabled and has at least 1,000 hours of service during the plan year.

Employer Contributions

Company contributions are discretionary and are approved by the Board of Directors. Company contributions are made in cash and company stock and are authorized by the Board of Directors. The Company is obligated to make contributions to cover the yearly unfunded distributions, when applicable.

Vesting

Vesting in the Company's contributions is based on years of service. The vesting schedule for employer contributions and earnings allows for the participant to receive 20% vested interest after two years of service, with such vesting increasing by 20% per year thereafter. A participant is ordinarily 100% vested after six years of credited service, and a participant is automatically 100% vested upon reaching age 65, terminates employment due to death, or terminates employment due to disability.

Dividends

The Company did not declare or pay a dividend for the years ended December 31, 2024 and 2023. Any dividends declared and paid by the Company would be paid based on relative share balances adjusted for forfeitures and distributions.

Payment of Benefits

The following describes the circumstances in which a payment of benefits will be made from the plan:

Distributions from the Plan will be made to participants who terminate, retire, become permanently disabled or die (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), based on a time period as defined in the Plan document. A participant is also entitled to a full distribution of their account if their account has been segregated as defined in the Plan document. Distribution of vested account balances on account of termination with employment for reasons other than death, disability or retirement shall begin during the year after the close of the fifth plan year following the plan year in which the participant terminates. Vested account balances less than \$7,000 will be automatically distributed without participant consent as defined in the Plan document. Distributions are single sum payments that are made in cash and for those that do not specify otherwise are rolled into an IRA.

Payment of Benefits (continued)

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan as long as the shares are not publicly traded or in the event that the shares are subject to trading limitations. During 2024 and 2023, all eligible shares were repurchased by the ESOP Trust; therefore, the Company did not repurchase any shares from participants.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. In each of the first five years, a participant may diversify up to twenty-five percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to fifty percent.

Participants who elect to diversify receive a cash distribution. For the years ending December 31, 2024 and 2023, eligible participants chose to diversify \$632,054 and \$335,885 in assets, respectively. The total value of shares eligible for diversification for the years ending December 31, 2024 and 2023 totaled \$4,802,567 and \$3,371,627, respectively.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts based upon the relation of the participant's compensation (W-2 compensation plus elective deferrals under 401(k) and Section 125) to total eligible compensation for the Plan year. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance to the total account value.

Forfeitures

Forfeitures of terminated non-vested account balances resulting from a participant's break in service, are allocated along with other shares on the last day of the year to each participant's account based on the relation of the participant's compensation to total eligible compensation for the Plan year. Forfeited and terminated non-vested account balances allocated at December 31, 2024 totaled approximately 414.81 shares. Forfeited and terminated non-vested account balances allocated at December 31, 2023 totaled approximately 360.04 shares.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which direction has been given by a participant. The Trustee is required, however, to vote any undirected shares on behalf of the collective best interest of plan participants and beneficiaries.

Administration of Plan Assets

The Plan's assets, which consist principally of the Company's common stock, are held by the Trustees of the Plan. Company contributions are held and managed by the Trustees, which invest cash received and make distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

The Plan's administrator of the registered investment company investments for the years ending December 31, 2024 and 2023 is TI Trust, who is also a named fiduciary of the Plan.

Plan Termination

The Company reserves the right to amend or terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to the participant or his or her beneficiary at the time prescribed by the Plan's terms and the Code.

Administrative Expenses

Investment advisor and other related investment fees are paid by the Plan. Expenses of maintaining the Plan are paid by the Company.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Recognition

The shares of the Company common stock and other ESOP investments are valued at fair value. See Note 5 for a discussion on the fair value measurements. Dividend income, if any, is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Realized gains and losses from security transactions, if any, are reported on the average cost method. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Distributions Payable

Accounts payable to participants for distributions owed but not yet paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management and other individuals valuing Company shares to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan’s investments are primarily made up of the investment in the Company’s common stock, as well as money market accounts and exchange traded funds. These investments are subject to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques (for valuation of Company’s common stock). Due to the level of risk associated with the significant investment in the Company’s common stock and to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that changes in the risk in the near term could materially affect participant’s account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 3 Tax Status

The Internal Revenue Service has determined that the Plan is qualified, and the Trust established under the Plan is tax-exempt, under the appropriate sections of the Code. The Plan has been amended since receiving the determination letter, however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan was qualified, and the related Trust was tax-exempt as of the financial statement date, and no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 Investments in Company's Common Stock

Note 5 Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The following presents fair value measurement information for certain financial instruments. The carrying values of receivables and cash included in the accompanying statement of net assets available for benefits approximated fair value at December 31, 2024.

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Measurements and Disclosures*, provides the framework for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Pennoni Associates Inc. Common Stock* - The fair value of the Pennoni Associates Inc. common stock held by the Plan is valued at fair value based upon independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser used the following unobservable inputs for the income valuation techniques: EBITDA, net income, weighted average cost of capital, discount rate, and discount for lack of marketability. For the market valuation technique, the appraiser used the following unobservable inputs: public comparables, revenue multiple, EBITDA multiple, and discount for lack of marketability.

The valuation process involves the selection of an independent appraiser under contract. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a preliminary report that plan management, along with the ESOP trustees, reviews in detail, discusses, and approves. The results of this process are documented in minutes of the plan fiduciary.

*Exchange Traded Funds* – valued at the daily closing price of the underlying securities which is measured at exchange traded funds performance. Exchange traded funds held by the Plan are funds that are registered with the Securities and Exchange Commission. The exchange traded funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
