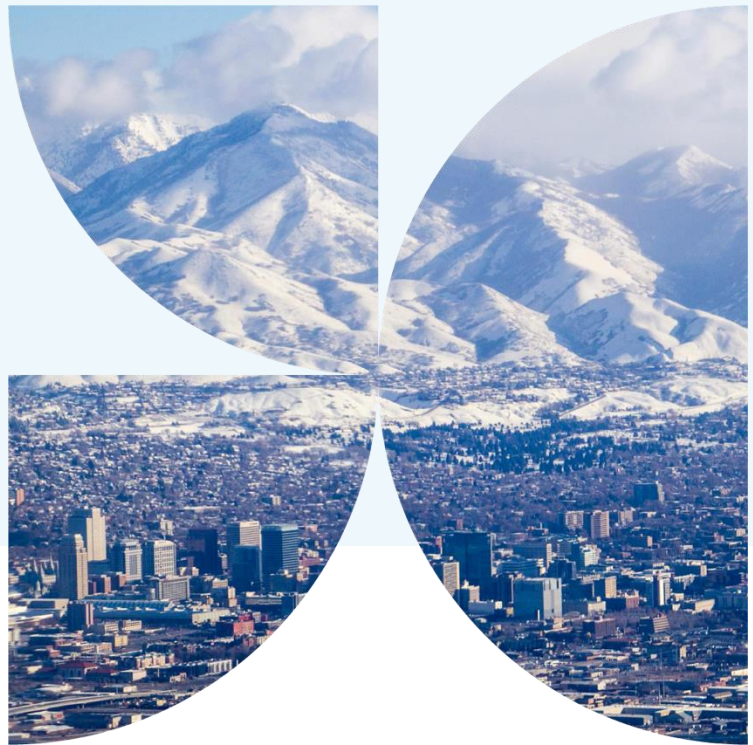

We have performed audits of the accompanying financial statements of Guardian Management LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting describe in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Managing is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental schedules of (1) Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) (modified cash basis) and (2) Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions (modified cash basis) are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Basis of Presentation

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental scheduled were prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

1. **DESCRIPTION OF PLAN**

The following description of the Guardian Management LLC 401(k) Plan (the “Plan”) is provided for informational purposes only. Participants should refer to the Plan Document and Summary Plan Description for more complete information.

General – The Plan is a defined contribution plan covering all employees of Guardian Management LLC (the “Company”) who have completed one year of service and attained the age of 21. The Plan excludes employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may make elective deferral contributions, traditional and Roth, subject to the allowable amounts imposed by federal income tax laws. Total contributions are limited to \$23,000 for 2024 and \$22,500 for 2023, plus a catchup contribution for those participants age 50 or older. Contributions which exceed allowable limits are returned to the participants.

The Plan provides for a safe harbor matching contribution for all participants who have made elective deferrals. The Company will match 100% of the first 3% contribution made by the employee and 50% of the next 2%. The Company made \$309,795 and \$274,702 in safe harbor employer contributions for the Plan years ended December 31, 2024 and 2023, respectively.

The Plan also provides for employer discretionary contributions, which are made at the discretion of the Board of Directors. Employer discretionary contributions are allocated to eligible participants in the ratio that each participant’s compensation bears to the total compensation of all participants. There were no employer discretionary contributions made for 2024 and 2023.

Participants’ Accounts – Each participant’s account is credited with the participant’s contribution, the Company’s safe harbor contribution, plus an allocation of Plan earnings. Allocations of Plan earnings are based on participants’ account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of service. A participant is 100% vested after completion of 6 years of service. However, in the event a participant’s employment terminates by reason of retirement (at or after Normal Retirement Age), death, or disability, all contributions and earnings thereon are 100 percent vested regardless of the number of years of service. A year of service for vesting purposes requires a minimum of 1,000 hours in a calendar year.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans must be repaid within five years, unless the loan proceeds are used to acquire the participant’s principal residence, in which case the administrator may permit a longer repayment term. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest which is deemed to be equal to the prime rate plus 2% on the date the loan is made for loans after June 13, 2014. Interest rates on loans outstanding at December 31, 2024 range from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

1. **DESCRIPTION OF PLAN** - Continued

Forfeitures – Forfeitures are retained in the Plan and generally will be used to pay administrative expenses. Any remaining amount may be used to reduce future Company contributions. For the years ended December 31, 2024 and 2023, \$9,250 and \$6,850, respectively, were used to pay administrative expenses. Amounts forfeited during the years ended December 31, 2024 and 2023, were \$2,455 and \$974, respectively. At December 31, 2024 there was \$2,306 of unused forfeitures available to carry forward to 2025.

Benefit Payments – Participants are eligible for benefit payments upon retirement, termination of employment, death or total and permanent disability. The Plan also has provisions for hardship distributions as permitted by the Internal Revenue Code. Benefits are payable in cash in the form of lump-sum distributions or other options as described in the plan agreement.

2. **SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation – The accompanying financial statements have been prepared on the modified cash basis of accounting whereby participant and employer contributions as well as investment income are recorded when received by the Plan and expenses are recognized when paid. The modified cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

Administrative Expenses – Charges by Great-West Trust Company, LLC (“Great-West”) and other fees charged to the Plan are reflected as administrative expenses in the accompanying statements. Certain other costs of administering the Plan such as payroll expenses of administrative and clerical personnel are incurred by the Company without charge to the Plan.

Investment Valuation and Income Recognition – The Trust’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The board of trustees determines the Trust’s valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year, and reinvested dividends from mutual funds.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Estimates – The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

3. **PARTICIPANT DIRECTED INVESTMENTS**

At December 31, 2024 and 2023 all investments were participant directed.

4. **INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Great-West in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments of \$6,974,645 and \$6,287,536 at December 31, 2024 and 2023, respectively, and related investment income of \$743,336 and \$846,631 for the years ended December 31, 2024 and 2023, respectively.

5. **FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Trust are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Trust are actively traded.

Insurance Company General Account: Key Guaranteed Portfolio Fund: The Key Guaranteed Portfolio Fund (KGPF) is a general account product of Great-West Life & Annuity Insurance Company (GWL&A). Because the KGPF is a general account product offered through the group annuity contract, principal and interest for participant-initiated benefit payments are fully guaranteed by the entire general account assets of GWL&A.

The investment strategy employed for the KGPF seeks to achieve consistent returns to support a competitive credit rate. Bonds invested in the general account segment have an average maturity between three and seven years; are investment-grade in quality; and are diversified across a range of fixed-income asset classes such as asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgage, private equity, etc.

5. **FAIR VALUE MEASUREMENTS** – Continued

A participant may transfer their account balance in the KGPF to any other investment option offered under the plan. Most transfers will occur the next day, however, participant transfers may be restricted for up to 30 days in the event of excessive participant trading. Management believes that no events are probable of occurring that might limit the ability of the participants to transact with the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels – The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported on the actual date of the event or change in circumstances that caused the transfer.

The Plan's management evaluates the significance of transfers, if any, between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2 or 3.

6. **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no differences between the Form 5500 and the financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

8. INCOME TAX STATUS

The IRS has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan may be amended from time to time, however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan's management does not believe the Plan has engaged in any activities that would result in income taxation and, as a result, has concluded that as of December 31, 2024 there are no uncertain position taken or expected to be taken that would require recognition of an income tax liability or other disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress and the trustees believe that the Plan is no longer subject to income tax examinations for years prior to 2021.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time. In the event of termination of the Plan, participants will become fully vested and the Plan's trustee will liquidate all Plan investments and distribute the amount realized to all participants.

10. PARTY-IN-INTEREST TRANSACTIONS

Fees paid to the Plan's recordkeeper, investment advisor, and third party administrator, qualify as party-in-interest transactions. The transactions with parties-in-interest are summarized below:
