NOTE A - DESCRIPTION OF PLAN

The following description of the Michels Corporation 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible nonunion employees of Michels Corporation and Subsidiaries (the Employer or Michels), as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

The Plan was amended on January 1, 2023, to include employees of J. D. Hair & Associates, Inc. a subsidiary of Michels Construction, Inc. Effective August 7, 2023, the Plan was amended to include employees of Mountain Tunnel Constructors, Inc. a subsidiary of Michels Corporation, Inc. Effective February 26, 2024, the Plan was amended to include employees of Michels Underground Cable, Inc. a subsidiary of Michels Utility Services, Inc. Effective December 2, 2024, the Plan was amended to include employees of Michels Preconstruction Services, Inc. a subsidiary of MICON Group, Inc. Employees are credited with years of service while employed by any one of the Michels family of companies.

Plan Administration

The Plan is administered by the Company. Prior to December 15, 2023, Principal Trust Company (Principal) acted as the trustee and recordkeeper of the Plan. Effective December 15, 2023, the Plan switched to T. Rowe Price as the trustee and recordkeeper. With this transfer of services, the Plan entered into a new Adoption Agreement and recordkeeping agreement.

Contributions

Participants may elect to make pre-tax and/or Roth contributions as a percentage of their annual compensation, not to exceed the limits of the Internal Revenue Code (IRC) as defined in the Plan document. These deferrals are specifically allocated to the account of the individual participant.

Participants are automatically enrolled in the Plan at an employee deferral contribution rate of 3% of eligible compensation. All employees with more than 30 days of service who are not covered by a CBA are eligible to participate in the Plan. All participants enrolled in the Plan will have a 1% annual increase in deferral percentage until a maximum contribution percentage of 6% is reached, unless the participant opts-out of the auto-escalation feature. The Plan also permits participants to make rollover contributions from other qualified retirement plans.

Matching contributions may be made by the Employer at an amount equal to a discretionary percentage of the amount of participant's pre-tax contributions, as determined by the Employer. The Employer matched 40% of the first 5% of employee deferrals for the 2024 and 2023 Plan years. In addition to the matching contributions, the Employer makes a fixed contribution of \$1.00 for each hour of service worked by the participant during the Plan year. Employees must complete one year of service to be eligible for the fixed contribution. The Employer made both discretionary matching contributions and fixed contributions to all eligible participants for the years ended December 31, 2024 and 2023.

Also, the Employer may make a profit-sharing contribution to the Plan at the discretion of the board of directors. No such contribution was made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited or charged with the participant's contribution and an allocation of: (a) the Employer's discretionary matching contribution; (b) the Employer's fixed contribution; (c) the Employer's discretionary profit-sharing contribution; (d) Plan investment income (loss); and (e) Plan administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan document. The Plan allows participants to invest their account balances between or among separate investment funds established by the trustee within the trust.

The Plan does not allow loans to be taken out by Plan participants.

Vesting

Participants are immediately vested in their voluntary contributions, including rollover amounts, plus actual earnings thereon. Vesting in the Employer contributions portion of their account plus earnings thereon is based on years of continuous service. A participant is vested in employer contributions at 20% per year starting in year two and is 100% vested after six years of credited service.

Payment of Benefits

Upon termination of service due to termination of employment, death, disability, or retirement, a participant may elect to receive the value of the vested portion in his or her account in the form of a lump-sum distribution or installments. Any benefits provided by the Plan are paid from the net assets available for benefits. The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated to such participant's account. The method of distribution will be determined by an election made by the Plan participant. The participant can elect a lump-sum distribution, partial distribution or installment payments for a specified term as defined in the Plan document. The source of distribution will be determined by an election made by the Plan participant for in-service, post-severance and lifetime required minimum distributions. Participants experiencing financial hardship may withdraw a portion of this account balance as defined by the Plan document.

Forfeited Accounts

Forfeited non-vested accounts from Employer matching and fixed contributions may be used to reduce non-elective contributions to the Plan or be used to pay administrative expenses of the Plan. Forfeitures of terminated participants' non-vested account balances used to reduce Employer contributions amounted to \$989,162 and \$356,795 for the years ended December 31, 2024 and 2023, respectively. There were \$125,515 and \$85,870 of forfeitures used to pay administrative expenses of the Plan for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the outstanding balance of forfeited non-vested accounts totaled \$805,362 and \$538,767, respectively.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

The significant accounting policies which have been consistently applied in the preparation of the accompanying financial statements follow:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain Plan administrative expenses are paid by the Plan and expensed when incurred. All other administrative expenses are paid by the Employer.

NOTE C - TAX STATUS

The Internal Revenue Service (IRS) issued its latest opinion for the plan on August 19, 2020, which stated that the Plan and its underlying trust qualify under the applicable provisions of the IRC and, therefore, are exempt from federal income taxes. The opinion does not cover all amendments to the Plan. However, in the opinion of the Plan administrator, the Plan and its underlying trust have operated within the terms of the Plan in all material respects and remain qualified under the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall become 100% vested in their accounts.

NOTE E - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the net asset value (NAV) of shares held by the Plan at year end, which is obtained from an active market.

Collective trust funds - Valued at the NAV of units of a collective trust is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F - RISKS AND UNCERTAINTIES

Investments

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements of the Plan.

NOTE G - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by T. Rowe Price. On December 15, 2023, the Plan's trustee changed from Principal Trust Company (Principal) to T. Rowe Price. T. Rowe Price and Principal are the trustees as defined by the Plan and, therefore, any transactions with T. Rowe Price or Principal qualify as party-in-interest transactions. However, they are exempt from the prohibited transactions rules under ERISA.

A portion of the costs of administering the Plan are paid by the Employer and are exempt from the prohibited transactions rules under ERISA. These costs include audit fees, investment advisory fees and custodial fees.

NOTE H - INFORMATION CERTIFIED BY TRUSTEES

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the trustee for the period from January 1, 2023 through December 15, 2023, and T. Rowe Price, the trustee as of and for the year ended December 31, 2024, and for the period from December 15, 2023 through December 31, 2023, have certified that the following data included in the financial statements and supplemental schedule are complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4i - schedule of assets (held at end of year), as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE I - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024, financial statements for subsequent events through September 26, 2025 the date the financial statements were available to be issued. There were no subsequent events required to be recorded or disclosed in the Plan's financial statements, except as disclosed below.

Effective January 1, 2025, the Plan was amended to increase the auto-enrollment default percentage to 5% and increase the auto-escalation maximum contribution to 15%.

Effective March 3, 2025, \$8,217,648 of account balances of the participants of the Equix Holdings, Inc. 401(k) Retirement Savings Plan who were employees of Mi-Tech Services, Inc., a business acquired by the Company in 2025, were transferred into the Plan.
