NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Joe & The Juice US Holdings, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan was established on January 1, 2024 and covers all eligible employees of Joe & The Juice US Holdings, Inc. (the Company and Plan Administrator). Investment management fees and a portion of administrative expenses are paid by the Plan. At December 31, 2024, the assets of the Plan were maintained in investment funds held by Reliance Trust Company (Reliance), the Trustee of the Plan. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

Eligibility

Employees of the Company who are not covered by a collective bargaining agreement are eligible to participate in the Plan on the first day of the month following completion of three months of credited service, as defined, and being 21 years of age.

Contributions

Participants may authorize a pre-tax elective deferral contribution up to 50% of earnings. Roth elective deferrals are permitted under the Plan. The Plan does not provide matching contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Newly eligible participants are automatically enrolled with a 3% elective deferral upon meeting the eligibility requirements unless a different affirmative election is made.

Participants direct the investment of employee contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) plan earnings and losses and (b) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum term of repayment for a loan is five years, unless it is for the purchase of a principal residence, in which case it may be longer. A participant may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

1. DESCRIPTION OF THE PLAN (Continued)

Withdrawals and Distributions

Unless a participant elects otherwise, distributions are made as soon as practical after the participant's normal retirement date or actual retirement date occurs. The normal retirement date is the date upon which the participant reaches age 65.

Participants may also receive hardship distributions under certain circumstances, as defined in the Plan Document. The Plan also allows for in-service withdrawals for employees who attain age 59 $\frac{1}{2}$.

Administrative Expenses

Investment fees are paid by the Plan. Administrative expenses not paid by the Plan are paid by the Plan Administrator.

Vesting

Participants are automatically 100% vested in their pre-tax, Roth, and rollover contributions.

Forfeitures

Forfeitures of non-vested separated participants are used to pay certain administrative expenses. At December 31, 2024, there were no forfeited nonvested account balances.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their account balances.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold or held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the financial statements.

Benefit Payments

Benefits are recorded when paid.

Income Taxes

The Plan uses a prototype plan document sponsored by Automatic Data Processing (ADP). ADP received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the prototype Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024, as well as investment income and investment transactions for the year then ended, has been derived from information provided by Reliance, the Trustee of the Plan, and has been certified by them as complete and accurate. The incorporation of this financial information in the accompanying financial statements is based solely on the certification.

4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. The Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued based on quoted market prices in active markets.

Common collective trust fund: Valued at the net asset value (NAV) of units of the collective trust, using independent pricing services approved by the trustee. The net asset value is based on the fair value of the underlying investments held by the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. There are no unfunded commitments or redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
