### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mana Products, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Mana Products, Inc. Profit Sharing Plan (the “Plan”) provides general information about the Plan for informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a participant-directed defined contribution plan established on July 1, 1981 by Mana Products, Inc., Subsidiaries and Affiliates (the “Company” or “Plan Sponsor”) to provide benefits for eligible employees as defined in the Plan document. Fidelity Management Trust Company (“Fidelity” or “Trustee”) serves as custodian and recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### Plan Administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. Fidelity serves as the Plan’s directed trustee and asset custodian. Fidelity also provides record-keeping services and manages participant accounts and participant related transactions.

#### Participant Contributions

Each year, participants may elect deferrals up to a maximum of 60% of pretax annual compensation, as defined by the Plan. Compensation and deferral amounts are also subject to certain Internal Revenue Code (“IRC”) limitations. Participants may also elect to make Roth Contributions on an “after-tax” basis to the Plan and may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans. During 2024, the maximum annual 401(k) pre-tax contribution limit was \$23,000 and the maximum annual catch-up contribution for participants aged 50 and older was \$7,500.

#### Employer Contributions

The Plan provides for discretionary employer matching contributions for all eligible participants. During 2024, the Company made employer discretionary matching contributions of 1% of the participant’s eligible compensation which totaled \$235,556. The Plan also allows for discretionary annual employer profit sharing contributions. For the year ended December 31, 2024, there were no profit sharing contributions made to participants.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant’s account is credited/charged with the participant’s deferral, the Company’s matching contribution and allocations of the Company’s discretionary contributions, if any, of Plan earnings (losses), and of administrative expenses. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies’ match contributions are directed based upon the participant’s allocations. The Plan currently offers various investment options for participants. Participants may change their investment choices daily.

#### Vesting

Participants become immediately vested in their elected deferrals and the Company's matching contributions. Participants are vested in their discretionary profit-sharing amounts based upon years of continuous service. A participant vests 20% for each year of participation after completion of the second year of service and is 100% vested after six years of service.

#### Notes Receivable from Participants

Notes receivable from participants represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear annual interest at a fixed rate commensurate with the prime rate (7.50% and 8.50% as of December 31, 2024 and 2023, respectively) as determined by the Plan Sponsor. Principal and interest are paid through payroll deductions. Interest rates on notes receivable from participants mature at various times through July 2031 and bear interest rates between 3.25% and 8.50%.

#### Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. However, if the participant is re-employed and fulfills certain requirements, as defined in the Plan, the participant's account will be reinstated.

At December 31, 2024 and 2023, the forfeited unvested accounts amounted to \$4,111 and \$1,488, respectively. Unvested forfeitures of the Plan (except profit sharing contributions) may first be used to reduce expenses related to the administration of the Plan and then to reduce Employer contributions. During 2024, no forfeitures were used to reduce expenses or Employer contributions. Unvested forfeitures of profit sharing contributions, if any, are reallocated among participants annually. Unused forfeitures may be used to reduce administrative costs of the Plan. Any remaining amounts may then be used to reduce future employer matching contributions.

#### Hardship and In-Service Withdrawals

Plan participants may take hardship withdrawals from the vested portion of their account. The distribution is limited to the amount necessary to meet the financial need created by the hardship. Participants may withdraw all or a portion of any rollover contributions, plus earnings thereon, for any reason. Participants who have reached age 59 ½ may withdraw all or a portion of the vested portion of their account for any reason.

#### Benefit Payments

Upon termination, retirement, death or disability, participants may, in accordance with the Plan provisions, elect to receive their vested account balance in (a) a lump sum, or (b) annual installments over the life of the participant and a designated beneficiary, with commencement of payment as prescribed in the Plan documents. Participant accounts not exceeding \$1,000 shall be paid in an immediate single, lump-sum payment.

#### Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

#### Deemed Distributions

Deemed distributions are recorded when a participant ceases making repayments on a loan from the Plan for three months. These amounts are no longer included in net assets available for benefits. During the year ended December 31, 2024, there were \$2,057 of deemed distributions.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan invests in various investment securities, including mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those such changes could materially affect the amounts reported in the financial statements.

#### Investment Valuation and Income Recognition

All Plan investments are held by the Trustee. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for discussion of fair value measurements). The investment Committee determines the Plan's valuation policies utilizing information provided by the trustee.

#### **Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, as the notes are collateralized by the participant's account balance. Delinquent notes receivable from participants are recorded as a distribution upon the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were available to for issuance, October 13, 2025.

### **NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of the investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing prices as reported by the Fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds managed by Fidelity Investments Management Services, LLC and Fidelity Investment Institutional Operations Co., affiliates of the Trustee and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Additionally, certain employees and officers of the Plan Sponsor, who may also be participants in the Plan, perform administrative services to the Plan, without a charge to the Plan for such services. Administrative fees paid by the Plan to the Trustee were \$27,232 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

### **NOTE 6 – TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a Cash or Deferred Arrangement (“CODA”) sponsored by FMR LLC. FMR LLC received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, which states that the Plan satisfies the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan’s management does not believe it has any uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan document, to terminate the Plan upon notice in writing to the Trustee, subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### **NOTE 8 – PROHIBITED TRANSACTIONS**

The DOL considers late deposits to be prohibited transactions. Plan Management determined that during the year ended December 31, 2023, the Plan Sponsor failed to remit certain employee deferrals to the Plan in a timely manner according to DOL regulations. For the year ended December 31, 2023, these late remittances totaled \$26,397. The Employer has undertaken the necessary procedures to calculate and reimburse the affected participants for lost earnings due to the late contributions occurring in the year ended December 31, 2023, under the DOL’s Voluntary Fiduciary Correction Program (“VFCP”).
