## INDEPENDENT AUDITORS' REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Apartment Services, Inc. 401(k) Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE A – DESCRIPTION OF THE PLAN**

The following description of the Apartment Services, Inc. 401(k) Savings and Retirement Plan, (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering all employees of Apartment Services, Inc. (the Sponsor) who have at least three months of service and are age twenty-one or older. Employees are eligible to receive discretionary matching contributions and profit-sharing contributions after three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan adopted provisions of the CARES Act and SECURE Act during 2020. The Plan document will be formally amended for the provisions of the CARES Act and SECURE Act by December 31, 2025 in accordance with the legislation.

**2. Contributions**

Each year, participants may contribute up to the maximum allowed by the applicable laws. The contribution limit for 2024 under the Internal Revenue Code (IRC) was \$23,000 for participants under age 50 plus a \$7,500 catch up contribution for those aged 50 or older. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Beginning April 1, 2024, participants may make Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation for the initial year, with an additional 1% each subsequent year until the deferral rate reaches 10%. Automatically enrolled participants have their contributions invested in a designated fund until changed by the participant.

The Sponsor may elect to make discretionary matching contributions and/or profit sharing contributions. The discretionary matching and profit sharing contributions are invested in the same investment options and allocation percentages as the participant-directed contributions. For the year ended December 31, 2024, the Sponsor's discretionary matching contributions were 25% of participants' elective deferrals to a maximum of 6% of eligible wages. No profit sharing contribution was made for the year ended December 31, 2024.

## **NOTE A – DESCRIPTION OF THE PLAN – Continued**

### **3. Participant Accounts**

Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as allocations of the Sponsor's profit sharing contributions and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **4. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is vested 20% after their first year of service, and an additional 20% each year thereafter. A participant is fully vested after five years of credited service.

### **5. Notes Receivable from Participants**

Beginning February 1, 2024, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, as defined by law. The loans are secured by the balance in the participant's account and bear interest at rates of 8.75% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator.

### **6. Payment of Benefits**

On termination of service due to death, disability, retirement or termination of service due to other reasons, a participant or the participant's estate or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account. Hardship withdrawals are permitted by the Plan.

### **7. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$494 and \$25,538 respectively. These accounts will be used to reduce future matching contributions. During the year ended December 31, 2024, \$59,053 of forfeited non-vested accounts were used to reduce employer contributions.

### **8. Unallocated Accounts**

In accordance with the Recordkeeping Fee Agreement with Vanguard Fiduciary Trust Company (Vanguard), annual budgeted administrative fees were deducted quarterly from participant accounts on a pro-rata basis. The funds were transferred to the Plan Revenue Account to pay future Plan expenses. During the year ended December 31, 2024, fees totaling \$13,554 were paid from the Vanguard unallocated accounts. Unallocated accounts transferred from Transamerica to ADP during the year ended December 31, 2024 were not used in 2024. At December 31, 2024 and 2023, the unallocated accounts totaled \$8,327 and \$21,398, respectively.

## **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **1. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **2. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expenses during the reporting period. Actual results could differ from those estimates.

### **3. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **4. Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024.

### **5. Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024, as required by the IRS.

### **6. Contributions**

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

### **7. Payment of Benefits**

Benefits are recorded when paid.

## **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued**

### **8. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Certain fees related to the administration of participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **9. Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.

## **NOTE C – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed or derived from information certified as complete and accurate by Vanguard, the Plan's trustee as of December 31, 2023 and for the period from January 1, 2024 to January 31, 2024 and Reliance Trust Company, the Plan's trustee as of December 31, 2024 and for the period from February 1, 2024 to December 31, 2024.

## **NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## **NOTE D – FAIR VALUE MEASUREMENTS – Continued**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Stable Value Common Collective Trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

## **NOTE E – RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by Vanguard, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Administrative fees paid by the plan to Vanguard totaled \$1,350 for the year ended December 31, 2024. ADP, Inc. (ADP) is the record-keeper as defined by the Plan, and, therefore, transactions with the Plan and ADP qualify as party-in-interest transactions. The fees paid by the Plan to ADP for the year ended December 31, 2024 totaled \$19,469. Advisory services are provided to the Plan by Greenspring Advisors, LLC (Greenspring), an investment advisory company, and transactions with Greenspring qualify as party-in-interest transactions. Payments to Greenspring by the Plan totaled \$54,556 during the year ended December 31, 2024. As described in Note B, the Plan Sponsor pays directly any other fees related to the Plan's operations.

## **NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contributions.

## **NOTE G – TAX STATUS**

The Internal Revenue Service issued a standard prototype profit sharing opinion letter to The Vanguard Group dated June 30, 2020, stating that its prototype plan document was designed in accordance with applicable Internal Revenue Code requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

## **NOTE G – TAX STATUS – Continued**

The Internal Revenue Service issued a standard prototype profit sharing opinion letter to ADP dated October 6, 2020, stating that its prototype plan document was designed in accordance with applicable Internal Revenue Code requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
