**NOTE A—PLAN DESCRIPTION AND BASIS OF PRESENTATION**

The following description of the MDR Construction, Inc. (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description to the Plan's provisions.

**General.** The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are age 18 or older. The Plan is subject to the provisions of ERISA. The Trustee is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustee.

**Contributions.** Each year, Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan does not include an auto enrollment provision. Participants must elect to participate once eligibility is met. MDR Construction, Inc. does not match employee contributions.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Because there is no employer match, participants are always fully (100%) vested in their elective deferral account, rollover contribution account, and qualified non-elective contribution account. At the time employer exercises their matching contribution, participant vesting schedule will be based on years of continuous service.

**Participant Loans.** Participants may not make loans from their accounts.

**Payment of Benefits.** On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeited Accounts.** All participants are fully vested; therefore, no non-vested portions of the accounts are considered forfeitures.

**NOTE B—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates.**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.**

Benefits are recorded when paid.

**Expenses.**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events.**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**NOTE C—FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to un-observable inputs (level 3).

The asset of liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE D—GROUP ANNUITY CONTRACT WITH JOHN HANCOCK**

In 2015, the Plan entered into a group annuity contract with John Hancock Life Insurance Company (John Hancock). John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. The Company may terminate the contract at anytime by requesting a withdrawal of the balance of all accounts subject to the provisions in the contract. This contract is not a fully benefit responsive contract, therefore it is not recorded at contract value.

Sub-accounts are investment options available under separate accounts of John Hancock. These accounts are described on Separate Account Riders attached to the Contract with the life insurance company. The value of investments in the sub-accounts will increase or decrease to reflect the investment experience of the sub-account. John Hancock assumes no fiduciary responsibility and provides no investment advice in doing so, and the Company retain the discretion to accept or reject investment options for the Plan.

**NOTE E—RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by John Hancock Life Insurance Company. The plan administrator contributes to the Plan as an employee of MDR Construction, Inc. and, therefore, these transactions qualify as party in interest transactions.

**NOTE F—PLAN TERMINATION**

It is the intention of the Plan sponsor, that this Plan will be permanent. However, the Plan sponsor reserves the right to terminate the Plan at any time for any reason. Upon termination of the Plan, participant accounts shall be distributed in a single lump sum payment.

**NOTE G—TAX STATUS**

The IRS has determined and informed the Company by a letter dated January 1, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that is more than likely than not would not be sustained upon examination by the Mississippi Department of Revenue. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
