## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the Bishop McCann LLC 401(k) P/S Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter – 2024 Supplemental Schedules Required by ERISA**

The supplemental Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, and the supplemental Schedule of Assets as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.



## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023 (UNAUDITED)

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Bishop McCann LLC 401(k) P/S Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The Plan was originally established January 1, 2006, and was amended and restated to adopt the Third Cycle Restatement effective August 26, 2021. The Plan was amended to convert from a discretionary match to a safe-harbor match calculated on a payroll basis with an effective date of January 1, 2021. Remaining plan provisions were unchanged.

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") for employees of Bishop McCann LLC (the "Company").

PAI Trust Company, Inc. (a subsidiary of Newport Group, Inc.) served as the Plan's investment custodian and trustee through September 14, 2023. PAI Retirement Services also served as the participant recordkeeper. In April 2022, Ascensus, LLC acquired Newport Group, Inc. The Plan merged into the Ascensus platform effective September 15, 2023. Ascensus Trust Company serves as the Plan's investment custodian and trustee. Ascensus, Inc. serves as the participant recordkeeper.

**Eligibility** – An individual is eligible to participate in the Plan after completing six months of service and upon reaching the age of 21. Entry dates for employee and employer contributions are the first day of the month following eligibility. The Plan excludes union employees and nonresident aliens.

**Contributions** – Participants may contribute amounts up to certain Internal Revenue Code ("IRC") limitations. Participants may contribute pre-tax amounts (401(k) contributions) or after-tax amounts (Roth contributions). A participant who is at least 50 years old may also contribute catchup contributions to the Plan.

The Company makes a safe-harbor matching contribution to all eligible employees who have deferred to the Plan at a rate of 100% of the first 3% of eligible earnings contributed, and 50% of the next 2% of eligible earnings contributed. The safe harbor matching contribution is paid into the Plan each payroll. An employee is eligible for the safe harbor matching contribution after 6 months of service with entry on the first day of the month following eligibility.

The Company may make a discretionary matching contribution paid into the Plan each payroll. No discretionary matching contribution was declared in 2024.

The Company may also make a discretionary profit-sharing contribution. A participant must be employed on the last day of the year and work 1,000 hours in that Plan year in order to receive a profit-sharing contribution (if declared). No profit-sharing contribution was declared in 2024.

**Participant Accounts** – Each participant's account is credited with the participant's and Company's contributions, investment earnings (losses), and is charged with the participant's withdrawals and distributions, and an allocation of expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options** – Participants may direct their contributions to various mutual funds or common collective trust funds.

**Vesting** – Participants' contributions and safe harbor matching contributions are fully vested at all times. Profit sharing contributions and additional matching contributions, if any, vest in 20% increments, with 20% vested after 2 years of service and becoming fully vested after 6 years. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested. An employee must work 1,000 hours in a year to earn one year of service.

**Forfeitures** – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. During 2024, no forfeitures were used to pay Plan expenses or to reduce employer contributions. As of December 31, 2024 and 2023, there were \$127 and \$121 in forfeitures, respectively.

**Payment of Benefits** – Distributions of a participant's vested balance may occur upon normal retirement, termination of employment, death, or permanent and total disability in the form of a total lump sum or installment payments. Participant balances under \$1,000 may be automatically distributed. If a participant's account balance is between \$1,000 and \$7,000, the balance will be automatically rolled over to an IRA, unless a different election is made.

**In-Service Withdrawals** – Certain participants may make withdrawals prior to termination of employment.

- Hardship withdrawals are available from all accounts.
- Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.
- Participants may withdraw amounts that are designated as rollover contributions at any time.

**Notes Receivable from Participants** – Participants are permitted to borrow against their individual account balances (salary deferral portion, only) a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the participant's vested account balance. Interest rates on the loans are set at 1% plus the prime rate, as determined by the *Wall Street Journal*. Loan terms are in accordance with limitations set forth by the Internal Revenue Service, and may not exceed five years, unless the loan is to purchase a primary residence. Loan repayments are made ratably through payroll deductions. A participant is allowed two loans at a time.

**Administrative Expenses** – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. During 2024, the Plan paid administrative expenses of \$50,245.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants shall become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Management fees and operating expenses charged to the Plan for investments in mutual funds and the common collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

**Date of Management's Review** – Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds and Money Market Fund – Valued at the net asset value (“NAV”) of shares held by the plan at year end.

Common and Collective Trusts (“CCT”) – Valued at the NAV of units of the trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. These investments consist of CCTs which are valued daily, can be redeemed daily with no notice, and have no unfunded commitments.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### 5. INFORMATION CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Ascensus Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants and related interest
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays certain fees to Ascensus to administer the Plan and to Capital Trust Advisors for investment advice. These transactions qualify as party-in-interest. Notes receivable from participants also qualify as party-in-interest.

**7. TAX STATUS**

The Plan has adopted a prototype non-standardized pre-approved profit-sharing plan with CODA, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Company believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

**9. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, employee deferrals and loan payments of \$42,113 were withheld from two payrolls and not remitted to the trust on a timely basis (as defined by the DOL) by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust. The Plan Sponsor is in the process of paying the appropriate excise tax and contributing the amount of lost earnings to the Plan for these late contributions. These transactions are prohibited according to the provisions of the DOL.

During the year ended December 31, 2023, employee deferrals and loan payments of \$23,496 were withheld from one payroll and not remitted to the trust on a timely basis (as defined by the DOL) by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust. The Plan Sponsor is in the process of paying the appropriate excise tax and contributing the amount of lost earnings to the Plan for these late contributions. These transactions are prohibited according to the provisions of the DOL.

**10. SUBSEQUENT EVENTS**

The Plan was restated effective February 1, 2025. The Plan was amended to calculate the safe-harbor matching contribution based on plan year earnings and to add a true-up provision.

The Company acquired MTI Events in July 2025, and the Plan was restated effective July 11, 2025, to add MTI Events as member of the Plan's controlled group. The acquisition brought in 8 new employees.
