### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of OrthoUnited, Inc. Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of OrthoUnited, Inc. Profit Sharing Plan and Trust (the Plan), formerly the Spectrum Orthopaedics, Inc. Profit Sharing Plan and Trust, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

As of January 1, 2023, Spectrum Orthopaedics, Inc. (previous Plan Sponsor) merged with Orthopaedic Multispecialty Network, Inc. (OMNI) which resulted in the formation of OrthoUnited, Inc. (Plan Sponsor). Effective February 6, 2023, the Plan was amended changing the name of the Plan from Spectrum Orthopaedics, Inc. Profit Sharing Plan and Trust to OrthoUnited Inc., Profit Sharing Plan and Trust. The Plan is a defined contribution plan established for the benefit of the employees of OrthoUnited Inc. (OrthoUnited and Plan Sponsor) and a participating employer, Ohio Specialty Surgical Suites, LLC (OSSS). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Effective February 29, 2024, the Plan was amended making OSSS no longer a participating employer in the Plan.

**Eligibility**

Employees become eligible to participate in the Plan on the first day of the month coinciding with or following their hire date, provided they are at least 21 years of age. Eligibility for nonelective and matching employer contributions requires completion of one year of service.

Effective January 1, 2023, the Plan was amended to include employees of Orthopaedics Multispecialty Network, Inc. (OMNI) following its merger with Spectrum Orthopaedics, Inc. Prior service with OMNI is recognized for eligibility purposes.

Effective January 1, 2024, the Plan was further amended to revise eligibility criteria and participant entry dates. Automatic enrollment for OrthoUnited employees was removed. Under the updated provisions, employees are eligible to enter the Plan on the first day of the quarter coinciding with or following the date they reach age 21 and complete one year of eligibility service.

**Contributions**

Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pretax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. In addition, the participants who enter the Plan under the automatic enrollment have an automatic escalation function which increase the participant's deferral rate 1% each year, until the participant reaches a 6% deferral rate. The participant can choose to opt out of the automatic increase and change their deferral rate at any time.

**Contributions (Continued)**

Employees of OSSS are excluded from the automatic enrollment function. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan also provides for a Qualified Automatic Contribution Arrangement (QACA) for all employees, unless elected otherwise, and provides for age-based funds as the investment default option. As part of the QACA, the Plan Sponsor must make a QACA Nonelective Employer Contribution to each eligible active participant in an equal amount ranging from 3% to 25% of the active participant's compensation. For the years ended December 31, 2024 and 2023, the Plan Sponsor elected to contribute 3% for the QACA Nonelective Employer Contribution, which totaled \$694,329 and \$760,579, respectively.

In addition, the Plan Sponsor has the option to make a discretionary profit-sharing contribution to employees of OrthoUnited and OSSS at varying percentages of the employee's eligible wages. The percentages vary based upon different groupings of employees by the Plan Sponsor. For the years ended December 31, 2024 and 2023, total discretionary profit sharing contributions totaled \$1,297,460 and \$1,400,244, respectively.

The Plan provides that OrthoUnited and OSSS may make discretionary matching contributions to the employees. For the year ended December 31, 2024, OSSS and OrthoUnited elected to match 50% of the participant's voluntary contributions up to the first 6% of compensation. Effective September 30, 2023, OrthoUnited elected to suspend the discretionary match for the remainder of the year. For the years ended December 31, 2024 and 2023, these matching contributions totaled \$8,779 and \$386,164, respectively.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit-sharing contribution, the Company's QACA Nonelective Contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching, profit sharing, and QACA nonelective employer contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after two years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment to be paid in a lump sum to the participant without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Effective April 1, 2024, the \$5,000 threshold increased to \$7,000. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

**Forfeited Accounts**

Forfeited nonvested accounts can be used to pay administrative expenses and to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$29,401 and \$12,732, respectively. There were no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023. There were forfeitures of \$2,235 and \$16,430 used to reduce Company contributions for the years ended December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value investments.

**Transfer of Applicable Net Assets to Other Plan**

\$760,330 of net assets were transferred out of the Plan into a related Employer's plan, Ohio Specialty Surgical Suites, LLC 401(k) Profit Sharing Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC (ETC), the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of investments and investment income as of and for the year ended December 31, 2024, as presented in the accompanying financial statements and ERISA-required supplemental schedule.

Fidelity Management Trust Company (Fidelity), the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of investments as of December 31, 2023, and investment income for the period from January 1, 2024 to April 16, 2024 and for the year ended December 31, 2023, in the accompanying financial statements.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Collective Fund:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Self-Directed Brokerage Accounts:* Self-directed brokerage accounts consist of mutual funds and common stocks that are valued at the closing price reported on the active market on which the individual funds are traded.

*Money Market Funds:* Valued at cash value; these are bank deposits.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Stocks:* Common stocks traded in active markets on national and international securities exchanges are valued at closing prices on the last business day of each period presented.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with EAICA (the Insurance Company). The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 8 PLAN TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the qualified institutions of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
