## INDEPENDENT AUDITOR'S REPORT

To the Trustees of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Genesis Medical Associates, Inc. 401(k) Profit-Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Note 1: Description of Plan and Summary of Significant Accounting Policies**

The following description of the Genesis Medical Associates, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only a general description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have one year of service and are age twenty-one or older. The Plan follows the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Participants may contribute a certain percentage of pretax annual compensation, as defined in the Plan. Participants who are at least 50 years old before the end of the plan year may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options maintained by the Plan.

The Company has the option to make discretionary profit sharing contributions. The Company invests its contributions into the various investment options selected by the participants.

Certain regulatory requirements limit the amount of both contributions.

#### *Participants' Accounts*

The Plan credits each participant's account with his or her contribution and allocations of the Company's contribution. The Company has the option to pay administrative charges of the Plan. The Plan will pay any reasonable expenses it incurs in connection with the Plan's administration that the Company does not pay. The Plan charges some fees directly to participants' accounts or the Plan's forfeiture account. Since participants direct their investments, the Plan segregates the participants' accounts for purposes of determining the earnings or loss on those investments. Individual accounts do not share in the investment performance of other participants who have directed their own investments.

#### *Vesting*

The Plan provides that participants' contributions, including actual earnings thereon, are immediately vested. With respect to the Company's contributions and the earnings thereon, a participant with less than 2 years of service, as defined in the Plan, is not vested; a

participant with 2 years of service is 20% vested, 3 years is 40% vested, 4 years is 60% vested, 5 years is 80% vested, and 6 or more years is 100% vested.

#### *Participants' Loans*

Participants may borrow from their accounts. A balance of the participant's account equivalent to the outstanding loan balance secures the loan. The Plan records the related interest income on the accrual basis. The loans bear interest at the prime rate in effect at the time the loan is granted plus 2%. The term of the loans may range from 12 to 120 months. The Company deducts loan payments, including interest, from the participant's salary or wages. The Plan values participants' loans at net realizable value, which approximates fair value.

As of December 31, 2024 and 2023, the Plan did not record any allowance for credit losses. If a participant does not make loan payments and the plan administrator considers the loan to be in default, the plan administrator will reduce the loan balance and record the delinquent participant loan as a benefit payment based on the terms of the Plan.

#### *Forfeitures*

The Plan may use forfeitures to pay administrative expenses of the Plan. Any forfeitures not used for that purpose may be used to reduce any discretionary profit sharing contribution for the current year or subsequent plan years.

#### *Basis of Accounting*

The Plan prepares its financial statements on the accrual basis of accounting.

#### *Benefits*

A participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account when the participant terminates service with the Company because of death, disability, or retirement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Generally, the Plan records benefits when paid.

#### *Estimates*

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect

certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan values its investments at fair value. The Plan values shares of mutual funds at quoted net asset values of units held by the Plan at year end, and the Plan values the units of a collective trust fund at the net asset value per share practical expedient (NAVPE). The Plan records purchases and sales of securities on a trade-date basis and dividends on the ex-dividend date. Net appreciation or depreciation includes gains and losses on investments bought and sold as well as held during the year.

### *Subsequent Events*

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements became available to be issued and determined that no adjustments or additional disclosures are necessary.

### **Note 2: Investments**

The Plan's methods to measure fair value of its investments may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs such as quoted prices for similar securities in active markets, quoted prices for identical or similar securities in markets, which are not active, or other inputs, which are corroborated by observable market data by correlation. Level 3 inputs consist of unobservable inputs. The Plan's management used Level 1 inputs to measure fair values of its mutual funds. For the plan's investments of its collective trust funds, management NAVPE for the collective trust fund in 2024 and 2023.

The components of the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023, are presented on the following page.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the period) appreciated in value by \$4,583,923. The mutual funds appreciated in value by approximately \$4,100,076 and the collective trust fund's value appreciated by approximately \$50,474.

On December 31, 2024 and 2023, investments included forfeited nonvested accounts totaling \$22,796 and \$15,987, respectively. The Plan will use these accounts to reduce future employer contributions or pay administrative expenses of the Plan. In 2024, the Company used \$6,032 to fund partially its employer contribution for 2023.

#### **Note 3: Participants' Loans**

As of December 31, 2024 and 2023, the outstanding balance of participants' loans amounted to approximately \$69,775 and \$94,394 respectively. The loans bear interest at various rates ranging between 5.25% and 10.5% and will mature by December 2028.

#### **Note 4: Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 5: Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated January 24, 2002, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained under examination by the IRS. The IRS may examine the Plan's annual informational returns for each of the years in the four-year period ended December 31, 2024. Should the Plan be subject to any penalties or interest assessed by the IRS, the Plan may account for such expenses as an administrative expense or may seek reimbursement from the Company.

**Note 6: Risks and Uncertainties**

The Plan invests in various investment securities and money market funds. Various risks such as interest rate, market, and credit may affect the value of the investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

**Note 7: Related Party Transactions**

American Funds manages certain investments of the Plan. The Plan's custodian is an affiliate of American Funds; therefore, transactions in such investments qualify as party-in-interest transactions.

The Company may pay certain administrative expenses on behalf of the Plan

**Note 8: Unaudited Information Certified by Plan Custodian**

The plan administrator prepared the 2024 and 2023 statements of net assets available for benefits, the investment activities included on the 2024 statement of changes in net assets available for benefits, and the accompanying notes to financial statements in part or entirely from information certified by the custodian in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The custodian certified total investments and participants' loans receivable of \$47,547,597 and \$41,404,497 on December 31, 2024 and 2023, respectively, and related net investment income of \$6,111,626 for the year ended December 31, 2024.
