Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Alkermes, Inc. 401(k) Retirement Savings Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for more complete information.

General - The Plan is a defined contribution plan covering all employees of Alkermes, Inc. (the “Company”) who are age 21 or older. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”). The Administrative Committee is responsible for oversight of the Plan. The Administrative Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions - Eligible employees may contribute a portion of their compensation in amounts subject to certain Internal Revenue Code (“Code”) limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to contribute to the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes a safe-harbor matching contribution to the Plan in an amount equal to a percentage of each participant’s contributions, as determined each year at the Company’s sole discretion. In 2024 and 2023, the Company matched 100% of participant deferrals up to 5% of eligible compensation. The Company may also make a discretionary profit-sharing contribution; no profit-sharing contributions were made in 2024 or 2023.

Participant accounts - Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions and earnings, and is charged with an allocation of administrative fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants are entitled to the benefit that can be provided from the participant’s vested account.

Investments - Participants direct the investment of their contributions and Company matching contributions into various mutual fund and collective trust fund investment options offered by the Plan.

Notes receivable from participants - Participants may borrow from their account balances up to the lesser of 50% of their vested account balances or \$50,000. The terms of the loans range from one to five years and bear interest at the Prime Rate plus 1%. Loans for the purchase of a primary residence are permitted with a repayment period extending up to the life of the underlying mortgage or until the participant reaches the age of sixty-five, whichever period is shorter. The loans are secured by the balance in the participant’s account and bear interest at rates that range from 4.25% to 9.5%, which is based on the prime rate plus 1% on the date of origination. Principal and interest are paid ratably through payroll deductions.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Payment of benefits - Participants are entitled to a lump-sum distribution equal to their total vested balance upon termination of employment, retirement, disability, or death. Withdrawals from the participant's vested portion of the Plan are permitted prior to retirement or termination if the participant is able to demonstrate financial hardship as defined by the Code. Additionally, participants who are active status may take an in-service distribution at age 59 1/2 in an amount up to 100% of the vested account balance.

Vesting - Participants are immediately fully vested in their contributions, the Company's contributions, and in the actual earnings thereon.

Forfeitures - Forfeitures, which result from the Company match portion of excess deferral contributions, are first used to pay administrative expenses, then to reduce Company contributions. For the years ended December 31, 2024 and 2023, no forfeitures were used to pay administrative expenses or reduce Company contributions. The Plan had \$105,242 and \$65,798 in unallocated forfeitures at December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Loans due from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits - Benefits are recorded when paid.

3. TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are shares of mutual funds managed by Vanguard Fiduciary Trust Company, the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions, however, are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for investment management services are included in administrative fees.

4. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

5. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include: quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - The Collective Trust Funds are valued at net asset value ("NAV") of units held in the collective trust, which is used as a practical expedient to estimate fair value as of December 31, 2024. The fair values of these investments are determined by reference to the respective funds' underlying assets.

7. TAX STATUS OF THE PLAN

On June 30, 2020, the Internal Revenue Service stated that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC) under Section 401(a). The Plan itself has not received a determination letter from the Internal Revenue Service. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS
