**Note 1 - Plan Description**

The following description of Built In, Inc. Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Built In, Inc. (the "Company") who have completed three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to make contributions to the Plan on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Effective July 1, 2024, the Company amended the Plan to include autodeferral election and auto-escalation features. If a new participant makes no deferral election prior to the first eligible payroll period, the participant will be assigned a pretax contribution of 6 percent and an autoescalation of 1 percent to increase their pretax deferral annually until reaching 10 percent. If a new participant in the Plan makes an affirmative election prior to the first eligible pay period, no automatic deferral will be applied to the account. Existing participants may opt in to the auto-escalation plan feature at a rate to be increased annually. This feature can be opted out of by a participant at any time. All auto-escalation elections will occur annually on July 1.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions and the related lost earnings to the Plan in 2025.

The Company may make an annual discretionary nonelective contributions. Participants must be employed on the last day of the plan year to be eligible to receive an allocation of the Company's discretionary nonelective contribution. There were no discretionary nonelective contributions made to the Plan during 2024.

The Company may also make a discretionary matching contribution to the Plan, as determined by the Company. The Company provided a discretionary matching contribution up to 50 percent of the first 2 percent contributed by employees for a maximum employer match of 1 percent.

**Participant Notes Receivable**

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate. There were no participant notes receivable outstanding as of December 31, 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**December 31, 2024 and 2023****Note 1 - Plan Description (Continued)*****Vesting***

Participants are immediately 100 percent vested in employee salary, rollover, and safe harbor matching contributions and any income or loss thereon. Effective January 1, 2023, the Company amended the plan agreement to cease its employer safe harbor matching contributions. Vesting in the Company's nonelective contribution portions of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in nonelective contributions made by the Company 25 percent after one year of service and an additional 25 percent thereafter until they become fully vested after four years of service. Effective January 1, 2024, the Company amended the plan to change the vesting of discretionary matching contributions to 100 percent immediately vested.

***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a single lump-sum payment or a partial withdrawal. Benefits may also be paid directly to an eligible retirement plan as an eligible rollover distribution. In-service distributions are allowed once a participant attains the age of 59½ and for a qualified birth or adoption.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by John Hancock Trust Company LLC or its affiliates. John Hancock Trust Company LLC is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies*****Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

John Hancock Trust Company LLC (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

**Note 4 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Common/Collective Trust Fund**

The common/collective trust fund is valued at net asset value (NAV) per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.
