## **INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee and participants of the  
IHG 401(k) Savings and Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the IHG 401(k) Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of the Plan

The following description of the IHG 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan that was formed on October 1, 2020 and covers eligible employees of InterContinental Hotels Group, Inc. and its affiliates (collectively, the Company). Eligible employees are covered under two separate groups as defined by the Plan. The first group are participants who are employed by Kimpton Hotel & Restaurant Group, LLC and affiliated companies that are its direct and indirect subsidiaries, (Kimpton Participants). The second group consists of participants employed by InterContinental Hotels Group (IHG) and represents all other eligible employees of the Plan, that are not Kimpton Participants (IHG Participants).

Employees of the Company generally become eligible to join the Plan on the first day of the month following the completion of 6 months of employment. The Plan also provides that certain categories of employees (interns, on-call employees, and special project employees) can enroll in the Plan on January 1 or July 1 after attaining the age of 21 and completing twelve consecutive months of service during which an employee completes no less than 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may make pre-tax and/or Roth contributions of up to 75% of their eligible compensation to the Plan, subject to a maximum of \$23,000 in 2024, plus an additional \$7,500 catch-up deferral for those participants over age 50 prior to the close of the Plan year. Participants can also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

For IHG eligible corporate employees and hotel executive committee members, the Company makes a safe harbor matching contribution to the Plan equal to 100% of a participant's contribution limited to 6% of the participant's eligible compensation. For IHG eligible hotel employees and participants, the Company makes a safe harbor matching contribution to the Plan equal to 100% of the participant's contribution limited to 4% of the participant's eligible compensation. Safe harbor matching contributions totaled \$18,993,509 for the year ended December 31, 2024.

For IHG Participants, the Plan provides for an additional employer contribution for hourly-paid participants who perform services under a contract covered by the Service Contract Act (SCA) and who are not a highly compensated employee. The SCA Fringe Contribution (SCA

Contributions) is equal to the difference between the total dollar cost of fringe benefits required to be provided to such participant minus the total dollar cost of all fringe benefit amounts provided to such participant. SCA contributions totaled \$6,747,517 for the year ended December 31, 2024.

Kimpton Participants receive safe harbor matching contributions that are calculated in the same manner as described above for IHG Participants. Safe harbor matching contributions totaled \$2,914,480 for the year ended December 31, 2024.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account. Participants are also charged with certain administrative expenses. Upon enrollment in the Plan, a participant can direct any contributions to any of the investment options offered by the Plan. Participants can change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

All participants vest immediately in their contributions, safe harbor matching contributions, and SCA contributions, plus actual earnings thereon. For Kimpton Participants, discretionary employer matching contributions made prior to January 1, 2023, plus actual earnings thereon, are fully vested after one year of service.

A participant's entire account balance immediately vests in cases of death, total and permanent disability, retirement at or after the age of 65, termination or partial termination of the Plan, or upon certain specified changes in the operations or structure of the Company.

### **Notes Receivable from Participants**

Participants can borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at any time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest as defined in the Plan. For the year ending December 31, 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the loan, not to exceed 5 years or 15 years, if used for the purchase of a residence. Principal and interest are paid through payroll deductions. Certain notes originated under plans merged into the Plan continued to be repaid under the original terms.

### **Payment of Benefits**

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive a payment of the vested interest in their account in the form of a lump-sum or installment distribution. In-service withdrawals are also permitted for participants who have attained the age 59½. If a participant terminates employment and has an account balance \$7,000 or less for which no distribution request has been made, the balance will be rolled into an individual retirement account in the participant's name. Participants are eligible to receive hardship withdrawals when certain conditions are met.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited accounts totaled \$1,201,614 and \$1,283,738, respectively. These accounts can be used to pay Plan administrative expenses or reduce future Company contributions. For the year ending December 31, 2024, \$0 of forfeitures were used to reduce Plan administrative expenses and \$162,498 of forfeitures were used to reduce Company contributions. Employees who returned within five years and are eligible for buy-back will be credited at the date of rehire with their nonvested account balance previously forfeited.

### **Administrative Expenses**

Participants are charged an annual Plan administration fee of \$24. Certain transaction fees for withdrawals and notes are charged directly to the participant. The Plan document permits certain administrative expenses to be paid by the Plan. These expenses are paid to service providers of the Plan and, therefore, qualify as party-in-interest transactions. All other expenses are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

The Plan has an ERISA account where the qualified institution deposits revenue sharing payments that are used to pay Plan expenses or allocated to participant accounts. In 2024, the qualified institution deposited \$41,537 into the account and \$41,607 was allocated to participants. The account had investment earnings of \$306, and \$0 were used to pay Plan fees. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. Payments from this account are included in administrative expenses when paid. At December 31, 2024 and 2023, the balance in this account was \$5,103 and \$4,867, respectively.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe harbor matching and discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Company SCA contributions are paid quarterly and considered payable to the Plan at the end of each quarter. Any unfunded participant or Company contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's (FASB) Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on investments. Interest income is recorded when received.

### Payment of Benefits

Benefits are recorded when paid.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default the participant note balance is reduced, and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

### Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), the Plan's qualified institution.

### 4. Investments

Certain Plan investments are managed by T. Rowe Price. T. Rowe Price is the qualified institution of the Plan and, therefore, transactions in these securities qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include a healthcare crisis, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cyber security attack, or other similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

### Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the money market fund and mutual funds are based on quoted market prices for the identical asset in an active market and are considered Level 1 assets.

Investments in common/collective trusts are valued daily using their net asset value (NAV). The NAVs are based on the fair value of the mutual funds, stocks, debt instruments, and other securities in the accounts. Participants can trade the common/collective trusts daily at the published NAV (Level 1).

The Plan invests in a stable value fund held in a common/collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the NAV, which is based on the contract value of the underlying investments (Level 1). The stable value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

### 5. Income Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated December 21, 2021, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns since inception are subject to examination by taxing authorities and may change upon examination.

The Plan has not completed the discrimination testing for the year ended December 31, 2024. Upon completion of this testing, the Plan may have to take corrective action based on the results of the testing.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.
