## INDEPENDENT AUDITORS' REPORT

To the Trustees of the  
Fire Equipment, Inc. 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting for the Financial Statements**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of the Plan**

The following description of the Fire Equipment, Inc. 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401(k) plan covering all employees of Fire Equipment, Inc. (the Employer) who have attained the age of 21 and have completed 30 days of service. Eligible participants may enter the Plan on the first day of the month coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the Plan Administrator. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Voya Retirement Insurance and Annuity Company (Voya) and The Guardian Insurance & Annuity Company, Inc. (Guardian) are the custodians for the Plan and hold and manage Plan investments at the direction of the Plan Administrator. Two employees of the Employer serve as the trustees of the Plan.

***Contributions***

Participants may elect to contribute on a pre-tax or post-tax basis any percentage of their annual eligible compensation to the Plan, so long as those contributions do not exceed annual limitations set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Employer may elect to make a discretionary matching contribution to the Plan. For the year ended December 31, 2024, the discretionary matching contribution was 50% of 3% of the participants' eligible compensation.

***Participant Accounts***

Each participant's account is credited with the participant's and Employer contributions and their allocations of Plan earnings (losses) and administrative expenses. Allocations are based on participant's compensation or individual participant account balances, as defined in the agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and rollover contributions, and actual earnings thereon. Participants become fully vested in the Employer discretionary matching contributions and the annual allocation of Plan earnings on those contributions after six years of service. Participants are partially vested in the Employer discretionary matching contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years, and 100% after 6 years.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 and up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the vested balance in the participant's account and bear interest at the prevailing prime rate plus one percent. Principal and interest are paid in level payments on at least a quarterly basis, and must be completed within five years, with the exception of notes whose proceeds are used for the purchase of a participant's primary residence, which must be repaid over a reasonable period of time, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Participants may only have one note outstanding at any given time.

***Payment of Benefits***

Upon retirement, death, disability or termination of service, a participant or beneficiary may elect to receive a lump-sum amount or installment payments equal to the value of his or her vested interest in their account. Upon reaching age 59½, participants may elect to withdraw all or a portion of their account balance while still employed by the Employer. The Plan also provides for mandatory distributions to participants upon reaching the age of 73. Upon termination of employment for reasons other than death, disability, or retirement, a participant's vested balance that is \$1,000 or less upon termination will be distributed to the participant in a lump-sum distribution. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$7,000, the amount will be rolled over to an individual retirement account designated by the Employer, unless otherwise directed by the participant.

Effective January 1, 2024, the Plan adopted certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE) Act 2.0, which increased the limit for involuntary automatic rollovers for small account balances from \$5,000 to \$7,000.

***Hardship Withdrawals***

Hardship distributions are permitted from participant elective deferral accounts subject to limitations imposed by the IRC and cannot exceed the amount required to meet the immediate financial need created by the hardship.

***Forfeitures***

Participants in the Plan who terminate employment before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeited non-vested accounts may be used pay administrative expenses or to reduce Employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,990 and \$2,872, respectively. During 2024, no forfeitures were used to reduce Plan expenses or Employer contributions.

***Plan Termination***

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the modified cash basis of accounting. The financial results reported in these financial statements differ from the results that would have been presented using accounting principles generally accepted in the United States of America primarily because participant and employer receivables have not been included in these financial statements.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value, except for amounts allocated to the insurance company general account investment which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Contract value represents investments at cost plus accrued interest income less amounts withdrawn to pay benefits. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodians.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

***Contributions***

Participant and Employer matching contributions are recorded weekly when the Employer remits the contributions for investment into the Plan.

***Payment of Benefits***

Benefits are recorded when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain expenses incurred in the administration of the Plan are paid directly by the Employer, unless the Employer directs that such expenses be paid by the Plan. Expenses that are paid directly by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses.

Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements under the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets available for plan benefits. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits – modified cash basis.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by two custodians. The Plan's exposure to credit risk is associated with the outside entities' non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

The Plan held four and two investments that accounted for approximately 64% and 36% of total Plan investments as of December 31, 2024, and 2023, respectively.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Pooled Separate Accounts:* Valued using net asset value (NAV) provided by the administrator of the fund based on the valuation of the underlying investments. The NAV is used as a practical expedient to estimate fair value. The pooled separate accounts have a daily redemption frequency and no redemption notice period.

*Variable Annuity Separate Accounts:* Valued using the NAV provided by the administrator of the contract based on the valuation of the underlying investments. Participant transactions (purchases and sales) may occur daily.

The Plan had no investments within the fair value hierarchy at December 31, 2024 and 2023. In accordance with Subtopic 820-10, the pooled separate accounts and variable annuity separate accounts that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy.

**4. Investment Contract with Insurance Company**

The Plan has entered into an investment contract (Fixed Account) with Voya. Amounts held in connection with this contract may be held in Voya's general account or separate accounts which invest in mutual funds advised by Voya, mutual funds sub-advised by third parties, mutual funds managed by external mutual fund companies or invested directly in securities.

Contributions allocated to the Fixed Account are invested in the general account of, and are guaranteed by, Voya. All other contributions allocated to any investment fund become part of separate accounts that are maintained separately from the general assets of Voya. The value of these contracts included in the financial statements, as reported to the Plan by Voya, is equal to the sum of the contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

The contract value of funds allocated to the traditional general account investment with Voya at December 31, 2024 and 2023 was \$82,398 and \$49,542, respectively. The crediting interest rate was 1.50% and 1.37% for the years ended December 31, 2024 and 2023, respectively. Withdrawals from this investment other than the payment of benefits may be subject to a market value adjustment and a surrender charge and the ability to move funds out of this investment may be restricted by Voya.

The guarantee of values provided for investments made with Voya under the Plan's investment contract is based on the financial strength and claims-paying ability of Voya.

**5. Income Tax Status**

The Plan is an adoption of a non-standardized pre-approved profit-sharing plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

**6. Summary of Financial Data Certified by the Custodian**

The following is a summary of financial information and data certified by Voya and Guardian, the custodians:

Statements of Net Assets Available for Plan Benefits – modified cash basis at December 31, 2024 and 2023, except for participant notes receivable;

Investment income on the Statement of Changes in Net Assets Available for Plan Benefits – modified cash basis for the year ended December 31, 2024; and

Investment information provided on the supplemental Schedule of Assets (Held at End of Year) at December 31, 2024, except for participant notes receivable.

Plan investments are held and managed by Voya and Guardian, the custodians of the Plan. Therefore, these transactions qualify as party-in-interest transactions. In addition, participant notes receivable qualify as party-in-interest transactions. Two employees of the Employer serve as the trustees of the Plan.

**9. Non-Exempt Transactions**

During 2024, 2023 and 2022, the Employer failed to remit participant contributions of \$25,708, \$3,645 and \$21,580, respectively, to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102. Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Employer.

The Employer remitted untimely participant contributions of \$21,580 for the year ended December 31, 2022, during the 2022 Plan year. The Employer is expecting to remit untimely participant contributions of \$3,645 for the year ended December 31, 2023, during the 2025 Plan year. The Employer remitted untimely participant contributions of \$25,347 for the year ended December 31, 2024, during the 2024 Plan year, with the remaining \$361 expected to be remitted during the 2025 Plan year. The Employer is currently working with its third-party administrator to calculate and remit any lost earnings associated with these late remittances.

**10. Subsequent Events**

Effective January 1, 2025, the Plan was amended to change the eligibility requirements to employees who have attained the age of 21 and have completed three months of service and to include an automatic contribution provision under which eligible employees are automatically enrolled to contribute 3% of compensation to the Plan unless they affirmatively elect otherwise.

Additionally, effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as "super catch-up" contributions. Under this provision, the maximum catch-up deferral amount for the participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Management has evaluated subsequent events through September 30, 2025, which is the date these financial statements were available to be issued.


