NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the Health & Welfare Benefit Plan for Part-Time Employees in the Field (Mass & Gold Crown) and Retail (CSG & Halls) (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions, which is available from the plan administrator.

General - The Plan was established by Hallmark Marketing Company LLC (the "Company") for the purpose of providing specific employee welfare benefits for eligible part-time employees and their dependents effective May 1, 2018. The Plan provides benefits through the following component benefit programs:

- Self-Insured Minimum Essential Coverage Health Benefit Program (the "MEC Program")
- Fully-insured Fixed Indemnity Plan
- Business Travel
- Group Term Life Insurance

The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is a member of the Hallmark Employee Benefits Trust (the "Trust") and substantially all contributions are made by Hallmark Cards, Incorporated except for contributions required from employees to obtain certain benefits under the Plan. The Trust is intended to qualify as a voluntary employee beneficiary association ("VEBA") under Internal Revenue Code ("IRC") 501(c)(9).

Eligibility - Part-time active employees in Hallmark's Mass Service organization scheduled to work under 40 hours, and Corporate Stores and Hall's retail store employees scheduled to work under 30 hours are eligible to enroll in the MEC Program. Eligible employees and dependents can enroll in the MEC Program during their first thirty days of employment with coverage beginning the first of the month following enrollment. All part-time active employees are eligible for business travel accident coverage and are enrolled on the first day of their employment. All part-time active employees who work an average of 20 hours per week on a rolling 12-month basis are eligible to receive group term life insurance and are automatically enrolled the first of the month once they meet the hour requirement.

Plan change - Effective January 1, 2024, the Plan changed the third-party administrator to Fringe Benefit Group, Inc. Through Fringe Benefit Group, Inc. the American Worker Plan offers employees the option of Minimum Essential Medical plan or Fixed Indemnity plan. Mercer Indigo is used for employees to enroll in additional voluntary benefits.

Benefits - The Plan offers benefits including medical, business travel accident benefits, and group term life insurance.

Continuation coverage - Under the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA") any person who is an employee, covered spouse of an employee or covered dependent child of an employee may elect continued coverage under the Plan for a limited period of time. In addition to the requirements of COBRA, the Plan also provides continued coverage during military service to the extent provided by the Uniform Services Employment and Reemployment Rights act of 1994 as amended.

(1) Description of plan (continued)

Insured benefits - The Plan fully insures life insurance and business travel accident benefits. The Plan offers a separate fully insured hospital indemnity insurance policy. The Company purchases annual insurance contracts for these insured benefits. Premiums for fully insured benefits are paid from either the VEBA or general assets of the Company.

Experience rated contracts - The life insurance contract is subject to experience rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) were determined by the insurance company in the following year and may result in a premium surplus or deficit. As of December 31, 2024 and 2023, no additional premiums were due as a result of a premium deficit that would be included in benefit obligations.

Self-insured benefits - Certain medical benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor. The claims processor pays claims directly to or for participants and then is reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claim processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop-loss coverage - Effective January 1, 2024, the Plan entered into a new stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (aggregate exposure for all claims). The stop-loss coverage begins at \$4,500 in the aggregate for an annual period. For the year ended December 31, 2024, stop-loss refunds totaling \$2,725 have been netted with claims paid in the accompanying statement of changes in net assets. Prior to January 1, 2024, the Plan had a similar policy in which coverage began at \$1,000,000. There were no aggregate claims above this threshold for the year ended December 31, 2023.

Funding - The claims processor collects premiums directly from employees. The Company contributes to the Trust the amounts necessary to pay plan benefits timely and expenses as they become due. The Welfare Committee establishes the amount of employee contributions required to be made by the eligible employee.

Plan termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants or to discontinue its contributions at any time and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, trust assets will be applied to pay benefits until such assets are depleted. The Company is obligated to contribute any amounts necessary to pay accrued benefits under the Plan to the extent such benefits were payable prior to the date of termination.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Accordingly, all significant contributions have been recognized in the period to which they apply and claims and expenses have been recognized as incurred.

(2) Summary of significant accounting policies (continued)

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits - Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims administrator. Amounts due to claims administrators that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of benefit obligations.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Claims incurred but not reported - Plan obligations for claims incurred but not reported ("IBNR") at December 31, 2024 and 2023 are estimated by the Company using historical claims experience.

Administrative expenses - Administrative expenses consist primarily of administrative fees paid to third-party claims administrators, as well as investment management fees and professional fees. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

(3) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

(3) Fair value measurements (continued)

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Trust were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Interest in master trust

The Plan's investments are maintained in a master trust account which was established to invest the assets of this Plan and other welfare benefit plans establishing the Hallmark Employee Benefits Trust. The Plan along with the Health & Welfare Benefit Plan of Hallmark Cards, Incorporated participates in the master trust. Each welfare benefit plan has a divided interest in the master trust account. At December 31, 2024 and 2023, the Plan's interest in the net assets of the master trust was approximately 0.01%.

(5) Related party and party-in-interest transactions

Certain investments held in the master trust are shares of money market funds managed by State Street Bank. State Street Bank is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

(6) Income tax status

The VEBA trust, funding certain benefits of the Plan, received an exemption letter from the Internal Revenue Service ("IRS") dated June 7, 1988, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time the Trust may be subject to income taxes. No income taxes have been recorded on the Plan's financial statements for unrelated business taxable income.

In addition, the Plan and the Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. The Hallmark Benefit Plans Advisory Committee and the Company's legal department believe that the Trust and the Plan are being operated in compliance with the applicable provisions of the IRC and, therefore, believe that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and uncertainties

The Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and these changes could materially affect the amounts reported in the statements of net assets available for benefits.

(9) Subsequent events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued. No significant matters were identified during this evaluation.
