INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Trustees
SST Employee Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SST Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits [and of accumulated plan benefits] as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits [and of changes in accumulated plan benefits] for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SST Employee Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan

The following description of the SST Employee Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan with a 401(k)-arrangement covering substantially all employees of Smart System Technologies, Inc., (the "Company or the "Employer" or the "Plan Sponsor") and employees of Smart System Technologies Arizona Inc. (an affiliate and adopting employer under this single plan) who elect for plan entry regardless of age and without minimum years of service requirements. Eligible participants may enter the plan upon their first payday of the first pay period following the hire date or thereafter on the 1st day of each calendar quarter. Effective December 1, 2022, eligible participants entry date will be their hire date, changes to participants' elective deferral contributions can be made at any time, and such changes will be implemented as soon as administratively feasible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions - Participants may elect to contribute from 0% to 100% of their eligible compensation for the year subject to overall limitations permitted by code section 402(g). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Starting January 1, 2021, the Company contributed a Safe Harbor Matching Contribution equal to 100% of each participant's elective deferral contribution up to 4% of the participant's eligible compensation. Before 2021, the Company made a matching contribution equal to 100% of each participant's elective deferral contribution up to 3% of the participant's eligible compensation. The total employer matching contribution was \$380,165 for the year ended December 31, 2024.
- C. Participants Accounts - Each participant's account is credited with the participant's contributions, an allocation of the Company's discretionary matching and discretionary non-matching contributions, and an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.
- D. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer discretionary matching and non-matching contributions made before January 1, 2021, is based on years of continuous service. Participants vest in these accounts at a rate of 20% per year of service after the first year of vesting service and are fully vested after five years of service. Participants are fully vested in all employer contributions received on or after January 1, 2021.
- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions. As of December 31, 2024, participant loans have maturities through 2029 and interest rates ranging from 3.25% to 8.5%
- F. Forfeited Accounts – Forfeitures of terminated participants' non-vested accounts arising from Company contributions and related Plan earnings may be first used to pay plan expenses. Any forfeiture left after paying plan expenses is used to offset the employer's matching contributions. Forfeitures of \$-0- and \$-0- were available for such purpose as of the years ended December 31, 2024 and 2023, respectively. Also, for the year ended December 31, 2024, employer contributions were reduced by \$2,357 from forfeited nonvested accounts.

Note 1 - Description of the Plan (continued)

- G. Participant Investment options – Upon enrollment in the Plan, participants must direct their salary deferral contributions and their allocated share of employer contributions into various investment options as made available and determined by the Plan administrator. The investment options are more fully described in the Plan’s literature.
- H. Payment of Benefits - Upon termination of service, participants with a vested account balance of less than \$1,000 will receive their vested benefits through a single lump-sum payment or may elect a rollover into another qualified plan. A participant with a vested account balance of at least \$1,000 but less than \$5,000 will receive their vested balances in a direct rollover to an individual retirement account unless the participant elects to receive a single lump-sum payment. Participants with vested account balances greater than \$5,000 excluding rollovers may leave their account in the Plan and continue to participate in the Plan’s investments or may elect to receive their vested balances in a direct rollover to an individual retirement account unless the participant elects to receive a single lump-sum payment, periodic installment payments or a rollover into another qualified plan or receive periodic payments as permitted by the Plan. Upon termination of service due to disability, a participant may receive benefits through a single lump-sum payment or periodic installments. If a participant’s service is terminated due to death, the participant’s beneficiary may receive the value of the participant’s account through a single lump-sum payment or periodic installments.

Note 2 - Summary of Significant Accounting Policies

- A. Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.
- B. Estimates - The preparation of the Plan financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting periods. Accordingly, actual results could differ from those estimates.
- C. Investment Valuation and Income Recognition - The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s investments in collective trusts and pooled separate accounts are valued daily based on the respective fund’s net asset value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.
- D. Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.
- E. Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024, the Plan did not have any excess contributions.
- F. Payment of Benefits - Benefits are recorded when paid.

- G. Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.
- H. Subsequent Events – The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 4 – Information Certified by Principal Life Insurance Company

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent accountants not to perform any auditing procedures with respect to the following information certified by Principal Life and Principal Global (jointly, Principal Group), custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedule.

Note 5 - Tax Status

The Company has adopted a pre-approved plan sponsored by Principal Financial Life Insurance Company. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of the accounts underlying investments. Such accounts contain synthetic investment contracts comprised of both underlying investment and contractual components which have observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. The Plan also holds an account that invests mainly in commercial real estate and includes mortgage loans which are backed by the associated properties. These underlying real estate investments have observable level 2 pricing inputs and are valued utilizing evaluated pricing models.

Collective Investment Trust: Valued at the net asset value (NAV) of the accounts underlying investments. Such accounts contain synthetic investment contracts comprised of both underlying investment and contractual components which have observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with the other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
