In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about B&K Transportation, Inc. Employee Retirement and Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Notes to the Financial Statements

Note 1: Description of Plan

The following description of the B&K Transportation, Inc. Employee Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the B & K Transportation, Inc. (the Company or the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's trustees are responsible for oversight of the Plan.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Eligibility

Employees are eligible to participate in the Plan after completing two months of service or 60 days and having attained the age of 18. Participants are eligible for the discretionary matching contribution if they meet the eligibility requirements to participate and are employed on the last day of the Plan year. All employees meeting the eligibility requirements will be automatically enrolled in the Plan at 5% of eligible compensation and each January 1st, the automatic participant deferral increases 1% each year up to a maximum of 10%, unless the participant elects to opt out.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan, not to exceed the maximum allowable under the Internal Revenue Service (IRS). Participant contributions can be made either before taxation, or starting May 1, 2023, after taxation of a participant's eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may, at its discretion, elect to make a qualified matching contribution to the Plan. For the years ended December 31, 2024 and 2023, the Company matching contribution was 50% of the participant's contributions, up to 5% of eligible compensation. The Company may, at its discretion, elect to make a profit sharing contribution to the Plan. There were no Company profit sharing contributions for the years ended December 31, 2024 and 2023.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and an allocation of the Plan's investment earnings (losses) thereon and Plan expenses. Allocations are based on participant earnings (losses) or account balances, as defined in the Plan. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings (losses) thereon.

Vesting in the Sponsor's contribution portion of their accounts, plus actual earnings (losses) thereon, is based on the number of years of continuous service as shown by the following:

2 years	20 %
3 years	40 %
4 years	60 %
5 years	80 %
6 or more years	100 %

Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during the Plan year. Upon termination of service due to death, disability, or retirement, participants become fully vested in their account balances.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan interest is determined at the time the loan is taken out and is paid back to the participants' accounts. Notes are secured by the balance in the participant's account and bear interest at a rate equal to 1.00% above the prime rate. Loans are immediately due upon the participant's termination. Loans must be fully repaid through payroll deductions within 5 years, unless it is used to acquire a primary residence. A loan term may extend beyond 5 years if the loan is used to acquire a primary residence. A participant can only have two loans at any given time. Principal and interest are paid ratably through payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

Upon termination of employment, death, disability, or retirement, a participant or designated beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance. In-service distributions may be made to participants who have not terminated employment if they have attained age 59 ½. Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes) from their account balance.

Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment prior to becoming fully vested. Forfeitures of the Sponsor's contributions may be used to reduce Sponsor contributions or pay administrative expenses. Forfeitures of \$0 and \$10,636 were used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$0 and \$13,947 were used to reduce sponsor contributions for the years ended December 31, 2024 and 2023, respectively. Unallocated forfeitures as of December 31, 2024 and 2023, were \$17,123 and \$3,903, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Administrative expenses directly attributable to a participant's transaction are deducted from that participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used in 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Note 3: Fair Value Measurements (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan invests in a FBRIC with Lincoln National Life Insurance Company (Lincoln) in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Lincoln including plan termination and other events as specified in the GIC. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Lincoln to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., the Custodian of the Plan.

Note 6: Party-In-Interest Transactions

Certain Plan investments are managed by Lincoln Financial Group Trust Company, Inc., the Plan custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA regulations.

Notes receivable from participants qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 8: Tax Status

The Company adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
