NOTE 1 - DESCRIPTION OF PLAN

The following description of the Bedford Road Pharmacy, Inc.'s ("Company") Employee Stock Ownership Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Bedford Road Pharmacy, Inc. (the Company) established the Plan effective as of April 1, 2004. Currently, employees of C.A.I.S, Inc. (dba Pharmacare Infusion Services) and Bedford Road Pharmacy, Inc. (dba Pharmacare) are eligible for the Plan. The Plan is designed to comply with Section 4975 (e) (7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of ERISA. The Plan is administered by a committee made up of Plan management.

ELIGIBILITY

The Plan is a combination safe harbor plan and an employee stock ownership plan covering all employees of the Company. Employees who are age 21 or older and have completed 1,000 hours by last day of the plan year are eligible for an ESOP contribution and can enter the Plan on December 31st. In conjunction with the operations of a separate retirement plan the Company contributes a safe harbor contribution of 3% of eligible wages to employees who are 21 years old and have completed 1,000 hours. Employees are eligible the first day of the Plan quarter after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

Each year, the Board of Directors may elect a discretionary contribution to be made in trust for eligible employees. Employer contributions will be allocated to eligible employees that are employed on the last day of the Plan year. The employer contribution shall be allocated to each participant's account by multiplying the employer contribution by a fraction in which the numerator is the compensation paid to the eligible participant for the year and the denominator is the aggregate compensation paid to all eligible participants for the Plan year. The discretionary contribution for the year ended December 31, 2024 and 2023 was \$60,901 and \$60,519 respectively.

The Company also contributes a 3% safe harbor contribution to eligible employees based on their eligible wages. This amount is contributed to the participants on a payroll period basis. The safe harbor contribution for the year ended December 31, 2024 and 2023 was \$189,099 and \$189,481 respectively.

PARTICIPANT ACCOUNTS

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an employer contribution, Plan earnings and forfeitures of terminated participants' non-vested accounts and charged with an allocation of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Employees are immediately vested in the Company safe harbor contributions. Vesting in the Company's contribution portion of participant accounts is based on years of continuous service. A qualifying year is counted as 1,000 hours in one calendar year. Employees also become fully vested at their Normal Retirement Date, death or upon termination because of disability. The vesting percentages for other distributions are as follows:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years +	100%

PAYMENT OF BENEFITS

On termination of service, from retirement, disability, or death, a distribution must begin no later than one year after the end of the Plan Year in which the participant has a break in service due to termination. Distribution payments shall be paid out in installment payments not to exceed five years, unless participants elect otherwise in writing. If the value of the participant's Plan account is \$7,000 or less, the participant will automatically receive a lump sum distribution as soon as practicable after the close of the Plan year after termination.

PUT OPTION

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradeable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

DIVERSIFICATION

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may withdraw from the Plan in cash, an amount based on the value up to 25 percent of his or her account. In the sixth year, the participant shall have the right to diversify up to 50 percent of the account balance.

VOTING RIGHTS

All Company stock in the Plan shall normally be voted by the Trustee. Participants are entitled to direct the Trustee as to how Company stock should be voted with respect to important corporate transactions.

ADMINISTRATIVE EXPENSES

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or the Company. The Plan pays the life insurance premiums for the key man life insurance policy of which the Plan is the beneficiary in the amount of \$2.5 million. The Company has historically paid the operating expenses for the Plan.

FORFEITED ACCOUNTS

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants for the years ended December 31, 2024 and 2023 totaled \$1,604 and \$2,394 respectively. There were no forfeited nonvested account balances as of December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The shares of Company common stock are valued at fair value. See Note 3 for discussion of fair value measurements.

Dividend income is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no benefit claims filed by terminated employees that had not been paid.

NOTE 3 - FAIR VALUE DISCLOSURES

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Money market fund: Public investment vehicles valued using \$1 as the NAV.

Bedford Road Pharmacy Inc. common stock: The fair value of the Company's common stock held by the Plan was determined with the assistance of the independent, third party appraiser.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Exchange traded funds (ETF): Valued at the closing price reported in the active market in which the individual securities are traded.

CHANGES IN FAIR VALUE OF LEVEL 3 ASSETS

Following is a description of the valuation methodologies used for assets measured at fair value. The fair value of the Sponsor Company common stock held by the Plan is valued at fair value based upon an independent appraisal. The appraiser took into account cash flow and net income, return on assets, return on equity, market comparables, and fair value of Company assets and liabilities. Plan management has concluded that a market participant would recognize a discount for lack of marketability or illiquidity. There have been no changes in methodologies used at December 31, 2024 and 2023.

The valuation process involves management's selection of an independent appraiser on an annual basis, with the ability to cancel at any time. Plan management accumulates the data for the appraiser from the financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with ESOP trustee, reviews in detail, discusses and approves.

The Plan originally held a life insurance policy to curtail the debt related to the ESOP shares in the event of the death of the guarantor and primary shareholder of the Plan sponsor. The Plan has subsequently maintained the life insurance policy after the loan payoff to purchase additional shares upon the payout of the life insurance policy.

NOTE 5 - ADMINISTRATION OF PLAN ASSETS

The Plan's assets are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 7 - TAX STATUS

The Plan has not yet applied for an IRS determination letter. However, as part of Voluntary Correction Program (VCP) request, the Plan was amended and restated effective January 1, 2024 to adopt the changes required by the 2014 Cumulative List (Notice 2014-77) and the 2009 Cumulative List (Notice 2009-98). The VCP was approved by the IRS on January 15, 2025. The Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. Accordingly, management believes that the plan will retain its tax-qualified status. No provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock and various other investment securities which are exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/ or other such techniques. Due to the level of risk associated with the investment in Company's common stock and other investment securities and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock and investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock. As described in Note 1 and 5, the Plan has a number of service providers. Such parties are parties-in-interest under the Plan.

NOTE 10 - SUBSEQUENT EVENTS

In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued. As previously discussed in Note 7 The VCP was approved by the IRS on January 15, 2025.
