Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Advance Tank Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024

1 Description of Plan

The following description of the Advance Tank Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General. The Plan was adopted effective May 1, 1984 and is a single-employer defined contribution plan. The Company sponsoring the Plan is Advance Tank and Construction Co., located in Wellington, Colorado. Prior to June 1, 2021, the sponsor of the Plan was Prairie Tank & Construction Co. Employees that are nineteen years of age and older can enter the Plan on the first day of the month following one year of employment, with at least 1,000 hours of service. The Plan includes an auto-enrollment provision whereby all newly eligible employees are enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The Plan is subject to the provisions of ERISA.
- B. Contributions. Each year, participants may contribute up to the maximum amount allowed under the Internal Revenue Service (IRS) Code, as defined by the Plan. Participants who have attained age 50 before the end of the year may make catch-up contributions. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Companies' matching contribution is discretionary.
- C. Participant Accounts. Each participant's account is credited with the participant's contributions, the Companies' matching contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses.
- D. Vesting. Participants are immediately vested in their contributions, plus actual earnings thereon. A participant is 100% vested in the employer's matching contributions after three years of credited service.
- E. Investment Options. Upon enrollment in the Plan, a participant may direct employee and employer contributions among any of the investment options offered by the Plan. Automatically enrolled participants have their contributions invested in a designated balanced fund until changed by the participant.
- F. Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the participant's account balance and will bear interest at the prevailing rate as determined by the Plan. Principal and interest are paid ratably through payroll deductions.
- G. Payment of Benefits. Benefit payments or withdrawals may be made from any of the following circumstances: normal retirement upon reaching 65; total disability; participant death; termination of service; or financial hardship. Benefits will be paid as either a lump sum equal to the value of the participant's account or through payment of equal or substantially equal installments paid not less than annually over a period to exceed the participants' life expectancy (joint life expectancy for joint life spousal elections).

1 Description of Plan (Continued)

H. Forfeited Accounts. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts of \$1,815 and \$956, respectively, were used to offset employer contributions and administrative expenses.

2 Summary of Significant Accounting Policies

A. Basis of Accounting. The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined-contribution plan are required to be reported at fair value.

B. Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

D. Payment of Benefits. Benefits are recorded when paid.

E. Operating Expenses. Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements.

F. Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

3 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. The Plan is not covered under the Pension Benefit Guarantee Corporation (PBGC) termination insurance program.

4 Tax Status

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the IRS Code and, accordingly, the Trust's net investment income is exempt from income taxes.

4 Tax Status (Continued)

The Plan has obtained a favorable tax determination letter from the IRS; and, although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRS.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize tax liability or (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

5 Fair Value Measurements

FASB ASC 820-10-50, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurements) and the lowest priority to unobservable inputs (Level 3 Measurements). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820-10-50 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include -

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and,
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

5 Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: The underlying securities are listed on national securities exchanges and valued based on year-end closing prices. The plan has concluded that this constitutes readily determinable fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments would result in a different fair value measurement at the reporting date.

6 Group Annuity Contract with Insurance Company

The Plan has a group annuity contract with Principal Life Insurance Company that invests contributions in the Principal Fixed Income Guaranteed Option. The contract value was \$34,783 and \$5,205 at December 31, 2024 and 2023, respectively. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

6 Group Annuity Contract with Insurance Company (Continued)

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Principal Life Insurance Company. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

7 Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the Trustee.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for Plan benefits.

9 Related Parties

Principal Life Insurance Company, a Trustee of the Plan, manages the pooled separate accounts and the group annuity contract and charges administrative fees to the Plan. Therefore, it is a party-in-interest to the Plan.

10 Subsequent Events

Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.
