1. Plan Description

The following brief description of the NYCHSRO/MedReview, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan covering all full time eligible employees of MedReview, Inc. and NY County Health Services Review Organization, Inc. (the "Company") who have completed one month of eligible service and attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Trustees of the Company is responsible for oversight of the Plan. Management of the Company determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Trustees.

Contributions

Each year, eligible employees may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers").

Effective January 2023, the Company is required to make a safe harbor matching contribution equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's eligible compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's eligible compensation but do not exceed 5% of the Participant's Compensation.

Effective January 1, 2024, the Company may make a discretionary profit-sharing contribution which is allocated pro rata based on each eligible participant's compensation for the Plan year.

Participant Accounts

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, employer safe harbor matching contribution and Plan earnings (losses). Income earned and net appreciation or depreciation on Plan investments, are allocated in proportion to the participant's account balance in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

1. Plan Description (*continued*)

Vesting

Participants are immediately and fully vested in their voluntary contributions, employer safe harbor matching contributions and employer discretionary non-elective profit sharing contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one outstanding loan at a time. The interest rate on the loan will be based on the Prime rate of interest published by Wall Street Journal as of the date of the loan plus 2 percent. Loan terms range from one to five years with the exception of loans for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, including death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments not to exceed the life expectancy of the participant or the surviving spouse. A participant may receive in-service distributions upon circumstances of financial hardship or upon attaining the age of 59 1/2. Distributions are subject to the applicable provisions of the Plan Document.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

2. Summary of Significant Accounting Policies *(continued)*

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in, less any withdrawals and transfers out. Registered investment companies held by the Plan are valued at fair value based on the daily closing price as reported by the companies. All of the registered investment companies and money market fund are open-ended and are registered with the Securities and Exchange Commission. These companies are required to publish their daily NAV and to transact at that price.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are valued at their outstanding principal amounts plus accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are paid. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded, when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Forfeitures

Forfeitures of non-vested benefits may be used to pay administrative expenses, or to reduce future employer safe harbor contributions. Forfeited non-vested accounts totaled \$107 and \$291 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, there were no forfeitures used to reduce employer contributions. During 2024, there were no forfeitures used to reduce administrative expenses.

Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Other expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company and Empower Life & Annuity Insurance Company of New York, qualified institutions.

4. Group Annuity Contract

The Plan has a benefit-responsive investment contract with Empower Life & Annuity of New York. The Guaranteed Interest Account (the “GIA”) is provided through a group annuity contract (the “Contract”). A crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Participants ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value. Such events include: removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor’s business. Such events may also include (1) removal from the plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) plan disqualification.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investor Service Aa3, A.M. Best Company A+, Fitch AA, and Standard and Poor’s AA. These ratings are as of June 2025.

5. Tax Status

The Internal Revenue Service (“IRS”) has issued an opinion letter to the prototype plan document preparer dated June 30, 2020 which states that the Plan is designed in accordance with the applicable regulations of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

5. Tax Status (*continued*)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Prohibited Transactions

During 2023, certain participants' contributions totaling \$36,483 were not remitted within the time period prescribed by Department of Labor regulations due to an administrative oversight in applying the Plan's compensation definition following the plan transition. The Employer has corrected the process and worked with its service providers to calculate and remit the required lost earnings.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.
