### 1. Plan Description

---

The following brief description of the Paradigm Oral Surgery 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of OIS Management Services, LLC and Oral Surgery Intermediate Holdings, LLC d/b/a Paradigm Oral Health and affiliates (the "Company").

Employees are eligible to make pre-tax and after-tax Roth salary deferral contributions after attaining age 19 and completing three months of service. Participating employees are also eligible to receive safe harbor matching contributions and discretionary profit sharing contributions. Eligible employees may become participants immediately coinciding with the date on which the entry requirements were fulfilled. Employees are eligible to receive discretionary profit sharing contributions only if they performed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year.

#### ***Contributions***

Each year, participants may contribute up to 100% of pre-tax annual compensation in connection with the 401(k) provisions of the Plan, up to the maximum dollar limits allowable by law. The Plan allows participants to designate a portion or all of their elective contributions as after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company will contribute a safe harbor matching contribution in an amount equal to 100% of the participant's deferral up to 3% of eligible compensation and 50% of next 2% of eligible compensation and may contribute discretionary profit sharing contributions (none in 2024 or 2023) to the Plan. Participants who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of a) the Company's safe harbor matching contributions and discretionary profit sharing contributions and b) Plan earnings and losses, and charged with an allocation of administrative expenses. The Company's safe harbor matching contributions are allocated based upon each participant's elected salary deferral. The Company's discretionary profit sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of investments held in participant accounts.

Effective January 1, 2024, investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity). Prior to January 1, 2024, investments were maintained by Capital Bank and Trust Company.

### ***Vesting***

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. The Company's discretionary profit sharing contributions credited to participants' accounts are vested based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of service.

### ***Notes Receivable from Participants***

The Plan will accept transfer 401(k) notes receivable from participants from companies that are acquired. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. The terms of the notes are limited to five years, unless the loan is for the purchase of a primary residence which are limited to ten years, and all principal and interest payments must be made through payroll deductions.

### ***Payment of Benefits***

Upon retirement, disability, termination of employment, or death, the participant or beneficiary may elect to receive lump sum payments equal to the value of the vested funds allocated to the participant's account. Distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan allows in-service distributions up to the vested amount in the distributing account for participants who have reached age 59 ½. Benefits are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Company's discretionary profit sharing contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan administrative expenses or to reduce Company contributions. During 2024 and 2023, the Plan did not use any forfeited, non-vested amounts to pay Plan expenses or reduce Company contributions. As of December 31, 2024 and 2023, forfeited, non-vested amounts totaled \$13,510 and \$6,084, respectively.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Unallocated Cash***

Unallocated cash represents cash that was in-transit to the Plan's new custodian or contributions that had not been allocated to the respective participant accounts as of year-end.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Expenses*

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Record-keeping and investment advisor fees are paid by the Plan and are included in administration expenses. Fees related to distribution payments are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are paid by the Plan and included in net appreciation in fair value of investments.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 14, 2025, noting no items requiring disclosure.

### **3. Information Certified by Capital Bank and Trust Company and Fidelity**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Capital Bank and Trust Company and Fidelity, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual and Money Market Funds: Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.

### 7. Related Party Transactions

---

Plan investments at December 31, 2024 include mutual funds and money market funds which are managed by Fidelity. Fidelity is the custodian as defined by the Plan and therefore, these transactions qualify as party in-in-interest. Capital Bank and Trust Company offered American Funds and was the custodian of the Plan through December 31, 2023, and therefore, these transactions qualified as party-in-interest transactions.

### 8. Custodial Change

---

Effective January 1, 2024, Fidelity was appointed as the new custodian of the Plan. Plan assets transferred to Fidelity were transferred into Target Date Retirement Funds based on participants' date of birth if a participant had not selected otherwise. The conversion initiated a "blackout" period beginning December 22, 2023, and continued through February 9, 2024. During this period, funds could not be applied to the funds with Fidelity or withdrawn from the Plan until Fidelity had time to accurately complete the conversion. During the period, employee contributions continued to be made through payroll deductions, and the contributions were wired to Fidelity and held in a trust account until the completion of the blackout period.
