Opinion

We have audited the financial statements of the Star Lumber & Supply Co., Inc. Employee Group Benefit Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets arising from cash transactions as of December 31, 2024 and 2023, the related statement of changes in net assets arising from cash transactions for the year ended December 31, 2024, and the related notes to financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets arising from cash transactions as of December 31, 2024 and 2023, and the changes in net assets arising from cash transactions for the year ended December 31, 2024, in accordance with the cash basis of accounting as described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Star Lumber & Supply Co., Inc. Employee Group Benefit Trust (Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description (SPD) for a more complete description of the Plan.

General - The Plan provides self-funded medical (hospital, surgical and major medical), and prescription benefits covering participating full-time employees of Star Lumber & Supply Co., Inc. (Corporation) that have met the eligibility requirements. An employee becomes eligible to participate in the Plan if they work 30 or more hours a week and have completed two continuous months of active employment with the Corporation. Employees are entered into the Plan the first day of the following month upon meeting eligibility requirements and an affirmative election to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The medical and prescription benefits are funded by the Corporation and participating employees. No participant will be required to contribute an additional amount or be entitled to a refund as the result of the actual expense incurred for any year. All funds contributed are to be used for the exclusive benefit of the participants.

Benefits - The Plan provides health benefits (medical and prescription drugs) covering enrolled employees who have met eligibility requirements. Eligible employees may also enroll their dependents in the Plan. A participant's dependents include a spouse and any children age 25 and under.

Stop-Loss Coverage - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for benefits liability on individual participant claims over a specific dollar amount.

Contributions - A trust agreement established under the Plan requires that, in addition to meeting the eligibility requirements in the Plan, all employees desiring to participate in the Plan must authorize the Corporation to make appropriate payroll deductions to meet employee contribution requirements. The amount of contributions required by each participant shall be determined by the Trustees in advance from time to time as they deem necessary. The amount of employees' contributions should be adjusted at least annually on the first day of the Plan year.

In addition to the employees' contributions, the Corporation shall contribute from time to time, as may be required, to fund the Plan's benefits and administrative expenses.

Continuation Coverage - The Plan contains provisions allowing terminated employees and dependents who become ineligible for the Plan to convert their policies to individual policies. The ineligible individuals are billed separately for their policies. However, the premium payments received from the individuals are recorded as employee contributions in the Plan's financial statements.

Administrative Expenses - Certain administrative functions are performed by officers or employees of the Corporation. No such officer or employee receives compensation from the Plan and no such costs are therefore included in these financial statements.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Self-insured Benefits - The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Corporation maintains a contract with Medtrak Services LLC and Auxiant to administer the payment of medical and prescription drug claims. The Plan has a contract with HCC Life Insurance which covers annual specific medical claims per covered person in excess of \$150,000.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements are prepared on the cash basis of accounting. Transactions are recorded when a transfer of funds is made without recognition as to when income was earned or expenses incurred. The difference between the cash basis and the accrual basis of accounting required by accounting principles generally accepted in the United States of America would involve the recording of receivables from the Corporation and employee contributions, claims payable, claims incurred but not reported or not paid, insurance premiums payable and administrative expenses incurred but not paid.

Cash - The Plan maintains its cash in bank deposit accounts that, at times, may exceed the federally insured limits. The Plan has not experienced losses in such accounts.

Insurance Premiums - Premiums paid by the Plan are recorded as health care insurance premiums paid in the accompanying statement of changes in net assets available for benefits. Premiums for expected claims as annualized by Meritain are paid by employees and the Corporation.

Claims Payable - Claims are recorded when paid in accordance with the cash basis of accounting. The estimate for unrecorded estimated medical claims payable and unrecorded claims incurred but not reported (IBNR) is calculated based on actual claims incurred during the year for which payment was made subsequent to year-end and historical data as provided by insurance consultants to the Plan. The estimated IBNR for the Plan was approximately \$202,000 and \$184,000 as of December 31, 2024 and 2023, respectively. These obligations will be funded through subsequent contributions or from existing assets in the Plan.

Stop Loss - Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits (cash basis). Stop loss refunds totaling approximately \$199,000 have been netted with claims paid in the accompanying statement of changes in net assets (cash basis).

Subsequent Events - These financial statements considered subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. CLAIMS ADMINISTRATION AND OTHER EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators (Auxiant). These expenses are reported on the statement of changes in net assets available for benefits (cash basis) as claims administration and other expenses.

4. FEDERAL INCOME TAXES

The Plan received an exemption letter from the Internal Revenue Service (IRS) dated July 21, 1988, stating that the trust is tax exempt under the provisions of Section 501(a) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for the year ended December 31, 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Plan. The plan administrator believes that the Plan, including any amendments to the Plan since receiving the determination letter, is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related Plan and trust are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements related to all open periods. No provision or liability for income taxes has been included in the financial statements.

5. PLAN TERMINATION

Although it has not expressed an intention to do so, the Corporation has the right under the Plan to modify the benefits provided to, and the contributions required of, participants; to discontinue its contributions at any time; and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Corporation or be used for the purposes other than for the exclusive benefit of the Plan's participants.

6. PARTY-IN-INTEREST TRANSACTIONS

Claims are managed by Auxiant; therefore, premiums paid, along with administration and consulting fees, qualify as party-in-interest transactions. Total insurance premiums paid totaled to \$447,139 in 2024. Fees incurred and paid directly by the Plan for claims administration services was \$212,391 in 2024 and are included in administrative expenses on the statement of changes in net assets arising from cash transactions.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

IBNR is determined based on certain assumptions pertaining to historical claim rates, lag times, and individual large claims, all of which are subject to change. Due to uncertainties inherent in the estimation and assumptions process, it is at least reasonably possible that changes in the estimates and assumptions in the near term would be material.
