The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of Crown Diversified Industries Corp & Affiliates 401(k) PS Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which was adopted on July 1, 1998, by Crown Diversified Industries Corp (the Company), amended on June 1, 2021, and again on December 1, 2022, is a defined contribution profit sharing plan with a 401(k) provision. The Plan covers all employees of the Company except for collectively bargained employees and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

American United Life Insurance Company (OneAmerica) is the Plan's recordkeeper and contract issuer.

Eligibility

Employees of the Company who have completed three months of service and are age 18 or older are eligible to participate in the Plan.

Contributions

Participants can defer salary up to 100% of compensation, not to exceed Internal Revenue Service (IRS) limits. Participants age 50 or older are eligible to make catch-up contributions. The Plan allows participants to make Roth after-tax contributions. Additionally, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan provides for the Company to make discretionary matching contributions. For the years ended December 31, 2024 and 2023, the Company matched 100% of the first 4% of eligible compensation up to \$10,000.

In addition, the Plan provides that the Company may make discretionary profit sharing contributions for each eligible participant. During the years ended December 31, 2024 and 2023, the Company did not make any profit sharing contributions.

Vesting

Participants are 100% vested in their salary deferral and rollover contributions plus actual earnings thereon. Vesting in Company discretionary matching and profit sharing contributions is based on years of service over a 5-year graded vesting schedule. A participant becomes 100% vested upon reaching the normal retirement age of 65, becoming disabled or death.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts may be used to pay administrative expenses or fund future Company matching contributions. Forfeitures available for future use amounted to \$36,567 and \$8,983 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures of \$461 and \$800 were used to reduce employer contributions and pay plan administrative expenses, respectively. During the year ended December 31, 2023, forfeitures of \$8,541 and \$1,064 were used to reduce employer contributions and correct a previous distribution, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary contributions and an allocation of the Plan's earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans must be secured by the participant's vested account balance and bear interest at prevailing market rates. Participants may only have one loan outstanding at any time. Principal and interest are paid back ratably through payroll deductions or participant payments.

Payment Of Benefits

Upon retirement, termination, or death, a participant may make withdrawals from his or her vested account in the form of a lump-sum payment. In the event that the vested portion of the participant's account does not exceed \$5,000, the balance shall be distributed in a lump sum as soon as administratively feasible.

In-Service Withdrawals

Active participants who attain the age of 59-1/2 or become disabled may withdraw all or part of their vested accounts. In addition, participants who experience a qualifying financial hardship may withdraw from the Plan a portion of their vested account from elective salary deferral contributions. Hardship withdrawals will be approved only if they conform to Plan provisions and established IRS safe harbors.

Administrative Expenses

Administrative expenses of the Plan are paid by participants in the Plan and the Company.

Investment Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. The net change in the fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized and unrealized gains and losses.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the AUL Stable Value Account is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded as earned on the accrual basis. Delinquent notes receivable are recorded as a distribution based on the terms of the Plan Document.

Payment Of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by OneAmerica, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from OneAmerica that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

4. Fully Benefit-Responsive Investment Contract

The Plan invests in a fully benefit-responsive investment contract with OneAmerica, which maintains the contributions in a guaranteed return account, at contract value.

As described in Note 2, because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by OneAmerica, represents contributions made under the contract, plus investment activity, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Company's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. The Company does not believe that any events have occurred that would limit the Plan's ability to transact at contract value with the Plan participants.

The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on an annual basis for resetting.

5. Fair Value Measurements

The Plan follows an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts

Valued at the daily closing price as reported by the fund. Pooled separate accounts held by the Plan are open-ended mutual funds that track specific indexes and are registered with the Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The pooled separate accounts held by the Plan are deemed to be actively traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Risks And Uncertainties

The Plan invests in various investment securities, which, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Party In Interest Transactions

The Plan investments comprised pooled separate accounts and an investment contract managed by OneAmerica. The Plan also paid OneAmerica for certain administrative expenses. In addition, certain participants have outstanding loans as of December 31, 2024 and 2023. These transactions are considered party in interest transactions allowable under ERISA.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become 100% in their accounts.

10. Income Tax Status

Effective December 1, 2022, the Plan was restated through the adoption of a pre-approved plan document sponsored by Pension & Retirement Services LLC. Pension & Retirement Services LLC received a favorable opinion letter from the IRS dated January 12, 2022, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date. As such, no income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

This is a summary of the annual report for Crown Diversified Industries Corp & Affiliates 401(k) PS Plan, 43-0956288/001 for 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and trust. Plan expenses were \$2,186,078. These expenses included \$18,948 in administrative expenses and \$2,127,153 in benefits paid to participants and beneficiaries, and \$39,977 in other expenses. A total of 582 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$15,048,493 as of 12/31/2024, compared to \$14,240,947 as of 01/01/2024. During the plan year the plan experienced an increase in its net assets of \$807,546. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,993,624, including employer contributions of \$629,093, employee contributions of \$1,168,117, gains of \$0 from the sale of assets and earnings from investments of \$1,196,414.
