Note 1 – Plan Description

The following description of the K-VA-T 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of K-VA-T Food Stores, Inc. and its wholly-owned subsidiaries, Misty Mountain Spring Water Co., LLC; JCS Sales, LLC; and FC ACE, LLC. (collectively, the “Company”) who are age twenty-one or older for employee deferral contributions, and who have one year of service with at least 1,000 hours of service and are age twenty-one or older for matching contributions. Excluded classes of employees include collective bargaining (union) employees and employees of related non-participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute 1% to 100% of annual compensation up to the maximum allowed by the *Internal Revenue Code (IRC)*, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective January 1, 2024, the Plan was amended to permit roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a match of \$1 for each dollar of the first 3% of base compensation that a participant contributes to the Plan. Contributions are subject to certain limitations. Additional amounts may be contributed at the option of the Company’s Board of Directors.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, any rollover accounts, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company’s matching portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service (a five-year cliff vesting schedule) in pre-2002 amounts and 100% vested after six years of credited service in post-2001 amounts as follows:

Notes from Participants

Participants may borrow from their vested balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance at the preceding valuation date. The maximum loan term may not extend beyond the earlier of sixty months or normal retirement age, as defined by the Plan agreement. Loans taken for a qualified home purchase, however, may extend up to a period of 240 months. Notes are secured by the vested balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant or a participant's beneficiary with a vested balance in excess of \$7,000 may elect to receive either a lump-sum amount or roll over the funds to another qualified plan or an individual retirement account. Vested benefits less than \$7,000 will be paid in a lump-sum amount.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$5,556 and \$-0-, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$133,719 and \$95,264 were used for Plan expenses from forfeited non-vested accounts.

Administrative Costs

Plan fees and administrative expenses are paid by the Company on a discretionary basis. The majority of these fees and expenses were paid by the Plan for the year ended December 31, 2024.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Certain information was certified as complete and accurate by Principal Trust Company, the Plan's Trustee. That information is as follows:

Note 4 – Investment Contracts

The Reliance MetLife Series 25053, Class 25 is a benefit-responsive investment contract with Metropolitan Life Insurance Company (MetLife). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Note 5 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Authoritative guidance issued by the Financial Accounting Standards Board established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The Reliance MetLife Stable Value Fund Series 25053 is a collective investment trust owned by the Plan at December 31, 2024 and 2023. The Stable Value Fund is invested in MetLife Group Annuity Contracts and seeks to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investments for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements

The fair values of common collective trust funds are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024, and 2023. There are no participant redemption restrictions for the investment; the redemption notice period is applicable only to the Plan.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contribution portion of their accounts.

Note 7 – Tax Status

The Plan is an adoption of a non-standardized, pre-approved profit sharing plan sponsored by the Trustee that obtained its latest determination letter on June 30, 2020. The Plan and related trust are designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

In March 2021, the Plan was notified by the IRS that the IRS would be conducting an examination of the Plan for the year ended December 31, 2019. The examination concluded with a settlement agreement signed on February 26, 2025. As a result of the examination, the Plan was amended to limit Highly Compensated Employee deferrals to 3% of compensation. The settlement payment was paid directly by the Plan Sponsor to the U.S. Treasury with no impact on the Plan or Plan participants.

Note 8 – Related Party and Parties-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds held and managed by the Plan's Trustee. Investments in funds issued and managed by the Trustee are considered party-in-interest transactions. Fees paid by the Plan to the Trustee and third-party administrators for investment management and record-keeping services amounted to \$319,259 for the year ended December 31, 2024.

Note 9 – Subsequent Events

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued. Management concluded no subsequent events have occurred that would require recognition in the financial statements.
