## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Pinnacle Advertising 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Pinnacle Advertising 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**A. DESCRIPTION OF PLAN**

The following description of the Pinnacle Advertising 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Ericjon World Wide Holdings, Inc. (the Company) who have one month of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee is responsible for oversight of the Plan.

Contributions

Each year, participants may make either pre-tax or Roth after-tax elective contributions of eligible compensation, as defined by the Plan, not to exceed the maximum amount allowable under applicable income tax regulations. The limit is \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, up to \$7,500 for 2024. Participants may also contribute the distributions received from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions. Safe harbor matching contributions are allocated among employees at a rate of 100% of the first 3% of participant's deferrals, and 50% of the next 2% of deferrals, which totaled \$402,073 for the year ended December 31, 2024. The Company may also make discretionary matching contributions or discretionary profit-sharing contributions. During the year ended December 31, 2024, the Company did not make a discretionary matching or profit-sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions as well as allocations of the Company's contributions plus Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate at the time of the loan plus 1%. Principal and interest are paid ratably through semi-monthly payroll deductions. As of December 31, 2024 and 2023, the balance of notes receivable from participants was \$62,876 and \$60,260, respectively.

Vesting

Participants are vested immediately in their elective contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and profit-sharing contributions plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year and become fully vested after five years of service.

Upon death or attaining normal retirement age (the later of age 65 or the fifth anniversary of participation in the Plan), participants will be 100% vested in the Company's discretionary matching and profit-sharing contributions.

**A. DESCRIPTION OF PLAN (CONTINUED)**

Payment of Benefits

Upon termination of service due to death, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the vested balance of the participant's account or to receive partial payments from time to time until the entire vested benefit is distributed.

Hardship distributions, as well as in-service distributions for participants who have attained age 59-1/2, are also available as described in the Plan.

**B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which represents fair value. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions are recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,697 and \$3,253, respectively. These accounts will be used to pay Plan expenses, restore forfeited balances of eligible rehires, and reduce future employer contributions. In 2024, no forfeited accounts were reallocated.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. No events requiring additional adjustments or disclosures were identified.

**C. CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (John Hancock) the custodian of the Plan, as follows:

During the year ended December 31, 2024, the Plan's investments (including investments bought, sold and held during the period) appreciated in value by \$1,659,721.

**D. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy give the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable input (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:

  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: The pooled separate accounts are group annuity contracts available through John Hancock. The Plan's assets are invested in various underlying funds, including:

- TIAA-CREF Lifecycle Index funds
- JH Multi-Index Lifecycle funds
- Vanguard and PIMCO bond funds
- Various other mutual funds and index funds from providers like Vanguard, MFS, JPMorgan, Franklin, and Fidelity

These investments are structured to approximate the investment performance of their respective indices or investment strategies by allocating assets to the underlying funds. The fair value of the underlying securities is used to determine the Net Asset Value of the separate accounts, which are not publicly quoted.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**E. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays administrative fees to John Hancock, the Plan's custodian and recordkeeper. These transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan made direct payments to John Hancock of \$62,753 for administrative services. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**F. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**G. TAX STATUS**

Effective January 1, 2022, the Plan operates under the provisions of the DATAIR Pre-Approved Defined Contribution Plan, as amended and restated. The IRS determined and informed DATAIR Employee Benefit Systems, Inc., by a letter dated June 30, 2020, that the non-standardized pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

The provisions of the Plan do not vary from the pre-approved plan. Accordingly, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax exempt.

**H. RISK AND UNCERTAINTIES**

The Plan provides for investment that, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
