Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of the SHS 403(b) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the financial statements of the Plan referred to in the first paragraph. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income/loss and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits as of December 31, 2024. The amount of these excluded annuity contracts and custodial accounts and the related income/loss and distributions are not determinable. Accounting principles generally accepted in the United States of America (U.S. GAAP) require that these accounts and the related income/loss and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


Auditor's Responsibilities for the Audit of the Financial Statements

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the SHS 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan is a defined contribution 403(b) plan established for the benefit of the employees of Susquehanna Health System (the System), the Plan Sponsor. The System and the University of Pittsburgh Medical Center (UPMC) completed an affiliation between the organizations, and the System was renamed UPMC Susquehanna. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). State Street Bank and Trust Company and Transamerica Financial Life Insurance Company serve as custodians of the Plan, and Transamerica Retirement Solutions Corporation (Transamerica) serves as the recordkeeper.

The Plan was amended to freeze all elective contributions, matching contributions and retirement income contributions (effective December 31, 2017); cease all new loans to participants (effective December 1, 2017); and cease all future transfers to the Plan (effective December 21, 2017). Additionally, effective December 31, 2017, entrance into the Plan was frozen. Participants continue to have access to their accounts and continue to receive earnings on their investments. They can change their investment elections throughout the year.

Participant Accounts - Effective after the Plan freeze at December 31, 2017, each participant's account was credited with allocations of Plan earnings or losses and charged with an allocation of administrative expenses. Plan earnings or losses are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants were immediately vested in their contributions and rollover contributions, as defined by the Plan document, plus actual earnings thereon. Vesting in the System's matching and nonelective contribution portions of accounts plus actual earnings thereon is based on years of service. A participant becomes 100% vested after three years of credited service, as defined in the Plan document. Participants became fully vested, regardless of the vesting table, upon attainment of normal retirement age. Effective January 1, 2018, the accounts of certain participants, as defined in the Plan document, became fully vested.

Notes Receivable from Participants - Prior to the freeze, a participant could borrow from his or her account up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. Loan terms could not exceed five years, unless the loan was for the purchase of a principal residence, in which case the loan repayment term could not exceed 20 years. Loans are collateralized by the percentage of the participant's vested account balance equal to the amount borrowed, divided by the vested account balance. Interest rates were determined in accordance with the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits - Upon termination of service, participants with account balances that do not exceed \$1,000 will receive a lump-sum distribution. Participants with account balances equal to or greater than \$1,000 but not exceeding \$5,000 will have their balance directly rolled over to an individual retirement account as designed by the Plan administrator, unless the participant elects a direct distribution or other eligible direct rollover. Participants with account balances exceeding \$5,000 may elect to receive either a lump-sum amount equal to the value of his or her account or periodic installments, not to exceed the life expectancy of the participant or the participant's beneficiary.

Withdrawals other than for termination are permitted under certain circumstances as defined by the Plan. The Plan permits in-service and hardship withdrawals.

Transfers - Effective April 1, 2018, the Plan permits fully vested eligible participants who participate in the UPMC 403(b) Retirement Savings Plan and/or the UPMC 401(a) Retirement Savings Plan to elect a plan-to-plan transfer to those plans, provided that the participant has no outstanding loans under the Plan. Transfers out of the Plan were approximately \$1,284,000 in 2024.

Forfeitures - Participants who leave the System and incur a break in service forfeit the nonvested portion of their accounts. Such forfeitures are used to offset Plan expenses. There were no forfeitures available at December 31, 2024 or 2023. The Plan used approximately \$3,000 of forfeitures to offset Plan expenses during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Annual Reporting Requirements - Prior to January 1, 2009, the custodians maintained records at a contract, not a plan level, and administratively decided to not provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees. As such, neither the System nor the custodians have been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and accuracy of the annuity and custodial accounts, related investment income (loss) and distributions related to these accounts, if any, could not be determined.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value, which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements and Note 5 for the discussion of fully benefit-responsive investment contracts.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payments of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's administrative expenses are paid by either the Plan or the System as provided by the Plan document. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events - Subsequent events are defined as events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are issued or available to be issued. Management has evaluated subsequent events through October 14, 2025, the date that the financial statements were issued, and determined that there have been no events that have occurred that would require adjustments to disclosures in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, except for the amount of certain excluded annuity contracts and custodial accounts and the related income/loss and distributions as mentioned in the Basis for Disclaimer Opinion paragraph, is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest and dividends, net appreciation in fair value of investments and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENT

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

- Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

NOTE 4 - FAIR VALUE MEASUREMENT (Continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance Company/General Account

The Plan holds an investment contract with Transamerica Financial Life Insurance Company (TFLIC), which is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The declared crediting rate is reset annually and will never be below 1.25%.

The guaranteed investment contract is fully benefit-responsive, therefore contract value is the relevant measurement. Contract value, as reported to the Plan by TFLIC, represents contributions made under the contract (prior to the freeze at December 31, 2017), plus earnings, less withdrawals and administrative expenses. The Plan may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Suspension of the contract might limit the ability of the Plan to transact at contract value with the contract issuer, however the Plan administrator does not believe the occurrence of this event is probable.

Certain events might allow TFLIC, the issuer, to terminate the contract and settle at an amount different from contract value. Such events include (1) deposits required under the terms of the contract are not received by TFLIC, or (2) TFLIC determines it can no longer provide benefits under the contract because of a change in the Plan.

Standard Stable Asset Fund I

The Plan holds a fully benefit-responsive investment contract with Standard Insurance Company (Standard), which maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate guaranteed to the Plan. The declared crediting rate is reset quarterly and will never be below 1%.

The guaranteed investment contract is fully benefit-responsive, therefore contract value is the relevant measurement. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract (prior to the freeze at December 31, 2017), plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments. The Plan administrator does not believe that the occurrence of any such event that would limit the Plan's ability to transact at contract value with participants is probable.

NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan holds a fully benefit-responsive investment contract that is issued and managed by one of the custodians. Additionally, the Plan holds loans to participants, which are secured by the participant's account balances.

Certain administrative expenses were paid directly by the System, for which it is not reimbursed. Expenses paid by the System are not material. Certain administrative functions are performed by officers or employees of the System. No such officers or employees received compensation from the Plan.

These transactions qualify as party-in-interest transactions, however they are exempt from the prohibited transaction rules under ERISA.

NOTE 7 - PLAN TERMINATION

The System has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

NOTE 8 - TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). Terms of the Plan have been prepared to conform with sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to risk, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in value could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.
