Independent Auditor's Report

To the Trustees, Plan Administrator, and Plan Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BWBR Architects, Inc. Notes to the Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following brief description of the BWBR Architects, Inc. Profit Sharing and 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan is a defined contribution plan covering employees of BWBR Architects, Inc (the "Company" and "Plan Sponsor") that meet eligibility requirements. Employees who are at least 21 years of age may elect to defer a portion of their compensation upon commencement of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the Internal Revenue Code ("IRC"). The Plan was established on December 1, 1974.

Contributions

Participants may contribute up to 100% of eligible compensation, as defined by the Plan, up to the maximum permitted by law to their plan accounts. The plan allows rollover and catchup contributions.

The Company contributes a safe harbor contribution of 3% of each eligible employee's eligible compensation. Company safe harbor contributions were approximately \$757,000 for 2024.

Discretionary profit sharing contribution may be contributed at the election of the Company's Board of Directors. Discretionary contributions are allocated based on each eligible employee's compensation compared to total Company eligible compensation. Discretionary contributions were approximately \$751,000 in 2024. Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions and employer safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 20% vested after each year of service and are 100% vested after five years of service.

Investment Allocation

Assets of the Plan are held in various funds as determined by the Company. All accounts are participant directed. Participants may change their investment allocation daily.

1. Description of Plan (Continued)

Payment of Benefits

Benefits paid to participants represent the amount paid during the year to withdrawing participants. Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of his or her benefits in the form of a lump-sum amount equal to the participant's account balance or installment payments over a specified period of time. For termination of service due to other reasons, a participant may receive the value of his or her account as a lump-sum distribution. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees. No hardship distributions are allowed.

The distribution will be in the form of a lump sum payment if the participant's vested benefit is \$5,000 or less, unless the participant elects a direct rollover or distribution of their vested account balance. The distribution will be automatically rolled over to an individual retirement account in accordance with the IRC if the participant's vested benefit is greater than \$1,000 (but less than \$5,000) unless the participant elects, within the applicable period, to have the distribution paid to them or rolled over to another IRA or other eligible plan able to receive rollovers.

Forfeited Accounts

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance may be used to reduce future employer contributions to the Plan or reduce plan expenses. There were no forfeitures used to reduce employer contributions or pay plan expenses during 2024. At December 31, 2024 and 2023, there was approximately \$17,000 and \$6,000 of forfeited nonvested account totals in the Plan, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with US GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements and Note 5 for disclosure related to the fully-benefit responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net appreciation in value of investments.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds

Valued at quoted market prices. Mutual funds traded in active markets are classified within Level 1 of the fair value hierarchy.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Administrative expenses, including audit, investment management fees, trust, and recordkeeping fees, are paid from the assets of the Plan or are allocated among Plan participants.

SECURE 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2020 CARES Act. Provisions will continue to become effective beyond 2024, and since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect. No optional provision elections had been made as of December 31, 2024.

Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through October 14, 2025, the date which the financial statements were available to be issued.

- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the direction of the Plan Administrator, the Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Fully Benefit-Responsive Contract

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica Retirement Solutions (Transamerica). Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

6. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their employer contributions and the Plan assets will be distributed according to the provisions of the Plan documents.

7. Tax Status

The Plan adopted the Transamerica Retirement Solutions, LLC non-standardized pre-approved profit-sharing plan, which received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

9. Party-In-Interest Transactions

Certain Plan investments are managed by Transamerica Retirement Solutions, the recordkeeper of the Plan, and Transamerica Life Insurance Company, the Custodian of the Plan; therefore, these are party-in-interest transactions.
