Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bridgeway Connects, Inc. and Subsidiaries Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

1. Description of Plan

The following description of the Bridgeway Connects, Inc. and Subsidiaries (the Company or Plan Sponsor) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan, the purpose of which is to provide regular salaried and hourly employees of the Company an opportunity to accumulate savings for their retirement. The Plan was adopted by the Company effective September 1, 1990, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan for the period of January 1, 2023 to May 31, 2024 was Reliance Trust Company. The trustee and recordkeeper of the Plan for the period of June 1, 2024 to December 1, 2024 was Ascensus, LLC. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective June 1, 2024, the Plan was amended to reflect a change in the trustee from Reliance Trust Company to Ascensus, LLC. As a result of this change, participants may no longer contribute to investment options offered by Reliance Trust Company. The employer and investment adviser completed a mapping of the previous investment options to the new investment options provided by Ascensus, LLC. Except where otherwise specified, "the trustee" refers to both of the entities in the respective period during which they were acting as the trustee and recordkeeper, as outlined above.

Eligibility

Employees of the Company are considered eligible for participation, except for: (1) nonresident aliens with no U.S. source of income; (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan; (3) leased employees; and (4) independent contractors.

Participant must be 18 years of age to participate in the Plan. Additionally, the participant must complete two months of service to participate in the Plan. A participant's entry date into the Plan will be the first day of the month coinciding with or next following the date in which the eligibility requirements were satisfied.

Contributions

Contributions to the Plan consist of participant deferrals and employer discretionary contributions that are participant-directed, and rollovers from other qualified retirement plans. Participants can elect to defer up to 100% of their annual compensation, subject to statutory limitations, and may direct investments among several investment options. Employees have the option of changing their investment options daily. A participant's elective contribution was limited to \$23,000 for 2024. Employees who become participants automatically have 2% deducted from their compensation as a

contribution to the Plan, unless otherwise elected. Employer contributions may consist of both a discretionary profit-sharing contribution and a discretionary matching contribution (collectively, the Company contributions). A participant must be employed on the last day of the year to receive an allocation of the Company's discretionary profit-sharing contribution. The Company made no profit sharing contribution in 2024 or 2023.

A participant may also make catch-up contributions in excess of the above limit for any year in which the participant is aged 50 or older by the last day of the Plan year. For the year ended December 31, 2024, the maximum amount of catch-up contributions permitted was \$7,500.

Contributions and the related receivable are recognized in the period during which the Company makes respective payroll deductions from the participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are credited for one year of service for each Plan year in which they work at least 1,000 hours. Vesting in the Company contributions occurs at a rate of 20% per year. An employee is 100% vested in Company contributions upon the completion of five years of service. Participant contributions, plus actual earnings thereon, are 100% vested at all times. Additionally, participants who are employed on or after the normal retirement age of 65 will be 100% vested in employer profit sharing and matching contributions.

Employer Contributions are subject to the following vesting schedule below:

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

Different vesting schedules may apply to certain participants as described in the Plan Document due to prior plan provisions.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments.

Participants may elect to rollover their vested balance to another qualified retirement plan or Individual Retirement Account (IRA).

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Participants may also withdrawal an amount at age 59½ if certain criteria are met.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$33,000 and \$68,000, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. No forfeited funds were used to pay administrative expenses in 2024.

Forfeitures may be allocated among eligible Plan participants. During 2024, no forfeited funds were allocated to participants from the forfeiture account. During 2024 all forfeited funds were used to fund employer contributions in the period.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 1% or at local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Also, each participant may not have more than one loan outstanding at any time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned on an accrual basis. The net appreciation in the fair value of investments includes the gains and losses on investments sold as well as held during the year.

Risks and Uncertainties

The Plan's investments are exposed to various risks and uncertainties, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near term could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes Receivables from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination or partial termination of the Plan, all amounts credited to a participants' account, including Company contributions, become fully vested.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan Document. Expenses that are paid directly by the Company are excluded from these financial statements.

Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan defines subsequent events as events or transactions that occur after the balance sheet date, but before the financial statements are issued or available to be issued. Management has evaluated subsequent events through October 14, 2025, the date in which the financial statements were available to be issued.

Effective January 1, 2025, the Plan adopted an amendment which reduces the vesting period from five total years until fully vested from the start of a participant's vesting period, to three total years until fully vested from the start of the participant's vesting period.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, as of December 31, 2024 and for the period of January 1, 2023 to May 31, 2024 and Ascensus LLC as authorized representative of Ascensus Trust Company as of December 31, 2024 and for the period of June 1, 2024 to December 31, 2024, qualified institutions.

5. Tax Status

The Plan is a non-standardized pre-approved profit sharing/money purchase/CODA plan. The pre-approved plan received a letter dated, October 6, 2020, in which the Internal Revenue Service stated its opinion that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is

currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party and Parties-in-Interest Transactions

The Plan paid certain direct and indirect fees to Reliance Trust Company, from the period of January 1, 2023 to May 31 2024, and to Ascensus, LLC, from the period of June 1, 2024 to December 31, 2024, for the year ended December 31, 2024, which are deducted from fund income prior to being distributed to Plan participants. Ascensus, LLC, is the recordkeeper of the Plan as of December 31, 2024 and for the year ended December 31, 2024; therefore, these transactions qualify as party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employers of the Company at no cost to the Plan.

The Plan has notes receivable from participants subject to specific guidelines as defined in the Plan Document (Note 1).

These transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.
