Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Fabuwood Cabinetry Corp. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan, established in 2011, is a defined contribution plan with a salary deferral arrangement subject to the provisions of the Internal Revenue Code (the “Code”) and the Employee Retirement Income Security Act of 1974 (“ERISA”). Fabuwood Cabinetry Corp. (the “Company”) serves as the “Plan Sponsor” and “Plan Administrator”. The Company is responsible for the oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Reliance Trust Company (“Reliance”) serves as the Plan’s Trustee and Custodian and TAG Resources, LLC serves as the third-party administrator (the “TPA”) and record keeper. Dennis M. Leahy (“DL”) serves as the Plan’s investment advisor. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

Eligibility

All full-time employees are eligible to participate except for union employees, nonresident aliens and leased employees. Employees become eligible to participate after they reach age 21 and have completed at least 1,000 hours in 12 months of service. Employees are admitted to the Plan by the next plan entry date.

Contributions

Each year, participants may contribute up to 90% of their pre-tax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed the amount allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year the employer is required to provide a safe harbor matching contribution of up to 4% of participant pre-tax compensation. The employer may also decide each plan year whether to make an additional discretionary matching contribution and a discretionary non-elective profit sharing contribution on behalf of eligible active participants. For the year ended December 31, 2024, the Company did not provide any additional discretionary contributions. Contributions are subject to certain IRS limitations.

NOTE 1 **DESCRIPTION OF PLAN (continued)**

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and a maximum of the lesser of \$50,000 or 50% of their vested interest in the Plan, less any outstanding loan balance. Loans are secured by the balance in the participants' accounts. The loan interest rate is set at 1% above the Wall Street Journal Prime Rate. Principal and interest are paid through payroll deductions.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, if applicable, and plan earnings. Each participant's account is charged with withdrawals and plan losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their voluntary employee contributions (including rollover contributions) and earnings related to those contributions. Additionally, participants immediately vest in safe harbor matching contributions. Vesting in the Company's discretionary profit sharing and matching contribution portion (other than safe harbor) of their accounts plus actual earnings thereon is based on years of service. A participant is 20% vested after two years, with a 20% increase in each succeeding year until becoming fully vested after the sixth year of service. However, participants who are employed on or after their 65th birthday become immediately vested in the Company's discretionary profit sharing and matching contribution portion.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Certain rollover contributions may be available for distribution at any time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited accounts had no balance. Forfeitures, as defined in the Plan Agreement, when not used to pay administrative costs of the Plan, will be used to reduce employer contributions. For the years ended December 31, 2024 and 2023 there were no amounts used to pay for administrative expenses or to reduce employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The Plan Administrator uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets, reported changes in net assets available for benefits and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Income Recognition

Net appreciation (depreciation) in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold, as well as held during the year, based on the value of assets at the beginning of the year or at the time of purchase during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest on notes receivable from participants is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are charged to the participants’ accounts and are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There are no excess contributions payable for the year.

Income Recognition

Net appreciation (depreciation) in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold, as well as held during the year, based on the value of assets at the beginning of the year or at the time of purchase during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest on notes receivable from participants is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements.

NOTE 3 INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian. This information has not been audited by the Plan's independent auditors.

NOTE 4 FAIR VALUE MEASUREMENTS

GAAP defines fair value, provides guidance for measuring fair value and requires certain disclosures. GAAP discusses valuation techniques, such as the market approach (comparable market prices), the income approach (present value of future income or cash flow), and the cost approach (cost to replace the service capacity of an asset or replacement cost). GAAP provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

The following is a brief description of those three levels:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active.

Level 3: Unobservable inputs that reflect the Company's own assumptions.

The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission and are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are categorized as Level 1.

Common Collective Trust - Reliance MetLife Stable Value Fund

The Plan’s investment in the Reliance MetLife Stable Value Fund is valued at the NAV of units of a bank collective trust. The NAV is provided by the Trustee and is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Unit values are determined by dividing the fund’s net assets at fair value by its units outstanding at the valuation dates.

NOTE 6 TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation, record-keeping and financial reporting of the Plan. The Company pays the salaries of these individuals and also pays other administrative expenses. Certain fees, to the extent not paid by the Company, are paid by the Plan. The Plan paid administrative fees related to the TPA and record keeper of \$61,911 for the year ended December 31, 2024.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 8 TAX STATUS

The Internal Revenue Service has determined and informed the previous Plan third party administrator by a letter dated December 31, 2018, that their prototype 401(k) Plan is designed in accordance with applicable sections of the Internal Revenue Code IRC. Although the Plan has been amended since receiving the determination, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment instruments, including mutual funds. Investments, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

There were three funds that represented more than 10% of the total investments held at December 31, 2024, and two funds that represented more than 10% of the total investments held at December 31, 2023.

NOTE 10 SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.
