Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Little Potato Company USA, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of the Plan

The following description of The Little Potato Company USA, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to qualifying employees of The Little Potato Company USA, Inc. (Company). The Plan is designed to comply with Section 401(k) and the regulations thereunder of the Internal Revenue Code (IRC), as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan is Securian Financial ("Securian" a business unit of Minnesota Life Insurance Company). The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees become eligible for the Plan upon reaching age 21 and completing three months of service. The Plan excludes residents of Puerto Rico. Once eligible, employees can enter the Plan on the first day of the month following satisfaction of the eligibility requirements.

Contributions

Under the Plan, employees can contribute up to 100% of their compensation subject to certain IRC limitations. Elective contributions by the employee can be made on a pre-tax or Roth basis. The Plan permits eligible participants to make "catch-up" contributions each year starting the year the participant attains age 50 subject to certain IRC limitations. Employees can contribute into the Plan eligible rollover distributions received from prior employers' qualified plans.

The Plan has an automatic enrollment feature. Under this feature, unless the employee affirmatively elects otherwise, any new employee will be deemed to have entered into a salary reduction agreement and elected to make elective contributions into the Plan coinciding with the employee's qualifying entry date. Automatic elective contributions are initially set at 6% for the first two years of an employee's annual eligible compensation and are automatically increased 1% annually until the employee has reached 10% or entered into a salary reduction agreement. Eligible employees may change or stop the amount of their elective contributions at any time subsequent to their automatic enrollment.

Under the Plan, the Company provides matching contributions of 100% of the employee's contributions up to 3% of eligible compensation, plus 50% of the employee's contributions that exceed 3% but that do not exceed 5% of eligible compensation.

The Plan provides for the Company to make discretionary profit-sharing contributions. The employee must attain 1,000 hours of service during the plan year and be employed as of the last day of the year to be eligible to receive the discretionary contribution. For the year ended December 31, 2024, there were no employer discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company match or discretionary contribution (as applicable), an allocation of Plan earnings or losses, and is charged with withdrawals and administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their elective and rollover contributions and any income or loss thereon. Participants are 100% vested in their Company matching contributions after two years of service. Participants vest in discretionary Company profit-sharing contributions as follows:

Participants earn one year of service for each 12-month period of time they are employed, beginning on the employment commencement date.

A participant's accrued benefits shall become 100% vested upon such participant's death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. Loan terms could range from one to five years, except for the purchase of a primary residence, for which the loan term could not exceed 30 years. Participant loan fees are payable by the participant. Principal and interest is paid ratably through payroll deductions. A participant may prepay at any time the entire loan without penalty. Loans are secured by the participant's vested balance and carry a fixed, commercially reasonable rate of interest equal to the prime rate plus 1%. Interest rates range from 4.25% to 9.50% for loans outstanding at December 31, 2024. As of December 31, 2024, loans were due on various dates through December 2029.

Payment of Benefits

Upon termination of service because of retirement (age 65) or disability, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account balance or to retain the balance in the Plan. Upon death of a participant prior to the commencement of distribution of any benefit under the Plan, or prior to the complete distribution of his or her accounts, his or her surviving beneficiary shall be entitled to a death benefit equal to the sum of such participant's accounts as of the date of his or her death, payable in a lump sum. On termination of service for reasons other than retirement, disability, or death, participants may elect to receive a lump-sum amount equal to the value of his or her vested account balance or to retain the balance in the Plan. All accounts with a balance of less than \$5,000 upon termination of service for any reason shall have their entire balance distributed in a single lump-sum as soon as administratively feasible. Participants may elect to withdraw all or any part of their vested matching contributions after completion of five years of plan participation. Participants may also request a hardship withdrawal from their elective deferrals and rollover contributions. As of December 31, 2024 and 2023, no distributions had been requested by participants but not yet distributed.

Forfeitures

Forfeitures arise as a result of participants who separate from service with the employer before becoming 100% vested in the employer's contributions and earnings thereon. Forfeitures of non-vested participant balances may be used to pay Plan expenses, allocated as an additional employer contribution, used to reduce any matching contributions, or offset employer contributions that are qualified nonelective contributions, qualified matching contributions and contributions made pursuant to Code Section 401(k)(12)(ADP Safe Harbor Contributions). As of December 31, 2024 and 2023, unallocated forfeited balances totaled \$0 and \$42,327 respectively.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of the investment securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest net of any allowance for uncollectible amounts. No allowance for credit losses had been recorded as of December 31, 2024 or 2023. The Plan classifies all notes receivable from participants with no payments received in a financial quarter as in default. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary/profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in the administration of the Plan shall be paid from the Plan; however, the Company may elect to pay expenses directly. Plan recordkeeping, administrative, and consulting fees are allocated to participant accounts based on account balances. Participant-specific transaction fees for distributions or notes receivable from participants are charged directly to the appropriate participant account.

3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's contract holder and trustee, Minnesota Life Insurance Company d/b/a Securian Financial, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at the end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Pooled Separate Accounts

Pooled separate accounts are valued at the NAV of the units of accounts held by the Plan. The NAV is used as a practical expedient in estimating fair value. The NAV of the accounts is based on the quoted market price of the underlying assets, which consist primarily of publicly issued bonds or common stocks or other equity securities of domestic or foreign companies or units of other separate accounts or interests in other commingled investments held that invest in common stock or other types of equity or debt instruments. The practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The Plan's investments in these pooled separate accounts are not subject to any withdrawal or redemption restrictions, and there are no unfunded commitments at December 31, 2024 and 2023.

The valuation methods used may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest Transactions

Certain investments are shares of a pooled separate account managed by Minnesota Life Insurance Company, contract holder and affiliate of the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to the trustees were \$33,856 in the year ended December 31, 2024, which are recorded in administrative expenses on the accompanying statement of changes in net assets available for benefits.

The Plan is administered by the Company. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan allows participants to take out loans from the Plan which are considered exempt party-in-interest transactions.

Notes to Financial Statements

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, the participants' accounts will become fully vested and non-forfeitable.

7. Tax Status

The Plan has adopted a prototype plan. The Internal Revenue Service (IRS) has notified the prototype plan sponsor by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. No provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of certain investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements and the participants' account balances.

9. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the Plan's financial statements were available to be issued.
