INDEPENDENT AUDITORS' REPORT

To The Plan Administrator Circare 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Circare 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Note 1 – Description of the Plan

General

The Plan is a defined contribution 401(k) savings/profit-sharing plan covering all employees of Onondaga Case Management Services, Inc. (DBA Circare) (the Company) 18 years or older with one year of service. The Plan was adopted by the Company effective December 15, 1989, and is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA) as amended. The Plan is administered by the Company.

Eligibility

An employee will be eligible to become a participant in the Plan after attaining the age of 18 prior to the enrollment date. Newly hired employees will be automatically enrolled when they meet the eligibility requirements unless they opt out. The auto enrollment feature includes a 3% auto deferral rate. If employees do not make investment elections, amounts contributed under the automatic enrollment feature of the plan will be invested in the default investment (Balanced Portfolio – 100%) until they make an investment election.

Contributions

Each year participants may contribute up to the maximum allowable pre-tax contribution as well as after tax Roth contributions as defined in the Plan. Each year the Company may elect to make a discretionary profit-sharing contribution with the approval of the Board of Directors.

Participant Account

Each participant's account is credited with the participant's contributions and allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of Plan losses and certain administrative fees paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions are 100% vested at all times.

Vesting (continued)

Participants will be 100% vested in employer profit-sharing contributions on the later of the date of their Normal Retirement Age (55) or the 5th anniversary of the first day of the Plan Year in which participation in the Plan commenced.

Notes Receivable from Participants

Loans to participants shall be permitted. The minimum amount of any loan shall be \$1,000. Loans cannot exceed the lesser of \$50,000 or one-half of the vested portion of the participant account balance. The term of the loan cannot be longer than five years, unless the loan qualifies as a home loan, in which case the repayment period cannot exceed 15 years. The loans are secured by the balance in the participant's account. The loan interest rate is prime plus 1%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon death, total and permanent disability, retirement or termination, the participant's vested benefits are paid in a lump sum or installments for participants who receive required minimum distributions. Payment of participant's vested benefits will be paid out when the participant requests a distribution. Hardship withdrawals can be made for qualifying expenses listed in the Plan document. In-service distributions may be made to participants who have reached age 59 ½. Involuntary cash-outs are permitted if the vested balances are less than \$1,000.

Forfeitures

If a participant stops working before they are 100% vested, the part of their account that is not vested is forfeited. All forfeitures shall be used to reduce employer contributions or, pay Plan expenses otherwise payable to the Plan year in which such forfeitures arise, and for each succeeding Plan year, if necessary, until such forfeitures are exhausted. The amount of forfeitures available were \$2,508 and \$3,217 at December 31, 2024 and 2023, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements included herein have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles and are in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2 – Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the payment date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal. Interest income is recorded when received. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Administrative expenses are paid by Onondaga Case Management Services, Inc. Investment advisor fees and transaction fees are paid out of participant accounts.

Payment of Benefits

Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Note 3 – Fair Value Measurements (continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which a fair measurement falls is based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing deposits – Valued at carrying value, which approximates fair value.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive the total balance in their individual account.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Related Party Transactions

The Company pays for the administration and record-keeping expenses of the Plan. Investment advisor fees are paid out of Plan assets.

Note 10 – Certified Investments

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was derived from the information prepared by Ascensus Trust Company, the trustee of the Plan and furnished to the Company. The Company has obtained certifications from Ascensus Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
