## **1. DESCRIPTION OF THE PLAN**

The following description of The Westervelt Company (the Company) Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering most employees of the Company. Employees are eligible to make elections after completing 60 days of employment. Administration of the Plan is vested in a Benefits Committee appointed by the Board of Directors of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Benefits Committee is responsible for oversight of the Plan; however, it delegates some administrative duties to the Administrative Committee. The Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

### **Contributions**

Each year, participants may contribute up to 100% of Roth and pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. The automatic deferral will escalate each year by 1% not to exceed a maximum of 10% Plan compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company contributes 100% of the first 6% of base compensation, as defined, that a participant contributes to the Plan.

Effective January 1, 2014, the Plan was amended to allow Roth 401(k) deferrals to the Plan.

The Plan provides for pretax employee contributions in accordance with Section 401(k) of the Internal Revenue Code, individual employee investment options and individual employee loan provisions.

Effective January 1, 2020, the Plan was amended to (1) permit the direct transfer of surplus assets from the terminated Westervelt Company Retirement Plan; (2) create a suspense account to hold the surplus assets pending their release and allocation to participant accounts; (3) provide profit sharing contributions under the 401(k) plan to provide a contribution source for the allocation of the surplus; (4) reflect the distribution and vesting rules, allocation conditions and eligibility requirements applicable to profit-sharing contributions; and (5) permit certain voluntary partial withdrawals from the 401(k) plan.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Investment options are 100% participant directed. Administrative fees related to the Plan are paid through investment returns or paid directly by the

Plan sponsor. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator and subject to change at the discretion of the Plan administrator. Principal and interest are paid ratably through payroll deductions according to the established repayment schedule.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period that may not extend beyond the life expectancy of the participant or the joint life expectancy of the participant and beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows participants to withdraw all or part of his or her vested balance due to financial hardship as defined by the Internal Revenue Service (IRS) regulations or attainment of the age of 59½ or later. Distributions are subject to the applicable provisions of the Plan.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5 and \$219, respectively. These accounts will be used to reduce future employer contributions. Employer matching and discretionary contributions were reduced by \$78,081 and \$132,374 from forfeited nonvested accounts during 2024 and 2023, respectively.

**Plan Amendments**

Effective January 1, 2023, the Plan was amended to allow for partial termination withdrawals from the Plan.

Effective January 1, 2024, the Plan was amended to credit employee services with a predecessor employer, American Mitigation Company.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. For the years ended December 31, 2024 and 2023, there were \$109,072 and \$64,334 in defaulted notes receivable from participants, respectively.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Subsequent Events**

Management has evaluated subsequent events and their potential effects on these financial statements through September 29, 2025, the date the report was available to be issued.

### **3. INFORMATION CERTIFIED BY TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee).

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codifications (ASC) 820, *Fair Value Measurements and Disclosures*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

A small portion of the Plan's financial instruments, including participant contributions receivable and notes receivable from participants, are not measured at fair value on a recurring basis. However, these instruments are carried at amounts that approximate fair value due to their liquid or short-term nature.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. There were no Level 2 or 3 investments.

Gains and losses included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

## **5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan invests in a common/collective trust fund that includes benefit-responsive contracts and is maintained in a separate account. The common/collective trust fund is credited with contributions plus accrued interest and charged for withdrawals. The trustee does not charge any fees to the trust; instead, each unitholder trust and qualified plan is charged its own trustee fee. The contract value of the common/collective trust fund at December 31, 2024 and 2023, was \$14,195,356 and \$16,745,539, respectively.

Certain events might limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from

contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

As described in Note 2, because the common/collective trust fund is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the common/collective trust fund. Contract value, as reported to the Plan by Vanguard Fiduciary Trust Company, represents contributions made plus accrued interest at the contract rate, less withdrawals.

## **6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in shares of mutual funds and a common/collective trust fund managed by an affiliate of the trustee who acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments or are paid directly by the Plan sponsor. During 2024 and 2023, the Plan made direct payments to the third-party administrator of \$113,912 and \$118,203, respectively, which were not covered by revenue-sharing.

## **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts in accordance with the terms and provisions of the Plan.

## **8. TAX STATUS**

The Company adopted a prototype, non-standardized, profit-sharing plan with a cash or deferral arrangement, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the prototype document has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan has filed Form 5500, which is the annual return for

employee benefit plans, for all years through December 31, 2023. Years ended December 31, 2021 and subsequent, remain subject to audit by taxing authorities. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
