**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of Granite Solutions Groupe 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. General**

The Plan was established on January 1, 2001 by Granite Solutions Groupe, Inc. (the “Company”) to provide retirement benefits to eligible employees. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Administration**

Reliance Trust Company serves as directed trustee of the Plan. A third-party administrator, ADP, Inc. Retirement Services (“ADP”), maintains the records of participant data.

**C. Eligibility**

The Plan covers substantially all employees of the Company. There are no age or service requirements. Plan entry is on the first day of the month following the date of attaining eligibility.

**D. Participant Contributions**

Participants may elect to have the Company contribute up to 90% of their eligible pre-tax compensation to the Plan subject to applicable Code limits. Participants of age 50 or older may elect to make up to \$7,500 of additional catch-up contributions for 2024. Participants who elect to have the Company contribute a portion of their pre-tax compensation to the Plan agree to accept an equivalent reduction in taxable compensation.

Effective September 1, 2023, employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with participant directions and the Plan’s provisions.

Effective October 11, 2023, participants may elect to make Roth after-tax contributions. Each participant’s pre-tax deferrals and Roth contributions are subject to applicable Code limits.

**E. Company Contributions**

The Plan provides for discretionary employer matching and non-elective contributions. No Company contributions were made for the 2024 Plan year.

**F. Vesting**

Participants are 100% vested in their accounts. Provisions of the Plan provide for full vesting of Company matching and nonelective contributions, if any, after three years of service.

**G. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, if any, and the participant's share of Plan earnings or losses and expenses. Plan investments consist of a diversified menu of mutual funds and common/collective trust investments. Participants direct the investment of their accounts.

**H. Payment of Benefits**

Normal retirement age under the Plan is age 65. Participants are eligible for benefits upon attainment of age 59½, retirement, disability or termination of service. Benefits under the Plan are payable in a lump sum or installments. Hardship distributions are permitted under limited circumstances subject to the approval of the plan administrator. Benefits are recorded when paid.

**I. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$500 up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by a participant's account, bears interest at a fixed rate determined at loan inception and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended to a maximum of 30 years. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry an interest rates ranging from 10.00% to 10.50% with various maturities through February 2039.

Notes receivable are measured at the unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**J. Expenses**

Fund operating expenses, brokerage, administrative and trust fees are charged directly to the funds and are thereby factored into each fund as a reduction of investment return. ADP receives payments in the form of revenue sharing from certain Plan investment funds. Such payments are used to offset fees ADP would otherwise charge for administrative services. Participant loan administration and benefit payment processing costs are charged directly to participants. Other costs incurred for administering the Plan may be paid by the Plan or the Company at management's discretion.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**C. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and the amounts reported in the financial statements.

**D. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 4 - TAX STATUS**

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at closing market prices of shares held by the Plan at year end. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.
