Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Niagara Falls Memorial Medical Center Sponsored 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of Plan:

The following description of Niagara Falls Memorial Medical Center Sponsored 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering employees of Niagara Falls Memorial Medical Center (Plan Sponsor) and its affiliated entities, Schoellkopf Health Center Inc and Niagara Falls Memorial Medical Center Foundation, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may voluntarily contribute a portion of pretax annual compensation, as defined in the Plan, provided total deferrals to the account of participating employees for any plan year shall not exceed the amount permitted by Internal Revenue Service regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan Sponsor contributes a fixed contribution of 2% of a participant's annual salary, as described in the plan agreement. The Plan Sponsor also matches 0.35% of each percent of elective deferrals up to 5% for a maximum match of 1.75%.

Participant Accounts:

Each participant's account is credited with (a) contributions and, (b) an allocation of Plan earnings, less allowable expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts can be used to reduce future employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in all elective participant deferrals and participant rollover contributions. Participants are fully vested in employer contributions after completing three years of service.

Investment Options:

Participants direct contributions into a variety of investments offered by Transamerica Retirement Solutions, LLC (Transamerica).

Participant Loans:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range up to five years (except certain residence loans which can extend up to ten years). The loans are secured by the balance in the participant's account and bear interest at the prime rate at the time of the loan, plus 2%.

Payment of Benefits:

On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments over a period of not more than the assumed life expectancy of the participant or beneficiary, or defer the commencement of benefits until normal retirement age.

Forfeitures:

Forfeited non-vested accounts are used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$45,591 and \$34,111. In 2024, employer contributions were reduced by \$1,397 from forfeited non-vested accounts.

2. Summary of Significant Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits:

Benefits are recorded when paid.

Investment Valuation and Income Recognition:

The Plan's mutual fund investments are stated at fair value based on quoted prices in active markets. The fully benefit-responsive variable annuity contract is reported at contract value.

The Plan maintains a fully benefit-responsive variable annuity investment contract, which is stated at contract value. Contract value, as reported to the Plan by Transamerica without further adjustment, represents contributions made, plus earnings, less participant withdrawals and administrative expenses. Participants may generally withdraw or transfer all or a portion of their investment at contract value unless Transamerica imposes a hold period at the contract level in the event of a full or partial contract discontinuance. There is no stated minimum or maximum interest rate for the variable annuity contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code, (2) complete or partial termination of the Plan, (3) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on a portfolio's cash flow, (4) any communication given to participants not to invest in a portfolio or to transfer assets out of the portfolio, or (5) premature termination of the contract. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

Participant Loans:

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Subsequent Events:

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 13, 2025 (the date the financial statements were available to be issued).

Tax Status:

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

3. Investments (Unaudited):

The following information included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained from data that has been prepared and certified to as complete and accurate by the custodian, State Street Bank and Trust Company:

Statements of Net Assets Available for Benefits – Investments and participant loans.

Statement of Changes in Net Assets Available for Benefits – Net appreciation in fair value of investments, dividends and interest, and participant loan interest.

Schedule of Assets (Held at End of Year) – all items.

4. Plan Termination:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Administrative Expenses:

At the discretion of the Plan Administrator, investment expenses have been borne by the Plan participants. The majority of administrative expenses have been borne by the Plan Sponsor.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
