Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of WFRA, Inc. Multiple Employer Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the WFRA, Inc. Multiple Employer Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility

The Plan was established on January 1, 1982, as a defined contribution plan, amended and restated through the years to comply with certain tax legislation, maintained and sponsored by the Wisconsin Fuel & Retail Association, Inc. (WFRA or the Sponsor). The Plan provides retirement benefits to employees of WFRA and Adopting Employers (Participating Employers) who are members of WFRA. The Plan qualifies as a multiple employer plan as described in Section 413(c) of the Internal Revenue Code (IRC). With the consent of the Sponsor, an Adopting Employer may adopt the Plan by executing an adoption agreement. Employees are eligible to participate in the Plan based on elections made by the Participating Employers. A Participating Employer may elect to have different eligibility criteria provided that the maximum age is not greater than 21 years and the length of services is not greater than one year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by designated management of the Sponsor. The Sponsor is responsible for the operations of the Plan, selection of investment options, and monitors investment performance. The Sponsor has contracted with The Retirement Advantage, Inc. (TRA) for certain Plan accounting and compliance. The Lincoln National Life Insurance Company (Lincoln or the Custodian) provides recordkeeping and custodian services to the Plan.

Plan amendment

Effective January 1, 2024, the Plan was amended to reflect the change in the Sponsor's name from Wisconsin Petroleum Marketers & Convenience Store Association, Inc. to Wisconsin Fuel & Retail Association, Inc.

Contributions

Each year, participants may contribute an amount of their annual compensation, as defined in each Participating Employer's adoption agreement, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Roth 401(k) deferrals are allowed under the Plan, if elected by the Participating Employer. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each Participating Employer may elect the level of safe harbor, matching or discretionary contributions to participants who make elective deferrals. Discretionary matching contributions percentages are determined by each individual Participating Employer. Participating Employers may, at their election, make non-elective profit-sharing contributions to the Plan which are allocated to participant accounts based on a percentage of compensation as determined by Participating Employers. Participating Employer contributions, if any, are recorded in the year for which the contributions apply. Aggregate Participating Employer contributions for the year ended December 31, 2024 amounted to \$1,430,539. Participating Employer contributions are invested in funds in accordance with the participant's direction and the Plan's provisions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1 – Description of Plan, Continued

Participant accounts

Each participant's account is credited with the participant's contributions, and their Participating Employer's contributions, as well as allocations of their Participating Employer's profit-sharing contributions (if any) and Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses that are paid directly by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of their account to any of the investment options offered by the Plan.

Vesting

Participants are vested immediately in their individual contributions and their Participating Employer's safe harbor contributions, if any, plus actual earnings or losses thereon. Vesting in all other Participating Employer's contributions, if any, and earnings or losses thereon, is based on the vesting schedule specified in the corresponding Participating Employer's adoption agreement. Participant accounts become fully vested upon death, disability, or reaching normal retirement age (defined by the Plan as 65). Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Forfeitures

Forfeited nonvested accounts may be used to offset Plan administrative expenses or reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$90,343 and \$123,444, respectively. For the year ended December 31, 2024, forfeitures used to reduce Participating Employer contributions or to offset Plan administrative expenses totaled \$118,282.

Notes receivable from participants

Plan participants may borrow from their fund accounts a minimum of \$1,000 and up to the lesser of 50% of the value of their vested account balance or \$50,000. Loan terms may not exceed five years, except in the case of loans for the purchase of a primary residence. Loans are secured by the balance in a participant's account and bear interest at local prevailing rates, as determined quarterly and as of the date of the loan request. A participant may only have two (2) loans outstanding at any time. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Principal and interest are repaid through regular payroll deductions.

Payment of benefits

Upon termination of service due to death, disability, normal retirement age (65), or other reasons, or qualifying under certain "hardship" rules, as prescribed by the IRS, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution, installment payments, or a rollover into another qualified plan. Additionally, participants reaching 59½ years of age may receive in-service distributions from the Plan, for certain heavy financial hardship, from their vested pre-tax or after-tax deferral account balances prior to retirement, as defined.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Note 2 – Summary of Significant Accounting Policies, Continued

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences may be material.

Investments valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Contributions

Contributions from the Plan participants and the matching contributions from the Participating Employers are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Refunds payable for excess contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of benefits

The Plan records benefits when paid.

Note 2 – Summary of Significant Accounting Policies, Continued

Plan expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor and Participating Employers. Expenses that are paid by the Sponsor or Participating Employers are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Uncertain tax positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Lincoln National Life Insurance Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on participant notes receivable as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H, Line 4i – Schedule of Assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.

Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

Following is a description of the value methodology used for assets measured at fair value:

Pooled separate accounts – Valued at its net asset value (NAV) based upon the units of such pooled separate accounts held by the Plan at year-end multiplied by the respective unit value. The unit values of the pooled separate accounts are based upon significant observable inputs, but are not based upon quoted market prices in an active market and are therefore considered Level 2 investments within the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan invests in a fully benefit-responsive investment contract (FBRIC) issued by The Lincoln National Life Insurance Company (Lincoln or the issuer). Lincoln reported contract value of the FBRIC totaling \$1,794,203 and \$1,930,792, as of December 31, 2024 and 2023, respectively. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive contracts.

Note 5 – Guaranteed Investment Contract with Insurance Company, Continued

Lincoln is the contract issuer and maintains contributions in its general account. The contract is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and interest under the terms of the contract. Contributions received are credited with the applicable crediting rate. Interest is credited daily at a rate not less than the guaranteed minimum interest rate of 1.0%, as contractually specified. The interest crediting rate is reset by Lincoln every six months. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on Lincoln's ability to meet its financial obligations. Lincoln's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with Lincoln. Such events include, but are not limited to, the following: (1) amendments to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Lincoln and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow Lincoln to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of Lincoln.

Note 6 – Related Party and Party-In-Interest Transactions

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Sponsor, Participating Employers, and certain others. The Plan's investments are managed, administered and/or issued by Lincoln, the Plan's Custodian. Therefore, these investments and investment transactions with Lincoln qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Sponsor. No officer or employee receives compensation from the Plan for these services.

Lincoln receives revenue from service providers for services Lincoln provides to the pooled accounts. This revenue is used to offset certain amounts owed to Lincoln for its administrative services. Fees incurred for investment management services are included in net appreciation in fair value of investments, as they are paid for by revenue sharing, rather than by direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

The Retirement Advantage, Inc. (TRA), the Plan's third-party administrator, receives fees for certain compliance, accounting, and recordkeeping services. Therefore transactions with TRA qualify as party-in-interest transactions.

Note 7 – Refunds Payable for Excess Contributions

During 2024 and 2023, the Plan received contributions from participants in excess of Plan and IRS limitations. Such excess contributions were refunded to participants in each of the subsequent years with a liability and corresponding reduction to contributions recorded in the year the excess contribution is received.

Note 8 – Tax Status

On June 30, 2022, the IRS stated that the volume submitter profit sharing plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since adoption, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Sponsor and the Participating Employers have the right under the Plan to discontinue their contributions, the Participating Employers may withdraw, and the Sponsor has the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Participating Employer's contributions.

Note 10 – Plan Transfers

Qualified plans sponsored by certain Participating Employers may be transferred into the Plan in conjunction with such Participating Employer's adoption of the Plan. Likewise, when Participating Employers withdraw from the Plan and adopt different qualified plans, assets attributable to these outgoing Participating Employers are transferred out of the Plan.

Note 11 – Delinquent Participant Contributions

For the years ended December 31, 2024, 2023, 2022, 2021, 2019 and 2018, participant contributions and loan repayments totaling \$28,616, \$70,936, \$611, \$135, \$79,680, and \$43,575, respectively, were not remitted to the Plan within the period prescribed by DOL regulations. These transactions qualify as prohibited transactions as defined by ERISA. The Participating Employers corrected and remitted lost earnings to the Plan for the 2022 and 2018 late remittances and a portion of the 2023 late remittances. The 2021 delinquent contributions were corrected in 2025. The 2024, 2019, and remaining portion of 2023 delinquent participant contributions have not been corrected as of the date of this report.

Note 12 – Subsequent Events

The Plan evaluated events occurring subsequent to December 31, 2024 through October 14, 2025, the date on which the financial statements were available to be issued, for matters that should be recorded in the financial statements or disclosed in the footnotes thereto.
