Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bernier Food & Beverage, LLC Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Berner Food & Beverage, LLC Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by Berner Food and Beverage, LLC (the Company). The Plan covers substantially all employees but excludes collectively bargained employees and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's board of managers is responsible for oversight of the Plan.

Eligibility: Employees of the Company who have completed one month of service, as defined, are eligible to participate in the 401(k) deferral portion and the safe harbor company match portion of the Plan and enter the first day of the month following completion of the service requirement. Employees of the Company who have completed a year of service, as defined, are eligible to participate in the Company nonsafe harbor match and profit sharing portions of the Plan as of the earlier of the first day of the Plan year or the first day of the seventh month of the Plan year after having met the eligibility requirements.

Contributions: Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations, provided these contributions will not cause the Plan to exceed the discrimination limits. Participants who will attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows Roth elective deferrals to be made to the Plan. Company safe harbor matching contributions are made quarterly using a safe harbor formula based on a percentage of compensation deferred by each participant. The formula is calculated as a 100% match up to 3% of compensation and 50% match on the next 2% of compensation, for a maximum matching contribution of 4%. For 2024, the safe harbor match was approximately \$653,000. The Plan also provides for a discretionary nonsafe harbor match and a profit sharing contribution. For 2024, the Company made no such discretionary nonsafe harbor match and profit sharing contributions. Generally, to receive an allocation of the discretionary contributions, participants must be employed on the last day of the Plan year and complete 1,000 hours during the Plan year.

Participant accounts: Each participant's account is credited with the participant's deferral contributions and the Company's match contribution, and an allocation of: (a) the Company's nonsafe harbor match and profit sharing contributions, if any, and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their participant deferral contributions and safe harbor company match contributions plus actual earnings thereon. Vesting in the Company discretionary contributions and Company match contributions made prior to the change to safe harbor contributions portion of their accounts plus earnings, is based on years of continuous service. For those contributions subject to vesting, a participant is 100% vested after six years of credited service based on a graded vesting schedule.

Note 1. Description of the Plan (Continued)

Investment options: Each participant has the option to invest their account balance and contributions in selected investment options as made available and determined by the Plan Administrator. Each participant has the option to transfer monies between funds and change their investment options daily.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested interest in his or her account reduced by other outstanding loans. Participants are limited to two loans outstanding at any one time. The \$50,000 maximum aggregate loan amount is reduced by any loan balance on the date a new loan is made. Note terms may not exceed five years, except for the purchase of a primary residence, in which case the note term cannot exceed 30 years. The notes are secured by the balance in the participant's account and bear an interest rate equal to the prime rate as published in the Wall Street Journal. Principal and interest are paid ratably through payroll deductions.

Payment of benefits: Upon termination of service for any reason, participants may elect to receive a lump-sum cash amount equal to the value of their vested account or partial withdrawals. A participant with a vested balance between \$5,000 and \$1,000 will automatically receive a single lump-sum rollover into an individual retirement account. A participant with a vested balance less than \$1,000 will receive a single lump-sum cash distribution. In addition, in-service withdrawals at age 59½ and hardship withdrawals are allowed by the Plan from vested accounts.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$100 and \$23,200, respectively. These accounts will be used to pay plan expenses and then to reduce employer contributions. During the year ended December 31, 2024, approximately \$23,500 of forfeitures were used to reduce the employer contribution.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's board of managers determines the Plan's valuation policies utilizing information provided by the investment custodian and investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accounted for on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Note 2. Significant Accounting Policies (Continued)

Payment of benefits: Benefit payments to participants are recorded when paid.

Administrative expenses: All administrative expenses incurred by the Plan, including audit fees, can be paid by either the Company or the Plan. Expenses paid by the Company are excluded from these financial statements.

Cash, interest-bearing: The carrying amount approximates fair value because of the short maturity of the instrument.

Subsequent events: Plan management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable by the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party and Party-in-Interest Transactions

Fees paid by the Plan to Savant Capital, LLC for investment advisory services amounted to approximately \$68,000. Fees paid by the Plan to PCS Retirement, LLC for recordkeeping services amounted to approximately \$28,000. These transactions qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company for which they receive no compensation from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their accounts.

Note 7. Income Tax Status

The Plan has adopted a pre-approved defined contribution plan sponsored by DWC The 401(k) Experts. The pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service as to the pre-approved defined contribution plan's qualified status. The pre-approved defined contribution plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved defined contribution plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
