1. DESCRIPTION OF THE PLAN

The following is a brief description of The Retail Group Retirement Plan (“the Plan”) and is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The plan was established on March 1, 2018 with an effective day to receive contributions from the sponsor since March 1, 2018. The plan third party administrator is A&A Employee Benefits Consulting Corporation.

General

The Plan is a profit-sharing plan established by The Retail Group, Inc., as applicable (the “Sponsor”), and covers substantially all its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), and structured pursuant to Section 1081.01(d) and other applicable sections or subsections of the Internal Revenue Code for a New Puerto Rico (IRCNPR). Benefits under the Plan are provided by a Trust Fund with individual account balances.

Trustee and Administrator of the Plan

Alta Trust is the asset trustee and Empower Retirement provides recordkeeping services for the plan for the years ended December 31, 2024 and 2023.

Eligibility

Employees are eligible to participate in the Plan after completes 12 months of service and upon attaining the age of 18. Participants working under professional services agreements are not eligible to participate in the plan.

Contributions

Employer contribution - respect to covered employees who have become eligible participants, the company will contribute to the plan an employer contribution that fluctuates between 25% to 50% of employee contribution according to the years of service, as established in Section VIII of plan document. The plan sponsor reserves the right to increase, decrease or eliminate its employer contributions for subsequent plan years. The decision to increase, decrease or eliminate the employer contributions must be made before the end of the plan year preceding the year of change.

Employee voluntary contribution – Each year, participants of the plan may contribute the lesser of 15% of their annual compensation or \$15,000. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, subject to the conditions and limitations set forth in the Plan agreement.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Vesting in the Plan Sponsor's contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. Each participant will at all times have a fully vested and non-forfeitable interest in his voluntary contributions and any investment growth thereon. Employer matching contributions are 100% vested after six or more years of service, 80% upon attaining five years, 60% upon attaining four years, 40% upon attaining three years and 20% upon attaining two years. For purpose of determining vesting, all of a participant's credited years of service with the employer after the effective date of this plan, shall be counted.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions as well as the participant's share of the Plan's income and any related expenses. Each participant's account is credited with the participant's contribution and an allocation of the Sponsor contributions and Plan earnings. Allocations are based on participant earnings or accounts balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures of profit sharing and/or matching contributions will be applied to reduce profit sharing and matching contributions required of the Employer, and/or reallocated as additional profit-sharing contributions and/or applied to reduce the Plan's administrative expenses. Forfeitures of terminated non vested account balances as of December 31, 2024 and 2023 amounted to **\$1,376** and **\$3,148**, respectively.

Plan Termination

The employer shall have the right at any time to terminate the plan by delivering to the Trustee and Administrator written notice of such termination. Upon termination or partial termination of the plan or complete discontinuance of contributions thereunder, each participant will continue to have a fully vested and non-forfeitable interest in his accounts. Upon termination of the plan, the trustees will distribute to each participant (or other person entitled to distribution) the value of the participant's accounts in a single lump sum payment or in substantially equal installments in accordance with the provisions provided in Article XVII of the plan.

Payment of Benefits

Plan participants who leave The Retail Group Retirement Plan as a result of termination, retirement, or death may receive the entire amount of their account balance in one lump-sum payment. If a participant dies, the participant designated beneficiary will receive the payment.

If a participant became disabled, a participant must satisfy the requirements for Social Security disability benefits to receive a disability retirement benefit.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Participant Loans

Loans to participants from the Plan are not permitted.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States.

Payment of Benefits

Benefits payments are recorded when paid.

3. INVESTMENT CONTRACT

The Plan entered into an investment contract with Empower Retirement. Empower Retirement maintains the contributions in a separate account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses charged by Empower. The contract is included in the statements of net assets available for benefits at contract value.

The adjustment from fair value to contract value for the investment contract is based on the contract value as reported by Empower Retirement (which represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses). The contract value of the investment contract as of December 31, 2024 and 2023 was \$1,033,576 and \$777,804, respectively.

Empower Retirement classify their investments as follows: variable investment options and fixed income options. Variable investment options include variable annuity contracts, mutual funds, and Collective Investment Funds (CIFs) held in custody of the Trust Fund. These variable funding options provide for participant directed investment through a number of underlying mutual funds. The value of these variable funding options is determined by the value of the underlying mutual fund shares plus any distributions received from the mutual funds less any charges assessed by the variable annuity contracts and Trust programs. Fixed income options seeks to maximize total return, while attempting to preserve capital.

4. EMPLOYEE CONTRIBUTIONS

A Department of Labor Regulation require the employee contributions to the plan to be remitted by the employer as soon as they can be reasonably segregated from the employer’s general assets, but no later than the 15th business day of the following month in which the participant contributions are withheld or received by the employer. DOL may assess penalties on employers or plan administrator who do not comply with these requirements. These financial statements do not consider the impact of penalties, if any, to be imposed by the IRS for late payments of the contributions made to the plan. All contributions were remitted to the plan by the employer within the time frame of the 15th business days or before. During the years ended December 31, 2024 and 2023 the plan received contributions as follows:

5. CUSTODIAN CERTIFICATIONS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certification from the Custodian that all information provided by them is complete and accurate. Information included in the accompanying financial statements as to investments, earnings on investments, and all information in the accompanying schedules is presented in reliance solely upon those certifications.

6. TAX STATUS

The Plan has received a favorable determination letter from the Secretary of the Treasury of Puerto Rico dated August 23, 2018, which states that the Plan and its underlying trust qualifies under the applicable provisions of the IRCNPR and, therefore, is exempt from local income taxes. The plan is being operated in compliance with the applicable requirements of ERISA and the IRCNPR.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Puerto Rico Department of the Treasury. The Plan Administrator has analyzed the tax position taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions however, there are currently no audits for any tax periods in progress.

7. GENERAL AND ADMINISTRATIVE EXPENSES

Plan participants pay administrative expenses of the Plan through fees deducted directly from participant accounts on a per-participant basis.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate or partially terminate the Plan at any time. In the event of the Plan termination, participants will become 100% vested and be non-forfeitable in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the company may determine.

9. RISK AND UNCERTAINTIES

The Plan invests in various investments securities. Investment securities are exposed of various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 7, 2025, the date that the financial statements were available for issue. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.
