INDEPENDENT AUDITOR'S REPORT

To the Administrator of
Ildico 401k Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Ildico 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ildico 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Reliance Trust Company as of December 31, 2024 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ildico 401k Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ildico 401K Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. NOTE 1 – DESCRIPTION OF PLAN

General

The Ildico 401k Plan (the Plan) is a qualified defined contribution plan designed to provide both current economic security and retirement benefits to employees of Ildico, Inc. (the Employer). The Plan covers all employees with at least six months of service and are age 21 or older.

Contributions

The Plan provides for both employer and employee contributions. The Employer contributes a safe harbor contribution equal to 3% of eligible wages as well as a discretionary amount which is determined annually. There was no discretionary contribution made for the plan year ended December 31, 2024. Employee contributions are made by the participants, at their discretion, up to a maximum contribution of \$23,000 for 2024.

Vesting

Employee contributions and the employer's safe harbor contributions are 100% vested at all times. The employer's discretionary contribution vests as follows: 0% for less than two years of service, 20% for two years of service, 40% for three years of service, 60% for four years of service, 80% for five years of service, and 100% for six years of service.

Payment of Benefits

A participant's plan benefits will be distributed at retirement, death, disability or termination of employment. If the participant's balance is greater than \$5,000, such benefits will be paid to the participant or beneficiary in a lump sum or under a deferred payment schedule if so elected. Account balances of less than \$5,000 are to be paid in a lump sum amount.

Employer Options

The Employer may, in its sole and exclusive discretion, discontinue Plan contributions or terminate the Plan in accordance with its provisions at any time. Upon termination of the Plan, or complete discontinuance of contributions, the rights of all affected employees in all of their account balances shall thereupon be 100% vested and non-forfeitable.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

Forfeitures may be applied to reduce contributions of the employer or for payment of administrative expenses of the Plan. During the year ended December 31, 2024, there were no forfeitures utilized for the payment of employer contributions or administrative expenses of the Plan. The balance of the non-vested forfeiture account was \$238 and \$0 at December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's matching contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of the following investment options:

- AB Global Bond Fund – Fund invests at least 80% of its net assets in fixed income securities. It invests significantly in fixed income securities of non-U.S. companies. The fund normally invests in the fixed-income securities of companies located in at least three countries.
- American Century Emerging Markets Fund – Fund invests at least 80% of its net assets in equity securities of companies located in emerging market countries. The fund's managers consider an emerging market country to be any country other than a developed country.
- American Funds American Mutual Fund – Fund invests primarily in common stocks of companies that are likely to participate in the growth of the American economy and whose dividends appear to be sustainable. It invests primarily in the securities of issuers domiciled in the United States and Canada.
- American Funds Target Date 2015 and 2020 – Fund normally invests a greater portion of its assets in fixed income, equity-income and balanced funds as it continues past its target date. The advisor attempts to achieve its investment objectives by investing in a mix of American Funds in different combinations and weightings.

- American Funds Target Date 2025 through 2060 (in five-year increments) – Funds normally invest a greater portion of its assets in fixed income, equity-income and balanced funds as they approach and pass their target dates. The advisors attempt to achieve their investment objectives by investing in a mix of American Funds in different combinations and weightings.
- Blackrock Liquidity Funds Fed Fund – Money market account.
- DWS Enhanced Commodity Strategy Fund – Fund invests in commodity-linked derivative instruments backed by a portfolio of fixed income instruments. It invests in commodity-linked derivative instruments (a contract whose value is based on a particular commodity), such as commodity-linked total return swap contracts, options and futures contracts, to gain exposure to the investment return of assets that trade in the commodity markets, without investing directly in physical commodities.
- Franklin Small Cap Growth Fund – Fund invests at least 80% if its net assets in equity securities of small-cap companies. The equity securities in which the fund invests are predominantly common stock.
- iShares Russell Mid Cap Index Fund – Fund invests 90% of its assets, plus the amount of any borrowing for investment purposes, in securities of the underlying index. The underlying index is a float-adjusted, capitalization-weighted index of equity securities issued by approximately 800 of the smallest issuers of the Russell 1000 Index.
- iShares S&P 500 Index Fund – Fund is a feeder fund that invests all of its assets into the Master Portfolio of MIP, which has the same investment objective and strategies of the fund. At least 90% of the value of the fund's assets are invested in securities comprising the S&P 500 Index.
- iShares Russell 2000 Small Cap Index Fund – Fund is a feeder fund that invests all of its assets in the Series, a series of the Master LLC which has the same investment objective and strategies as the fund. It will be substantially invested in securities of the Russell 2000, and will invest, under normal circumstances, at least 80% of its net assets in securities or other financial instruments that are components or have economic characteristics similar to the securities in the Russell 2000.
- iShares US Aggregate Bond Index Fund – Fund is a feeder fund that invests all of its assets in the Master Portfolio of MIP, which has the same investment objective and strategies as the fund. Under normal circumstances, at least 90% of the value of the fund's assets, plus the amount of any borrowing for investment purposes, is invested in securities comprising the Bloomberg U.S. Aggregate Index.

- iShares MSCI Total International Index Fund – Fund is a feeder fund that invests all of its assets in the Master Portfolio. It will be substantially invested in equity securities of the MSCI ACWI ex USA Index, and will invest, under normal circumstances, at least 80% of its net assets in securities or other financial instruments that are components of or have economic characteristics similar to securities included in the MSCI ACWI ex USA Index.
- Invesco Global Fund – Fund invests mainly in common stock of US and foreign companies. It can invest in any country, including countries with developing or emerging markets. However, the fund currently emphasizes its investments in developed markets such as the United States and Western European countries. It does not limit its investments to companies in a particular capitalization range, but primarily invests in Mid and Large Cap companies. The fund normally will invest in at least three countries (one of which may be the United States).
- Invesco Real Estate Fund – Fund invests, under normal circumstances, at least 80% of its net assets (plus any borrowings for investment purposes) in securities of real estate and real estate-related issuers, and in derivatives and other instruments that have economic characteristics similar to such securities. It may also invest in debt securities, including corporate debt obligations and commercial mortgage-backed securities. The fund may invest up to 10% of its net assets in non-investment grade debt securities of real estate and real estate-related issuers. It is non-diversified.
- JP Morgan Government Bond Fund – Fund principally invests in securities issued by the US government and its agencies and instrumentalities and related to securities issued by the US government and its agencies and instrumentalities. It mainly invests in government bonds with intermediate to long remaining maturities. The fund's average weighted maturity will ordinarily range between 3 and 15 years, taking into account expected prepayment of principal on certain investments.
- JP Morgan US Equity Fund – Under normal circumstances, the fund invests at least 80% of its assets in equity securities of US companies. "Assets" means net assets, plus the amount of borrowings for investment purposes. In implementing its strategy, the fund primarily invests in common stocks of large and medium capitalization of US companies, but it may also invest up to 20% of its assets in common stocks of foreign companies, including depository receipts.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

- Lord Abbett Income Fund – Fund pursues its investment objective by investing at least 65% of its net assets in investment grade debt (or fixed income) securities including corporate debt securities of US issuers, corporate debt securities of non-US (including emerging market) issuers that are denominated in US dollars; mortgage-backed, mortgage-related and other asset-backed securities; securities issued or guaranteed by the US government, its agencies or instrumentalities, and inflation-linked investments.
- Lord Abbett Short Duration Income Fund – Fund invests in various types of short duration debt (or fixed income securities). It invests at least 65% of its net assets in investment grade debt securities including corporate debt securities of US issuers; corporate debt securities of non-US (including emerging market) issuers that are denominated in US dollars; mortgage backed, mortgage related, and other asset-backed securities; and securities issued or guaranteed by the US government, its agencies and instrumentalities; and inflation linked investments.
- MFS Growth Fund – Fund normally invests primarily in equity securities. Equity securities include common stocks and other securities that represent an ownership interest (or right to acquire an ownership interest) in a company other than issuer. The adviser focuses on investing the fund's assets in the stocks of companies the adviser believes to have above average earnings growth potential compared to other companies.
- MFS Growth Allocation Fund – Fund is designed to provide diversification among different asset classes by investing its assets in other mutual funds advised by the adviser, referred to as underlying funds. Within the equity fund allocations, the adviser seeks to diversify by geography (including domestic and international underlying funds), in terms of market capitalization (by including large, mid, and small capitalization underlying funds), and by style (including both growth and value underlying funds).
- Nuveen Life Cycle Index 2010 through 2060 (in five-year increments) – Funds invest in Class W shares of other Nuveen mutual funds and potentially other investment pools or investment products. They have a policy of investing at least 80% of their assets in underlying funds that are managed to seek investment returns that track particular market indices.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

- PGIM Total Return Bond Fund – Fund seeks its investment objective through a mix of current income and capital appreciation as determined by the fund's subadvisor. It invests, under normal circumstances, at least 80% of the fund's investable assets in bonds. For purposes of this policy, bonds include all fixed income securities, other than preferred stock, with a maturity date of issue of greater than one year. The fund may invest up to 30% of its investable assets in speculative, high risk, below investment-grade securities. It may invest up to 30% of its investable assets in foreign debt securities, including emerging market debt securities.
- PGIM High Yield Fund – Fund normally invests at least 80% of its investable assets in a diversified portfolio of high yield fixed-income instruments rated BA or lower by Moody's Investor Service or BB or lower by S&P Global Ratings and instruments either comparably rated by another nationally recognized statistical rating organization, or considered to be of comparable quality, that is, junk bonds.
- PIMCO Income Institutional Fund – Fund invests at least 65% of its total assets in a multi-sector portfolio of fixed income instruments of varying maturities, which may be represented by forwards or derivatives such as options, futures contracts or swap agreements. It may invest up to 50% of its total assets in high yield securities rated below investment grade by Moody's, S&P, or Fitch, or if unrated, as determined by PIMCO.
- T Rowe Price Overseas Stock Fund – Fund expects to invest significantly outside the US and to diversify broadly among developed market and, to a lesser extent, emerging market countries throughout the world. It normally invests at least 80% of its net assets in non-US stocks and at least 65% of its net assets in stocks of large-cap companies.
- Victory Trivalent International Small Cap Fund – Fund invests primarily in equity securities of companies principally in countries represented in the S&P Developed ex-US Small Cap Index. Under normal circumstances, at least 80% of the fund's assets will be invested in securities of small-capitalization companies.

Participants' Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000, and up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the participant's vested account during the prior twelve-month period, or 50% of their vested account balance. The vested account balance will be used as collateral for any loan. Interest is charged based on the prevailing rates charged by persons in the business of lending money for loans, which would be made under similar circumstances. All loans must be repaid in level payments on at least a quarterly basis over a five-year period unless it is for the purchase of a principal residence, in which case the loan is payable over ten years.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investment contracts held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants

Participants' notes receivable at December 31, 2024 and 2023 are valued at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Participant Contributions

Participant contributions are accrued when compensation is paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN (UNAUDITED)

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by the Trustee, which included total investments as of December 31, 2024, the total investment income for the year ended December 31, 2024, and all information included in the supplemental schedule H, line 41 – Schedule of Assets (Held at End of Year).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, supplemental schedules and Note 4.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

U.S. Accounting Standards establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data or other means and Level 3 unobservable inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

Inputs to the valuation methodology included quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The trustee of the Plan, Reliance Trust Company, invests certain Plan investments with Merrill Lynch for employee benefit plans and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the investment management services were \$34,462 in 2024. The plan sponsor absorbs all other administrative costs.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Employer has adopted the Automatic Data Processing (“ADP”) Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (the ADP Plan). The ADP Plan obtained its latest determination letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the Plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The opinion letter has been relied upon by this Plan. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax years in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
