To the Concrete and Aggregate Employees 401(k) Plan Trustees and Participants:

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Concrete & Aggregate Employees 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE A – DESCRIPTION OF THE PLAN**

Concrete and Aggregate Employees 401(k) Plan (the “Plan”) was established by Lauren Concrete, Inc. and Texas Aggregate, LLC. (the “Company”), two separate companies under common ownership. The following description of the Plan provides only general information. Participants should refer to the summary plan description or the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Company who are eligible to enter the Plan the first day of each month. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute to the Plan on a pretax or after-tax basis, subject to statutory limits, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make discretionary matching contributions at the option of Company management. These contributions, if made, will be computed by the Company based on eligible participants compensation deferred into the Plan each payroll period. The Plan defines compensation as all income subject to income tax and paid by the Company during the Plan year within IRS established limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution (if any), Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant’s vested account.

**Administrative Expenses**

The Plan’s administrative expenses primarily consist of fees paid to third parties for investment management, record keeping, annual audit, and other administrative fees. The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of 50% of their vested account balance or an aggregate outstanding loan balance of \$50,000. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest as determined by the Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant’s account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon.

Participants vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon will be based on one year of service. Service is defined as elapsed time generally based upon your date of employment with your employer. Vesting is determined as follows:

Less than 1	0%
1	100%

A participant will be considered fully vested upon attaining normal retirement age of 65, or if active employment ceases due to death or disability.

**Forfeitures**

Forfeitures of non-vested Company contributions are used to first reduce any administrative expenses with any remaining forfeitures to be used to reduce future Company contributions. During the years ended December 31, 2024 and 2023, \$21,777 and \$9,410, respectively, of forfeited participant accounts were used to reduce the Company’s administrative expenses. At December 31, 2024, there were \$0 of forfeited participant accounts that were available to be applied to reduce the Company’s future contributions.

**Plan Participation**

Employees become eligible to participate in the Plan on the first day of each month, following initial hire date.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting, in conformity with generally accepted accounting principles in the United States of America.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

**Risks and Uncertainties**

The Plan provides for investments in various securities, which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements and supplemental schedule.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – continued**

**Investment Valuation and Income Recognition**

The investments are presented at fair value based on quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan has a collective trust investment, the Fidelity Managed Income Portfolio Fund ("the MIP"). The fund seeks to preserve the principal investment while earning a level of interest income that is consistent with principal preservation. The fund seeks to maintain a stable net asset value (NAV) of \$1 per share, but it cannot guarantee that it will be able to do so. The yield of the fund will fluctuate. The fund invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions ("Contracts"), fixed income securities, and money market funds. Under the terms of the Contracts, the assets of the fund are invested in fixed income securities (which may include, but are not limited to, U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities, and collective investment vehicles and shares of investment companies that invest primarily in fixed income securities) and shares of money market funds. The fund may also invest in futures contracts, option contracts, and swap agreements. All of which are subject to minimum credit quality and diversification standards. Withdrawals made by participants are made available daily. Plan sponsor level directed withdrawals require a twelve month advance written notice. As of December 31, 2024 and 2023, there were no unfunded commitments related to the common collective trust investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable accounts are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no participants who had elected to withdrawal from the Plan that were not yet to be paid.

**Corrective Distributions**

Corrective distributions are required when employee contributions exceed contribution limitations of the Plan. These amounts are recorded as a liability in the year in which they were initially contributed to the Plan and reduce contributions received.

**Allowance for Credit Losses**

The Plan recognizes an allowance for credit losses for financial assets carried at amortized cost to present the net amount expected to be collected as of the balance sheet date. Such allowance is based on the credit losses expected to arise over the life of the asset (contractual term) which includes consideration of prepayments and renewal/extension options that are not accounted for as derivatives and are not unconditionally cancellable by the Plan.

Assets are written off when it is determined that such financial assets are deemed uncollectible or based on regulatory requirements, whichever is earlier. Write-offs are recognized as a deduction from the allowance for credit losses.

**Allowance for Credit Losses – continued**

Expected recoveries of amounts previously written off, not to exceed the aggregate of the amount previously written off, are included in determining the necessary reserve at the balance sheet date. At December 31, 2024 and 2023, the Plan had no financial assets carried at amortized cost.

**NOTE C – INVESTMENTS**

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held at the end of the year), which are all participant-directed, had a net appreciation of \$1,440,531.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework established under generally accepted accounting principles in the United States of America provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable input.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (NAV) and has been determined to have a readily determinable fair value by the Plan at year end.

*Common collective trust:* Valued at observable net asset value (NAV) of the underlying investments as reported by the investment company.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments are at fair value included in the investment amount, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Common Collective Trust Stable Value Fund, at net asset value, included in the investment amount as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, with the exception of the notes receivable from participants, which are not yet certified.

**NOTE F – RELATED PARTY TRANSACTIONS**

The Plan maintains transactions with certain parties in interest, as defined by the Employee Retirement Income Security Act of 1974 ("ERISA"). Parties in interest generally include the Plan sponsor, trustees, investment managers, service providers, and other related entities. During the current year, the Plan engaged in the following transactions with parties in interest:

- Service Provider Fees: The Plan paid \$53,343 in recordkeeping and administrative fees to Fidelity, which is a party in interest. The Plan paid \$20,000 in fees for investment management services to Gallagher Benefit Services Inc., which is a party in interest. The Plan paid \$3,199 in fees for investment management services to Strategic Advisors Inc., which is a party in interest.
- Investments Managed by Parties in Interest: At the end of the current year, the Plan held \$15,635,249 in collective investment trusts managed by an affiliate of the Plan's trustee.

These transactions are considered exempt party-in-interest transactions under ERISA Section 408(b). Management believes all such transactions were conducted in the normal course of the Plan's liquidation and at terms that were reasonable.

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balance.

**NOTE I – TAX STATUS**

The Internal Revenue Service has determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) based on the volume submitter Cash or Deferred Arrangement (CODA) determination letter dated March 31, 2014. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.
