Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cook Children's Health Care System Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Note 1. Description of the Plan

General

The following description of Cook Children’s Health Care System Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by Cook Children’s Health Care System (Employer) for the benefit of its full-time and half-time employees who are contributing to the Employer’s 403(b) plan. Additionally, employees classified by the Employer as seasonal, temporary, part-time, per diem nurses (PRN), or pool must be employed on the last day of the plan year and complete at least 1,000 hours of service during the plan year to be eligible to participate in the Plan. The Plan only includes Employer-matching contributions, as all employee contributions are held in a separate 403(b) plan. Related employers who also participate in the Plan include Cook Children’s Medical Center, Cook Children’s Physician Network, W.I. Cook Foundation, Inc., Cook Children’s Health Plan, Cook Children’s Home Health, Cook Children’s Child Study Center, Cook Children’s Health Enterprises, and Cook Children’s Medical Center-Prosper. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and serves as plan custodian.

Contributions

The Employer makes nondiscretionary matching contributions based on the percentage of eligible compensation contributed by employees to the Employer’s 403(b) plan. The Employer contributions are as follows for the years ended December 31, 2024 and 2023:

<u>Matching Contribution</u>	<u>Completed Years of Service</u>
100% up to 4%	Less than 5 years
100% up to 5%	5 years
125% of the first 5% provided the participant contributes at least 5%, otherwise 100%	6 to 10 years
150% of the first 5% provided the participant contributes at least 5%, otherwise 100%	11 or more years

Participant Investment Account Options

Participants direct the investment of the Employer’s contribution into various investment options offered by the Plan. The Plan currently offers mutual funds, money market funds, and a fully benefit-responsive group annuity contract as investment options for participants. Participants may also invest in the Fidelity Brokerage Link Account (Self-Directed Accounts) offered by Fidelity. The Self-Directed Accounts allow participants to invest in additional mutual funds.

Participant Accounts

Each participant’s account is credited with the Employer’s contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in the Employer's contribution to participant accounts, plus earnings thereon, is based on years of continuous service or upon reaching normal retirement age. A participant fully vests after three years of continuous service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, a participant's vested benefits may be paid out as a lump-sum distribution, as a direct rollover, or as installment payments. The Plan permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the plan document. Additionally, certain in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,636,908 and \$789,062, respectively. Forfeitures are first used to pay plan administrative expenses, and any remaining portion will be used to reduce future Employer contributions. Employer contributions were reduced by \$1,038,931 and \$943,639 from forfeited nonvested accounts in 2024 and 2023, respectively.

Notes Receivable From Participants

Through July 1, 2011, the plan document included provisions authorizing loans from the Plan to active eligible participants. All loans outstanding at December 31, 2024 and 2023 are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through automatic bank drafts. Interest on the loans was based on local prevailing rates as determined by Fidelity.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The money market funds are valued at cost, which approximates fair value.

The fully benefit-responsive investment contract is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the years.

Contributions

Contributions from the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Employer or the Plan, at the Employer’s discretion. The Employer may also use revenue credits earned under the recordkeeping agreement with the trustee to pay administrative expenses of the Plan (see Note 5). These revenue credits are netted with administrative expenses in the accompanying statements of net assets available for benefits.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

Note 4. Investment Contract With Insurance Company

In 2002, the Employer entered into a fully benefit-responsive group annuity investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract guarantees an interest rate for the first guarantee period and a minimum rate for the subsequent periods.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract with Principal will terminate when there are no deposits existing under the contract.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invests in certain funds of the plan trustee. Certain plan investments are shares of registered separate accounts with investments in mutual funds and general accounts managed by the trustee. Therefore, these transactions qualify as party-in-interest transactions. The Employer has a recordkeeping agreement with Fidelity whereby revenue credits are calculated quarterly and may be used to pay administrative expenses of the Plan. The Employer provides certain administrative services at no cost to the Plan.

The Plan paid \$253,330 and \$242,150 of recordkeeping fees to the trustee during the years ended December 31, 2024 and 2023, respectively.

Note 6. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan holds no Level 2 or Level 3 securities.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The IRS has determined and informed the Plan by a letter dated July 8, 2010 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cook Children's Health Care System Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1. Description of the Plan

General

The following description of Cook Children’s Health Care System Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by Cook Children’s Health Care System (Employer) for the benefit of its full-time and half-time employees who are contributing to the Employer’s 403(b) plan. Additionally, employees classified by the Employer as seasonal, temporary, part-time, per diem nurses (PRN), or pool must be employed on the last day of the plan year and complete at least 1,000 hours of service during the plan year to be eligible to participate in the Plan. The Plan only includes Employer-matching contributions, as all employee contributions are held in a separate 403(b) plan. Related employers who also participate in the Plan include Cook Children’s Medical Center, Cook Children’s Physician Network, W.I. Cook Foundation, Inc., Cook Children’s Health Plan, Cook Children’s Home Health, Cook Children’s Child Study Center, Cook Children’s Health Enterprises, and Cook Children’s Medical Center-Prosper. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and serves as plan custodian.

Contributions

The Employer makes nondiscretionary matching contributions based on the percentage of eligible compensation contributed by employees to the Employer’s 403(b) plan. The Employer contributions are as follows for the years ended December 31, 2024 and 2023:

100% up to 4%	Less than 5 years
100% up to 5%	5 years
125% of the first 5% provided the participant contributes at least 5%, otherwise 100%	6 to 10 years

Participant Investment Account Options

Participants direct the investment of the Employer’s contribution into various investment options offered by the Plan. The Plan currently offers mutual funds, money market funds, and a fully benefit-responsive group annuity contract as investment options for participants. Participants may also invest in the Fidelity Brokerage Link Account (Self-Directed Accounts) offered by Fidelity. The Self-Directed Accounts allow participants to invest in additional mutual funds.

Participant Accounts

Each participant’s account is credited with the Employer’s contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in the Employer's contribution to participant accounts, plus earnings thereon, is based on years of continuous service or upon reaching normal retirement age. A participant fully vests after three years of continuous service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, a participant's vested benefits may be paid out as a lump-sum distribution, as a direct rollover, or as installment payments. The Plan permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the plan document. Additionally, certain in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,636,908 and \$789,062, respectively. Forfeitures are first used to pay plan administrative expenses, and any remaining portion will be used to reduce future Employer contributions. Employer contributions were reduced by \$1,038,931 and \$943,639 from forfeited nonvested accounts in 2024 and 2023, respectively.

Notes Receivable From Participants

Through July 1, 2011, the plan document included provisions authorizing loans from the Plan to active eligible participants. All loans outstanding at December 31, 2024 and 2023 are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through automatic bank drafts. Interest on the loans was based on local prevailing rates as determined by Fidelity.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The money market funds are valued at cost, which approximates fair value.

The fully benefit-responsive investment contract is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the years.

Contributions

Contributions from the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Employer or the Plan, at the Employer's discretion. The Employer may also use revenue credits earned under the recordkeeping agreement with the trustee to pay administrative expenses of the Plan (see Note 5). These revenue credits are netted with administrative expenses in the accompanying statements of net assets available for benefits.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

Note 4. Investment Contract With Insurance Company

In 2002, the Employer entered into a fully benefit-responsive group annuity investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract guarantees an interest rate for the first guarantee period and a minimum rate for the subsequent periods.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract with Principal will terminate when there are no deposits existing under the contract.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invests in certain funds of the plan trustee. Certain plan investments are shares of registered separate accounts with investments in mutual funds and general accounts managed by the trustee. Therefore, these transactions qualify as party-in-interest transactions. The Employer has a recordkeeping agreement with Fidelity whereby revenue credits are calculated quarterly and may be used to pay administrative expenses of the Plan. The Employer provides certain administrative services at no cost to the Plan.

The Plan paid \$253,330 and \$242,150 of recordkeeping fees to the trustee during the years ended December 31, 2024 and 2023, respectively.

Note 6. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan holds no Level 2 or Level 3 securities.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The IRS has determined and informed the Plan by a letter dated July 8, 2010 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
