Definitions

Interest credit percentage

For each calendar year prior to January 1, 2013, the interest credit percentage is the average rounded to the nearest 0.01% of the weekly averages for the weeks ending in the month of November in the prior calendar year of the rate on Treasury Constant Maturities, 1-year, as published in the Federal Reserve Statistical Releases, H.15 (519) or its replacement publication.

After December 31, 2012, the interest credit is based on the greater of the first segment rate under Code Section 430(h)(2)(C) for the month of November in the prior calendar year without regard to MAP-21 and 3.50%.

Optional forms of benefit payments

Bargaining hourly participants

- Monthly annuity payable for life, or 10 or 15 years certain and life.
- Monthly annuity payable as a survivorship life annuity with survivorship percentages of 50, 66 2/3, 75 or 100.
- Single sum payment at plan termination.

Salaried and non-bargaining participants

- Monthly annuity payable for life, or 10 or 15 years certain and life.
- Monthly annuity payable for life with cash refund of the participant's cash balance account.
- Monthly annuity payable as a survivorship life annuity with survivorship percentages of 50, 66 2/3, 75 or 100.
- Single sum payment.

The optional form conversion basis is 7.00% interest and the RP-2000 Combined Mortality Table (50% Male and 50% female) for payments other than lump sums.

Lump sum provisions

Small amount force out (SAFO) – allowed up to \$5,000.

Lump sums in excess of SAFO – are allowed for salaried and non-bargaining participants (limited to \$10,000 with remaining benefit paid when eligible for retirement) at termination of employment and (unlimited) at retirement and plan termination.

Conversion for bargaining hourly participants – the deferred rate based on the applicable interest rate and applicable mortality table as set forth in Code Section 417. The applicable interest rate uses the fifth calendar month preceding the first day of the stability period which is the month.

For salaried and non-bargaining participants, the lump sum is equal to the cash balance account determined at the date of distribution.
